OPENING OF THE HENLEY REGATTA

The Crowd was Not as Large as Usual—Weather Fine.

CAMBRIDGE WINS THE CUP

McDowell, of Chicago, Beats Guinness, of the Thames, for Diamond Sculls—Blusse Wins from Hairair.

Henley-on-Thames, July 14.—The trial heats of the Henley regatta of 1897 began today with beautiful weather, though a stiff wind blew at intervals from the Berkshire shore. The crowd in attendance was not as large as usual.

In the grand challenge cup first heat, the Lusander Club beat the Thames Rowing Club by one and three-quarter lengths.

At Berks Station, in the first trial heat for the grand challenge cup, Trinity Hall, Cambridge beat the London Rowing Club.

In the second trial heat for diamond sculls at Berks Station, J. J. Blusse, of the Hoop Rowing Club, Amsterdam, beat H. Hairair, of Jesus College, Cambridge.

In the second trial heat for diamond sculls at Berks Station, Dr. W. H. McDowell, of the Delaware Boat Club, Chicago, beat Thomas Guinness, of the Thames Rowing Club. McDowell cleared easily at the finish, but passed the final post a length ahead. Guinness was cheered from the banks along the whole course, while very little encouragement was given McDowell.

STAGE ROBBERY. Solomonville, Ariz., July 14.—News has just been received that the stage from Globe to Jerome was robbed Monday afternoon, ten miles from Globe. The robbers secured \$1,000 in silver, sealed up in tomato cans. The stage broke down ten miles from Globe and the driver went back alone for a new conveyance. When he returned the money was gone. The driver and his companion are under arrest.

NOTED EQUAW DEAD. Tacoma, July 14.—Sarah Leavelle, the last descendant of the famous Nequally war chief, Leavelle, hanged for fighting whites, died on the Puget reservation today. Three hundred Indians attended the funeral this afternoon. Ka-Chiet Sadawah addressed the assembled tribesmen in their native tongue. Two nephews named Quilamath are the only remaining relatives of the famous chief.

MURDER IN SAN FRANCISCO. San Francisco, July 14.—Sigmond E. Draverman, a diamond dealer at 121 Post street, shot and fatally wounded Anton Burgle, a well-known restaurateur, this morning, as a result of a quarrel over money matters. Burgle made an ante mortem statement that he visited Draverman's office with the intention of killing the jeweler and then committing suicide.

Creede had instituted divorce proceedings against his wife and her cross complaint was filed three weeks ago.

MAULEY OUT AGAIN. Tacoma, July 14.—Ex-City Treasurer Mauley, under sentence of three years in the penitentiary for misappropriation of public funds, was for the second time released on bail today, pending the reopening of his case before the superior court. The bond furnished was for \$500.

HIG MINING DEAL. Toluca, Mex., July 14.—It is announced that the negotiations for the purchase of La Esperanza gold mining property by C. D. Lane, representing a California syndicate, has been closed. The consideration was \$5,000,000. Lane deposited \$100,000 as an option on the mine a short time ago.
