The Platform.

To the Chairman and Delegates of the Republican City Convention:

Gentlemen—Your committee on platform appointed on the 29th instant has completed its labors and makes the following report:

The Republican party in convention assembled hereby reaffirms its allegiance to the citizens and taxpayers of this city and pledges itself to an economic, careful and progressive administration of city affairs for the coming biennial term of 1898 and 1899.

We assert that the past two years of Republican administration has demonstrated to the taxpayers that the finances of this city have been ably and judiciously managed; our city warrants having increased in price from 25 cents two years ago to 58 cents the present price; that our debts have not been increased; that the burden of taxation has been reduced and our credit has been strengthened with investors at home and abroad.

The improvement of our streets, at the lowest possible cost, consistent with good workmanship, has continued during the administration, and we pledge the party to the same care regarding such improvements and other expenditures during the future. We recognize the importance of an efficient and honest police force to maintain law and order, restrain criminals and administer justice in the courts.
