NEW YORK, May 11.—Hillary A. Herbert, secretary of the navy in Cleveland's last term, was seen last night by a World correspondent in Washington, who asked him what in his opinion would be the general destination of the Cape Verde squadron. He replied: "I have been informed that the Spanish fleet has gone to Cadiz. If this is so, I think the Spaniards propose to consolidate their fleet before attempting to cross the Atlantic. They will, in my opinion, get together as strong a fleet as possible and will then sail for America. I do not think it will ever be necessary for our vessels to attack the Spanish coast. If we capture the Philippines, Porto Rico and Cuba, we will practically end the war, and I believe the Spanish navy will be forced to come here and give battle. No dynasty could live in Spain that would refuse to do this."

NEW YORK, May 11.—A dispatch to the Herald from Madrid says: It is only indirectly that attention is paid to the progress of the war by the people here. For the time being everyone is engrossed with the consideration of the ministerial crisis. Upon its solution depends the immediate action of Spain. If the cabinet weathers the storm it will emerge from it either instructed to prosecute the war vigorously or else empowered to take steps for the re-establishment of peace with the least possible delay. From careful consideration of the ministerial action it is more than probable that the latter solution will be more in accordance with its members' personal desire. The question is, will they be able to follow their desires? The proposition is a difficult one. They know only too well that the longer the war is prosecuted the more severe will be the loss of Spain. It is manifest that the government is trying to throw the responsibility for the continuance of the war on parliament. It is also manifest that the opposition is trying to embroil the government by refusing to accept that responsibility without at the same time giving the ministry any ground for saying later that peace was consummated by the will of the nation's representatives and not by the government's party management. The government will not help the opposition to secure peace, as later it may overthrow the liberals on this ground. Which of the two parties, ministerial or the opposition, will be the stronger is the one subject of interest at present. There is growing authority for the feeling that to pursue the

NEW YORK, May 11.—A dispatch to the World from Cadiz says: The war and naval departments are advancing preparations for a relief expedition to the Philippines, which it is said, will be composed of 5,000 regular soldiers and two battalions of marines. Instructions have been sent to General August to hold out as long as possible, forty days being required for the arrival of an expedition going by the way of the Suez canal and the Red sea. The commander of the squadron conveying the relief will be Admiral Butler if Admiral Camara elects to remain in charge of the remaining vessels of the reserve fleet.

NEW YORK, May 11.—A dispatch to the World from San Sebastian says: There is great excitement here on account of the phenomenal fall in exchange in favor of Spanish money. Yesterday the rate was 215, whereas this morning it fell to 195 and at the close of the day offers were refused at 150. I am informed on most excellent authority that a well-known banking house has come to the rescue and advanced the bank of Spain 100,000,000 pesetas.

SAN FRANCISCO, May 11.—The steamer Australia will be turned over to the government today and the City of Peking tomorrow. The City of Sydney will not be in readiness for several days and both she and the Australia will have to go on the dry dock. It is not expected, therefore, that the troops will leave here before the early part of next week, though it was expected to have them ready to sail on Saturday. It was thought at first that the Peking would carry only stores and naval supplies, but it has been decided that she will carry 100 soldiers in addition to her cargo of supplies. The Sydney can carry 1200 men without freight, and the Australia can carry a similar number. In addition to the vessels which have been chartered the steamers Ohio and Connecticut are also being overlooked by agents of the government. A report regarding their capacity and condition has been sent to Washington. It is likely that the two vessels will be added to the transport fleet. Captain Baldwin, purchasing commissioner for the navy, received instructions yesterday to purchase 1,000,000 rations for the troops going to Manila.
