Portland and the O. R. Nelson are having lots of fun at Astoria's expense just now; but it may not be very long before somebody else will be doing the laughing as well as the business.

The Oregonian is not elevating itself in the esteem of the people of Oregon as a fair and public-spirited journal by its method of treating the Astoria common point proposition. Wheat producers and readers generally are sure to find out sooner or later how the true facts have been concealed or misrepresented, and the result will be such a loss of confidence in the honesty and reliability of the Oregonian as a state organ as will more than offset the cheap triumph of its present petty aggravation of Astoria, and require years of consistent devotion to the best interests of the whole state to recover.

The course of the Oregonian in its mean and contemptible reproduction of the dirty slings against Astoria people appearing in certain papers of this city could be overlooked if it were not known that the Oregonian does not look upon these papers as representative at all, but from its own knowledge of the situation here realizes that they are utterly discredited and despised by every decent person in Astoria. Does the Oregonian think the standing it gives these papers in other sections of the state by the double-headed reprint of their foul slanders and unjust insinuations against Astoria people tends to help the cause of decent journalism in the northwest, or answer the calm and dispassionate inquiry of Astoria's leading citizens why the producers of Oregon and Washington should be forced to lose upwards of two millions of dollars annually on the sale of their wheat through the discrimination of transportation companies against the Astoria harbor?

IS IT DESIRABLE THAT OREGON PRODUCERS SHOULD REACH DEEP DRAFT VESSELS?

Will the Oregonian say what it thinks of this:

"The deeper the draft of vessels, the 'cheaper' transportation becomes. It is 'a fact in engineering science that for every inch of water of a ship's draft, 'you add 30 tons to her carrying capacity.' This shows the value of a single inch of 'channel. The great problem of the country is cheaper transportation. The 'country cannot prosper if the producers 'do not prosper. Vessels drawing 25 and 'even 30 feet of water can now cross the 'Columbia bar under full sail.'—Mr. Hermann, to the Portland chamber of commerce.

And will the Oregonian say what it thinks of this:

The A. & C. R. R. Co. is ready to bring wheat to these vessels of 30 feet draft. Do the producers' interests count for nothing with Portland unless the transfer to vessel shall continue to be made there? Let the producers combine and become their own shippers, and save one and one-quarter million dollars to themselves every year by reaching deep draft vessels. The wheat producing regions are even more vitally interested than is Astoria in having the obstructions (viz., the Cascades, the Dalles and the O. R. & N. Co.) removed from the Columbia river route. Then by either light draft fleets or by rail, the producer can reach vessels of 30 feet draft, and have the benefit of competition in reaching them.

The notion of calling an extra session of congress before the regular session in December has been abandoned, as the administration has been advised from many sections of the country that the republican candidates for congress need all their time to mend their fences. Though the success of the war has made McKinley exceedingly popular, the hue and cry against the war department threatens to hurt the republicans, especially in those districts whose regiments have lost men by sickness in camp. It is certain that this will make the hottest kind of campaign material, and it is freely admitted at congressional campaign headquarters that the republicans have their hands full to combat these allegations against a member of McKinley's cabinet, and consequently against the administration itself. But it is generally conceded that the next meeting of congress will not be able to finish half the important legislation connected with the war, and an extra session in the spring is inevitable.

Ball shipments (of lumber) from the state of Washington continue to show a gratifying increase. If the ratio keeps up fully 10,000 carloads of lumber will be shipped to the eastern states before the year is over. For car material seems to have the call, as in times past, with bridge strings, fir sills, cedar siding, spruce siding and doors in the order named. Prices are keeping up exceedingly well, which is a good indication—Pacific Lumber and Trade Journal.

Already some practical individuals want to know if coffee will be cheaper now that the United States own Porto Rico. The coffee plantations on that island are the sources of great incomes, and, no doubt, under better management, will be made to yield even more wealth.
