NOTICE OF INTENT

Notice is hereby given that the Common Council of the City of Astoria, Oregon, proposes and determines to improve Astor street, from the west side of Sixth street to the west side of Ninth street, in said city, by grading said street where necessary to intersect with and overcross same with plankings laid upon proper timbers and stringers, and constructing sidewalks on each side thereof, the planking to be for a width of 20 feet on each side of a line drawn through the center of said Astor street throughout the aforesaid extent thereof, and the sidewalks to be 10 feet wide on both sides of said street, also constructing the necessary crossings on said improvement. The site and quality of all the lumber to be used in the construction of said improvement shall be as directed by Ordinance No. 193 of the ordinances of said city, entitled "An Ordinance in Relation to the Improvement of Streets," approved January 24, 1938.
