A TRIBUTE TO BRAVERY.

Committee Will Show Flowers on the Bier of Ensign Monaghan, the Hero Who Gave His Life in the Defense of Another at Apia, Samoa.

This morning the steamer Columbia, from San Francisco, is expected in with the remains of Ensign John R. Monaghan, who was killed near Apia, Samoa, during the attack of the Matafua rebels on the combined English and American forces. The body is en route to Spokane, where his parents live and where the remains of the brave ensign will be buried. The county court, Cushing Reelber, Corps No. 1 Naval Reserve and the city government will send representatives to the dock to honor the noble dead.

The following committee will be in attendance: County court, Judge J. H. D. Gray, H. J. Wherry and Thomas L. Lilliville, W. R. C. Mrs. Vera Green, Mrs. Belle Cleveland and Mrs. Pauline Ziegler, Naval Reserve, W. A. Sherman, W. P. Wilson and G. Ziegler, City of Astoria, Osmus Irix, E. P. Parker and A. Schrecknecker.

Flowers will be taken to the dock and the respect of Astoria shown to the memory of Ensign Monaghan. A beautiful wreath which has been prepared will be one of the principal floral offerings.

The father of the deceased will accompany the corpse on the steamer, which is expected to arrive about 5 o'clock this morning. It would be a fitting tribute to the deceased to have the flags around town flying at half-mast during the time that Columbia is in the harbor.

The story of the ensign's death is one of remarkable heroism. The American and English forces were ambushed by the rebels and were forced to fall back. Lieutenant Langsdale, of the Philadelphia, was wounded in the retreat and finally became so disabled that he could go no farther and ordered his men to keep up the retreat and leave him. Ensign Monaghan would not do this and stayed with the lieutenant, defending him till the last, when both were shot and bedeviled by the barbarous rebels.

While valorous deeds are not wanting in the history of the late war, it would be hard to find a more gallant action than that recorded above and the real heroism and self-sacrifice of the ensign will long be remembered by our people.

A ROAD TO SEASIDE.

A Practical Route, With Light Grades, Outlined by Mr. Stafford.

CLATSOP, June 22.—(Editor of Astorian) I saw in your paper a few days ago that a road from the Lewis and Clarke bridge was to be opened to Clatsop Plains, north of the one already there, on which a five per cent grade was to be had. To show what the opening of the way to town is likely to do, I'll just drop a few lines about another route to the seaside. After crossing the bridge at Lewis and Clarke, by keeping around the hill, where it joins the tide land, and crossing the ravines at their mouths, instead of higher up, a road practically level can be made to the warehouse below Mrs. Harder's. From there to Blamers the road is open about as it will have to be, only requiring a little change near D. J. Ingal's house, and at the Anderson farm. From the Blamers it will follow along the foot of the hill next the bottom land to reach the south side of the Charles Sackett homestead till it reaches a ravine that has its head at the old Sackett mill at Charles Sackett's house, thence along the ravine to its head by the mill, thence along the present county road to the house of the old gentleman Sackett and the other old mill, thence, leaving the road following down a ravine up a continuation with the county road near where Frank Byrd's mill was located, thence by county road as now laid out to the Seaside.

The arguments in favor of this route in preference to all others to Seaside are: First, it is the most direct route. Second, it is practically a level route and can be made with any reasonable grade. Third, there is abundance of both fuel and brush rock along the route to be had, also hard sand rock, which is a sort of cross between sandstone and basalt. The very best kind of rock for road foundation. And, fourth, it will be all the way, except from the old gentleman Sackett's house, to the road by the Byrd mill, through fine farming land that is sure to have many settlers on it to improve it from year to year. If Astoria wants a good road to the seaside that will be a pleasant drive and first-class in every respect, this is certainly the route she should pay her particular regards to.

Some think the road should go on the east side of Lewis and Clarke, instead of crossing the bridge at Heckard's, but this would make necessary another bridge near the warehouse by Harder's, but a bridge there would be an evening trouble, by reason of freshets and drift, and although a road on the west side might be a little more difficult to make, when done it would cease to be expensive.

Insane Chinaman Shuffles Off This Mortal Coil.

Some time Wednesday night Lun Yot, a Chinaman employed at Warren's cannery at Cathlamet, committed suicide by hanging. Early Thursday morning the Chinese employes of the cannery found the body hanging from a tree a short distance from the bank house, but when found life was extinct.

It was at first thought that murder had been committed, but later development showed beyond question that it was suicide, as he was well liked by all the employes at the cannery and no possible motive for murder could be found, besides every indication showing that he came to his death by his own hand. The coroner's jury had not made their findings known when last heard from yesterday, but their verdict will no doubt be suicide. The body was taken to Portland yesterday, where the Chinese of that city will attend to the burial.

Additional proof to support the suicide theory is furnished by the fact that Lun Yot had been discharged as cured from the state insane asylum about two months ago. Very likely his insanity returned and prompted him to end his life.
