 At the Vining**

Zane Grey, famous novelist, sends a special message to those of his readers who witness "Riders of the Dawn." Benjamin B. Hampton's photoplay of his latest novel, "The Desert of Wheat," which with an all-star cast, including Roy Stewart, Claire Adams, Robert McKim and other celebrities, is the attraction at the Vining theater today, and tomorrow.
 "Readers of my novel, 'The Desert of Wheat,' will find that when they witness 'Riders of the Dawn' they will see, instead of the novel as it appeared serially and in book form during the war, a film version that is almost a sequel to the original," said Mr. Grey. "I want them to know how this happens. The novel was written for the war, and contained in fiction form my appeal for patriotism. The film does not deal with the war.
 "It was to have been filmed, like my previous personally endorsed picture by Benjamin B. Hampton, 'Desert Gold,' as an accurate screen edition to the book. **Irrigation
 Season Ends**

GRANTS PASS, Sept. 1.—The farmers having been giving their alfalfa fields the final irrigation and as most other crops, grains, fruits, etc., are already made, the irrigation season is now near its end. The pump supplying the lower valley farms of the north-west unit will be operated night and day for a few days more, when it will be run only by day. The pumps of both other units will be closed down tonight, the north side possibly for the season and the south side for several days. They will be put into commission again as soon as the farmers need the water.

**History of Class of 1875
 Of the Ashland Academy**

At the reunion of the old Ashland academy classmates which was held at the Hotel Austin last Monday evening in honor of Judge Felix Ewing of Ventura, Calif., while the latter was visiting in this city, R. P. Neil, one of the members of the class, gave the following sketch of the lives of the seven surviving members of the class who were in school 45 years ago:
 I have been asked to prepare a brief sketch of the lives of the few remaining members of the class of 1875, as organized in the old Ashland Academy, 45 years ago. As my memory served me at this time, that class consisted of about 30 students. The ravishes of time in the past 45 years, have reduced by death about five-sixths of this number, leaving but six or eight of the class members at this time. The immediate personnel of this class, living today are, as far as my knowledge goes, C. B. Watson, E. J. Farlow, G. S. Butler, C. H. Gillette, F. W. Ewing, R. P. Neil and Mrs. G. F. Billings, all of whom are practically of the same age. In preparing the sketch of the above named individuals, any omissions or mis-statements of a minor character should be charitably overlooked, as so hastily a prepared sketch, prompted from memory only, covering a period of 45 years, would naturally be faulty in some particulars.

In sketching the past life of C. B. Watson, I will say that immediately after finishing his education in the old Ashland Academy, he chose as a profession for a life work, that of the law, having served many years as prosecuting attorney in different parts of this state, with credit to himself and to his constituency, and while he has grown older along with the rest of us, he is still a foe in litigation, that the best attorneys in this district hesitate to face. It has been said of him that in a legal way he has been a contributory cause to more divorce cases than any other man in Jackson county.

In considering the past life of E. J. Farlow, suffice it to say that it has been a quiet, upright, unassuming business life. In his early life he taught school, later in having been elected county superintendent of this county, which position he filled faithfully and well. Later he was interested in the mercantile business for many years, and his many patrons always received a square deal from him, with a smile and a cherry word thrown in. He is now retired on a competency from active business life, but boosting for Cox and Roosevelt.

G. S. Butler's life has been a varied and most successful business life. He was extensively interested in real estate and livestock, to the extent of many thousands of dollars. Still later he was in the mercantile business. As a matter of fact, if there is any line of legitimate business that he has not successfully tackled, the writer does not know what it is. He has served Jackson county as county commissioner, one or two terms, and was called the Watch Dog of Jackson county's funds. He has also served as mayor and other official capacities, in the administrative affairs of the city of Ashland, with credit to himself and Ashland's citizens. Although possessed of a large share of this world's goods, he does more hard work yet than any other man in town.

C. H. Gillette is probably the youngest living member of this class and is recognized as a clean, clear cut man of affairs. He recently finished his fourth year as recorder of this city, and his work in that capacity was conceded by experts to be first class, in every respect. In business affairs as well as in private life, his word is considered to be good as the best bond obtainable. He is treasurer and an elder in the First Presbyterian church of this city, serving in these capacities faithfully and well.

Mrs. G. F. Billings, nee Frances Myer, the only lady member of this class living, that we can recall, has spent her life up to the present, in Ashland. Her chief occupation has been in the rearing of a model family, and the upkeep of an ideal home. This, in the writer's opinion, is the greatest God-given privilege and

honor that comes to a woman. God bless our mothers.

R. P. Neil, the next subject of this sketch, has failed in many, many things, yet he claims credit for doing something that no other surviving male member of this class has done; namely the raising of two husky boys to manhood, who are sharing the responsibilities and citizenship of our government, and voting the democratic ticket. This is all the credit I am asking.

And last, but by no means least, comes our old friend and schoolmate, our guest of honor on this occasion, F. W. Ewing, whom we are so pleased to meet once again. Doubtless with his professional brethren and his home neighbors he is known as Judge Ewing, but to those of us who knew him in the olden time, he is just plain Felix. We hesitate when attempting the sketching of his life. During these 45 years there seems in a business and professional way, to have come to him nothing but success. Positions of honor and trust have come to him in rapid succession, one after another. That he has met and measured up to the requirements of these numerous responsible positions, goes without saying. In fact, when we recall the fact that he ever stood at the head of his class in school, we are not surprised at his success, because it was no child's play to outclass some of his fellow students.

After leaving school, he taught school for a number of years, reading law at the same time. After successfully practicing law for some time, he was elected prosecuting attorney for Modoc county, California. After serving in this capacity for a number of years in said county, he removed further south.

Still practicing his chosen profession with such success the electorate of his district elevated him to the honorable position of Superior Judge for a term of six years. During this time he tried many important cases in Los Angeles and other large cities of California.

Tiring of the strenuous life on the bench, at the expiration of his official term as judge, he chose to enter the banking business, since which time he has been actively engaged in said business, and is now a large stockholder and president of two of California's most important banks.

Felix, so many good things have not come to the rest of us, but we are not jealous of your success, and are hoping that business reverses may never knock at your door. We are glad to have you with us, Felix, and when you go hence, may we all feel that our friendship ties are just a little closer and a little stronger than they have ever been before.

In closing, may I hope that while we will probably not meet in this life again, yet may we meet in a life to come, where we will know each other as we are known.
