PICTURESQUE PIONEER OF NORTHERN CALIF. IS DEAD

YREKA, Calif., Dec. 30.—Although failing rapidly, and for the last few days not conscious of any material thing, Nelson Harvey Eddy was allowed to live in accordance with his oft-expressed wish to be 91 years old, and he answered the final summons on Monday evening, December 26, not twenty-four hours after passing his ninety-first milestone.

Mr. Eddy, accompanied by his wife, came to the Shasta valley with the New Lebanon company, from Illinois, in October, 1854. During his years of active ranch life which followed, Mr. Eddy was known as one of the most progressive and prosperous stockmen of northern California, and much of his life was spent in the saddle.
