ON HORNS OF A DILEMMA

A great clamor has arisen in Ashland over the publication of an article in the current issue of the Oregon Motorist. Below we print the article in full in order that readers may exercise their own judgment in arriving at a decision as to what extent the harsh criticism is justified by the facts in the case. Much that the article contains is untrue, and Mayor Lamkin and Chief of Police Hatcher have sent a communication to the editor of the Motorist, a copy

of which will be found in another column, replying to the statements contained in the article.

The city authorities are confronted with a delicate situation; having on the one hand the safeguarding of the lives and limbs of nearly a thousand children in attendance at the schools, which, unfortunately, adjoin and face the Pacific highway. And on the other hand, they are brought face to face with the undeniable fact, that motorists, naturally, set up a howl when they are haled into court for violating the speed laws, and spread the report that Ashland is seeking to build a Chinese wall around itself, and advising their fellows to give the city a wide berth. This is essentially a tourist town, with more attractiveness than any other in the whole state, and not without just cause is it known from one end of the coast to the other as "Beautiful Ashland." To have the tourist traffic diverted from this city could not be regarded as other than a public calamity, and it does seem that some middle ground could be reached, whereby observance of the law, in the spirit at least, rather than in the letter, could be reached, without antagonizing the tourists to the extent that their itinerary will be "to" rather than "through" Ashland.

Here is the article which aroused widespread indignation:
"BEWARE OF ASHLAND SPEED COPS—DRIVE SLOW—DRIVE THROUGH"

"It has been reported that the city of Ashland has entered the ranks of those somewhat obsolete and decidedly unpopular 'burbs' in the rural sections that are wont to play on the motorist during the busy season. The beautiful little city near the California line has placed two or three ancient citizens on the payroll with instructions to grab any automobilist who travels faster than 12 miles through the city. That these cops are 'on the job' day and night, is evinced by the numerous complaints which have come into the main office during the past week.

"The method of operation of the Ashland officers is somewhat unique. Representatives of the California Automobile association report that they were arrested while passing through the southern Oregon city recently at a rate not exceeding 15 miles an hour. Two cops with long chin whiskers, one on each side of the street, stopped them by holding long bamboo fishing poles across the street. The California motorists were haled before a justice of the peace and compelled to wait an hour before they were allowed to proceed with a reprimand. That they were not compelled to pay a fine they attribute to the fact that they were representatives of the California association. These gentlemen claim that they saw five California cars stopped, but that Oregon cars seemed to be immune from prosecution.

"If Ashland is starting out this early in the touring season to mulch the traveling automobilist, the city fathers down there will do well to stop and consider. The word of such tactics as is used by officers in that city spreads like wildfire among automobilists, and it will only be a short time until motorists will pass 'slowly but surely' through the city, refusing to stop or spend a cent. The loss in revenue which will surely result will be keenly felt by the merchants thereof.

"Twenty miles is the limit in most cities throughout the state, and the sooner that Ashland wakes up and lines up with the big majority the better it will be for her own good. 'Nuff said!'"

The estate is worth \$10,000, the petition estimates, \$8500 in realty in Multnomah and Coos counties, and \$1500 in personal property. The daughters are Florence B. and Frances Bowker. Mrs. Bowker was appointed administratrix.
