FLIVVER KING WILL LEAD IN FORD PARADE

51 PRIZES ARE OFFERED TO WINNERS OF VARIOUS EVENTS

Cars Entered in the Parade on Ford Day Are Eligible for Entry in the Parade on the Fourth of July Also Is Decision of Committee.

Chairman McGee is reported to have had a communication from Henry Ford to the effect that he can be depended upon to be present on the occasion of the big Ford parade next Monday. It is further currently reported that the efforts of Conan Doy's were enlisted to secure the presence of the master of the flivver on this auspicious occasion, and that he will certainly have him here, in the spirit, if not in the flesh. According to all reports, the famous author stands aces up in the spirit world and can be relied upon to make good, so that spectators may rest assured that the presidential possibility from Dearborn will be in the parade to supervise the motley collection of his works.

Ashland's Ford Day parade should contain the largest collection of Ford cars ever seen in Ashland at one time, and, if the committee in charge has its way, the flivver cavalcade will excel in decorations, as well as numbers, anything attempted in this section.

There are 16 events, or classes, which Ford owners may enter, and 51 prizes are being offered to winners of the various entries. A total of \$220 in cash and an equal value of merchandise offered by business men of the city is represented.

It is hoped that every car entered in the Ford parade will be in the parade the next day—July 4th. No additional work in decorating the machines will be necessitated, and there will be a chance of winning a prize in the Fourth parade, in addition to anything that might be won in the Ford Day parade.

An extra prize has been added to the Ford Day list for the best float mounted on a Ford truck or chassis, and floats competing for this award could be entered the following day without any change. If decorated originally and artistically, there would be opportunity for an entry of this sort to get in on the prize money both days.

The Ford Day committee have decided to furnish a state license plate with the Ford car to be given away the evening of the third. This is in addition to other accessories originally placed on the machine.

RAILROAD OFFICIALS VISIT BUSINESS MEN

SEN. McCUMBER LOSER IN RACE FOR RE-ELECTION

WASHINGTON, June 29.—Senator McCumber, in a statement to the International News Service, virtually conceded his defeat to former Governor Frazier, in the North Dakota republican primary.

"The lead I've piled up in the cities will be overcome in the country," McCumber declared. "I'll issue a formal statement later explaining the causes for the result."

Ex-Governor Frazier is a Non-partisan candidate, who less than a year ago was recalled.

ASHLAND TO HAVE PARADE ON BOTH THIRD AND FOURTH

The Lithians held a "popoff" last evening in the band stand near the Chautauqua auditorium, to discuss the various features of the Fourth, including the parade and their own activities on that date.

It seems to be the mistaken opinion of some people that there will be only one parade this year, and the Lithians wish to reiterate the statement that there will be a parade on the 3d of July, with Fords of every description, including trucks and Fordson tractors. On July 4th, there will be another parade, with floats of every kind and description, as well as all kinds of decorated cars. It is hoped that every Ford that is entered in the parade of July 3 will be found in the parade on the Fourth. The parade committee asks particularly that every car winning a prize in the Ford parade be re-entered the following day, as there will be a great many people present on the latter day that will not be able to get here on the first day.

Discussion of the hour of the parade the Fourth was also taken up, and it was decided to start promptly at 10 o'clock from the corner of Helman and North Main street, the same as the Ford Day parade, with Fred Homes as marshal of the day. The Lithians will have charge of lining up the floats and cars, after which they will march with the float bearing the "Queen of the Lithians." They will be identified during the day by hat bands bearing the word "Lithians." All are to wear straw hats, white shirts, black ties and dark trousers.

Members have been plied with the question of "Where does the surplus money go from the Ford tickets?" In answer to this, the local Ford dealer gets the exact cost of the machine set down in Ashland, minus any commission, and the total sum collected from the sale of tickets, above this amount, will go into the general Fourth of July fund.

Following the popoff, two members were taken to the regular popoff place in the park, and obligated to the organization.

SCORE SAWYER FOR NEGLECT OF VET HOSPITALS

ECONOMY POLICY OF HARDING'S PHYSICIAN IS SEVERELY CRITICIZED

Charge Is Made That General Sawyer, With an Appropriation of \$18,600,000, Has Failed to Provide a Single Hospital.

SAN FRANCISCO, June 29.—Much of the blame for the government's shortcomings in hospitalization work for world war veterans should be placed on Brigadier-General Charles E. Sawyer, President Harding's personal physician. So declared Humphrey Sullivan, of St. Louis, representing National Commander MacNider of the American Legion, yesterday in an address in behalf of the American Legion before the convention of the Disabled American Veterans of the World War.

Sullivan charged General Sawyer, who is head of the federal board of hospitalization and given authority by Director Dawes of the budget, to determine its policy, with attempting to economize at the expense of the health of wounded service men. He charged that with an appropriation of \$18,600,000, after 14 months not one of the new hospitals provided for by act of congress has been established.

Sullivan said that General Sawyer had announced his policy as preferring to spend that money for the purpose of developing places of domicile on that will be comfortable for the individual who passes the hospital period.

"When we read in the papers that veterans are committing suicide at the rate of two a day, we wonder if the brigadier general is speaking of graves," said Sullivan.

FIRE DESTROYS GAMBLING HALL LOSS \$500,000

MEXICALI, Mex., June 29.—Fire which last night destroyed the second city block to be consumed by flames here within two days, causing estimated damage in excess of \$500,000, was under control early today.

Flames broke out simultaneously at two widely separated points on the property of the Owl cafe, famous gambling hell, which with its subsidiaries, occupied the entire block.

BUSINESS ON UP GRADE DESPITE STRIKE THREAT

WASHINGTON, June 29.—Despite the coal strike and the threatened railroad tieup, the business of the United States continues to improve, high officials of the treasury department said today.

Improvement is accounted for by the heavy summer buying of stocks in preparation for winter trade.

AMAZONS JOIN RANKS OF THE IRISH REBELS

DUBLIN, June 29.—Two republicans were killed in a futile attempt to capture a battery of the Free State artillery at Dublin castle. Firing has broken out in Dame street, where a woman was shot dead and two were wounded. The bombardment of the rebel strongholds in the Four Courts area still continues.

The republicans have seized the buildings of strategic importance in Connell street. All shops have been compelled to close. Fighting was resumed this morning after a lull of several hours. Colonel Moundeville and Captain Vaughton of the Free State army were killed when a detachment of their troops were attacked from ambush.

A great many women are enlisted in the republican ranks. All kinds of material are being commandeered. Residences at the corners of strategic streets are being seized and converted into blockhouses. The casualties have been light, in view of the severity of the fighting. The dead are estimated at 15, and the wounded at 40.

The leaders say it is impossible to say when the civil war will end. While the Free State troops have been successful in routing the irregulars from some of their positions, they have been unable to achieve a decisive victory. The indications are that hostilities will continue for days.

UNION CHIEFS CHARGED WITH A CONSPIRACY

GOVERNMENT TAKES DRASTIC MEASURES TO PREVENT RAIL STRIKE

Cites Brotherhood Leaders and Officials of Association of Railway Executives for Hearing Tomorrow to Avert Strike Set for Saturday.

CHICAGO, June 29.—The government, through the agency of the United States railway labor board, made its first move to avert the nationwide railroad strike called for Saturday.

The union chiefs—heads of federated shop crafts, maintenance of way brotherhoods, signal men, clerks, stationery engineers, and firemen's organizations—were cited by the labor board to appear before the board tomorrow on charges of conspiracy to interfere with the operations of the railroads.

Officials of the American Association of Railroad Executives have also been cited to appear before the board tomorrow.

This action is taken under the transportation act, which provides that the board, at any time it believes cessation of railroad traffic is threatened, can take jurisdiction.

The opinion is expressed in well-informed circles that the strike may be averted, despite the obdurate attitude of both the union chiefs and the railway executives.

MILLER TRAINING HARD FOR MATCH WITH RALPH HAND

Telegrams received here from Walter Miller at Los Angeles would indicate that he does not hold Ralph Hand cheaply. The pair will meet here on Monday night in the Armory in a wrestling match in which the middleweight championship of the world is involved. They have met before, and Miller won out on a narrow margin. As a consequence he is training industriously for Monday night's go.

Hand is in training in Cottage Grove, but as he is battling pretty much all the time, he is always fit as a fiddle. Fans look forward to this event with keen anticipation, as it is among the possibilities that the championship may change hands as the result of the meeting Monday night.

BELFAST, June 29.—The barracks at Drogheda, which has been held by the republican irregulars, has been recaptured by Free State troops.

BIGGEST RAINBOW CATCH OF SEASON AT ROCKY POINT

What was declared to be the biggest catch of rainbow trout at Rocky Point this season, was taken Sunday by William Smith and V. V. Hedgpeth of Kamath Falls, and W. M. Anderson of San Francisco, traffic agent for the Chicago Great Western Railroad company. The fishermen arrived at Rocky Point Saturday evening, and by early Sunday had caught the limit.

MEXICAN REBELS FREES AMERICANS THEN RAID AGAIN

WASHINGTON, June 29.—Forty Americans and a quarter of a million dollars worth of American property, belonging to the Cortez Oil company, seized Monday near Tampico, by General Gorazabe, a Mexican rebel, have been released, according to official advices reaching the state department.

The rebel general, however, left the camp and proceeded with his men to a camp of the Lahoare Oil company, near Tecero, where he seized property and 35 workers in the camp. The property is owned by Dutch-British interests. Included among those captured were six Americans.

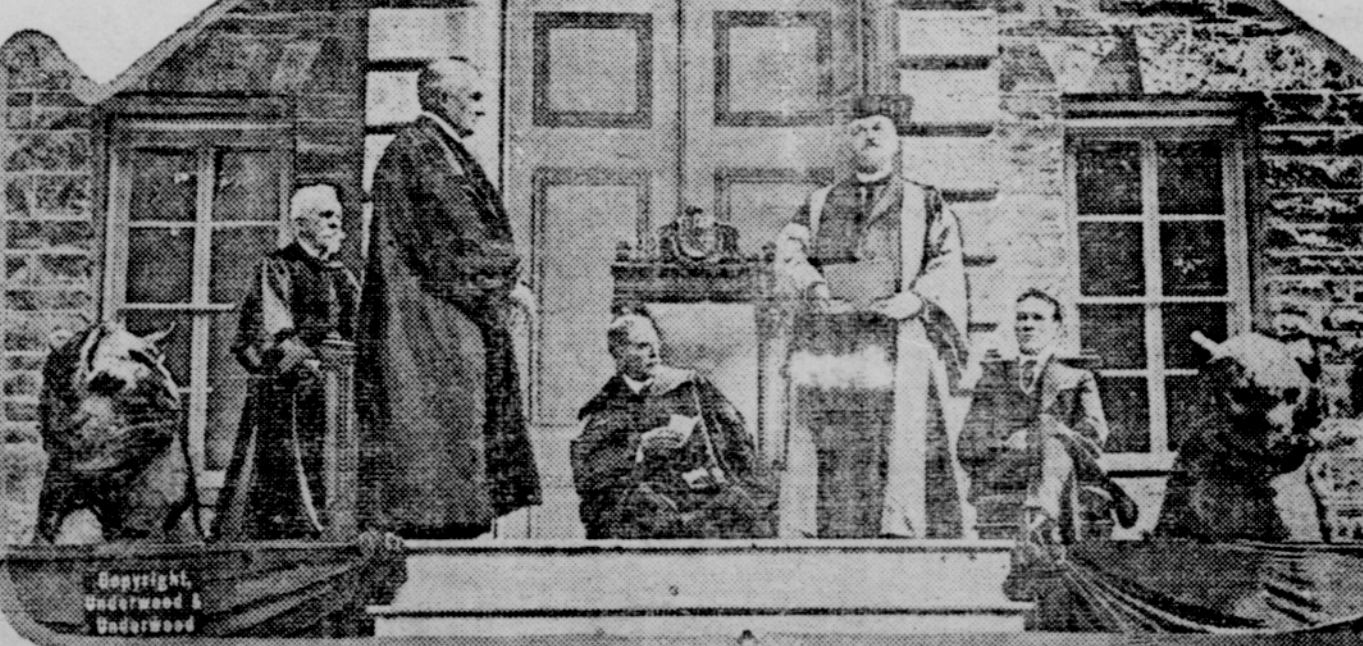
HOWARD W. ODEN AND LOUISA EDWARDS MARRIED

BANK CASHIER CONFESSES HE STOLE \$41,000

LEADING WOODLAND CITIZEN HAD TAPPED BANK FOR TEN YEARS

Took One Thousand Dollars at a Time, Making Forty-One Inroads On Bank's Funds—High Living Caused Downfall.

WOODLAND, Calif., June 29.—Voluntary confession that he had embezzled \$41,000 from the Bank of Yolo, where he has been assistant cashier since 1912, by Floyd L. Tuttle, active in church and fraternal circles, and federal food administrator for Yolo county during the war, caused a sensation here today and placed Tuttle behind the bars at the county jail awaiting the placing of a formal charge against him by the district attorney's office.

Tuttle's confession, which came with the force of a bombshell to his many friends, was made in the office of Sheriff J. W. Monroe at 11:30 o'clock last night. Before the sheriff, District Attorney C. C. McDonald, a court stenographer and officials of the bank, he bared all details of his defalcations over a period of years, starting 12 months after he became assistant cashier.

Forty-one times since 1913, he related, he had appropriated \$1000 of the bank's funds to his own uses, falsifying the records to conceal the defalcation. Each time he believed the money could be returned, and never, he asserted, had he taken more than \$1000. The total of his shortage had run up to \$41,000 before he realized it, he added. He attributed his downfall to high living.

HANGING BACK ON THE RECALL OF SHERIFF TERRILL

The petitions circulated for the recall of Sheriff Charles E. Terrill, and the nomination of D. M. Lowe, farmer and fair exhibit expert, to make the race against him, has not been tied with the county clerk up to this afternoon. The county clerk said he was informed the petitions were to be filed Tuesday afternoon at 2 o'clock, but they failed to materialize. It is not known what is delaying the petitioners, as they have plenty of signers—1600 names having been secured the first day, according to reports.
