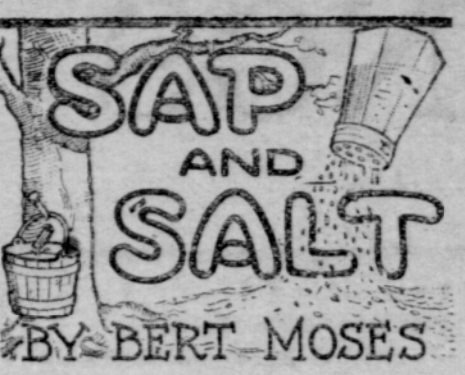

MAKE IT A PROGRESSIVE ASHLAND

We do not believe in mud-slinging in politics—especially local politics. We are all citizens of a city of wonderful possibilities. We should all want to act in such a way as to keep our friends and put the city forward. However, folks differ on public policies, and we think, rightly so. It would be a dull old world if everybody thought and acted alike, but, if we should hear the nastiest story possible on Dr. Blake, we would not repeat it, for, ten chances to one it would be a dirty lie; if we repeated it, it would do our cause no good and might do him an irreparable injury. We believe, however, in speaking out our opinions straight from the shoulder without vilification, innuendo or evasion. If there is no good argument for our position, we are not right in assuming it. If we think citizens are acting in such manner as to thwart the town, we have no hesitation in naming them and saying why we think they are. We can see nothing wrong in that. Anyhow, we insist on doing that in all good spirit, but in simple and plain language.

Factions are good for a community. They do not tear down; they build up. When factional spirit runs high, men, otherwise passive, become interested in the affairs of the city and are active advocates of this policy, or that. What is everybody's business is nobody's business, unless the issues are crystalized and vitalized. No business conducted haphazard will succeed. Certain fundamental policies must be established in any private undertaking to bring it to a successful goal. So, in public business, certain definite policies should be established and adhered to. If men aspire to office there should be a greater reason for it than mere personal ambition. They should recognize what they consider real specific needs and should set these needs down, according to their views, and publish them so that citizens may know what they stand for and the specific policies they intend to pursue, if elected. Upon these issues they may be judged.

The Tidings is perfectly sincere in its advocacy of a change in the personnel of Ashland's administration. We think the wrong spirit has been exemplified and wrong policies have been pursued during the past two years. Many things can be done, without additional cost to the city, which will strongly tend to build up the town, if its administration exemplifies, through its officers, a genuine, effective, progressive spirit while a non-progressive, don't-care-a-rap spirit always proves a handicap to progress. tribute to health and progress. The election of the Blake ticket will be a public approval of those policies. The election of the Loomis ticket will indicate a desire on the part of citizens for a more progressive administration.

Without regard to individuals, it is the Tidings hope that the Loomis ticket be elected from top to bottom. We think it will be a good thing for the town.

LOOMIS PLATFORM
 Being a candidate for mayor of Ashland, I make the following statement of the policies I stand for, and the position I take on the issues of the campaign:

The first consideration of a city should be the health of its people, I am, therefore, in favor of taking every precaution to protect the water of Ashland creek from pollution. It must be kept pure.

I believe in the enforcement of the laws, particularly those against gambling and bootlegging.

I am opposed to factions in Ashland, and promise, if elected, to be the mayor for all the people, rather than for a part of them. My slogan is this: "The way to get action is to unite every faction."

I am in favor of the new hotel project. We have the scenery, the climate, the soil and the people—everything here except a modern hotel to attract newcomers. Let's get that hotel!

I am proud of Ashland's fine reputation everywhere in the matter of schools and education, and I favor any suitable action looking towards the re-opening of the normal school.

I am in favor of having all offices and all positions on the city's payroll filled by citizens and taxpayers of Ashland itself. No outside place-holders!

I believe that when the people vote in favor of anything they should get it, and I am opposed to all forms of trickery, particularly the so-called "jokers" that are often used to deceive the voters. I believe that being on the level is the highest form of American citizenship.

The present water supply for Ashland is inadequate, and I favor taking immediate steps toward increasing the supply through such measures as the people may adopt.

I believe the mayor and city council should give their moral influence and support to all practical projects for profitably utilizing the fruits and vegetables of this community. At present, thousands of dollars worth of local products go to waste for lack of canning and preserving facilities.

On these principles I ask to be judged.

Light Being Thrown On 1927 Exposition Before Election Day

A final explanation of the purposes and plans of the Oregon 1927 exposition has been issued by the general committee under the heading, "The Exposition Means Immediate State Development," the state has been issued for general distribution between now and the election on November 7th, when the exposition issue will be finally settled.

It is proposed that the 1927 exposition shall be the central feature of a ten-year development plan for the entire state," says one of the significant paragraphs. "If you believe that Oregon should at once institute some tangible and impressive method of state development you can confidently give your approval to the exposition measure."

"The one purpose of the exposition is the development of Oregon and Oregon resources. The present undeveloped condition may be seen from the fact that in spite of size and fertility, Oregon has but one-third the population per square mile that Washington and California have. Oregon has eight persons to the square mile; Washington 20, and California 22. The one relief from Oregon's burden of taxation is more people to develop more wealth to share the tax burden."

"The exposition is to be financed by Portland, no tax levy being provided in the state and none being anticipated or proposed. The state is voting on the question of permitting Portland to tax itself. Portland naturally is interested in the development of Oregon, and the state should be willing to encourage this effort to the extent of extending moral support."

1923 AUTOMOBILE TAGS PROCURABLE AFTER NOV. 4

Next Saturday will mark the opening date for the procuring of the 1923 license plates for automobiles, and those who have a leaning toward the smaller numbers had best send in their applications to Secretary of State Sam Kozer. Assignment of the new plates will begin on that date.

Based upon the registration of more than 131,500 automobiles and trucks, the total registration for the coming year is estimated at 145,000 according to Mr. Kozer.

In contrast to the plates this year, the 1923 licenses will consist of white figures on a dark blue background.
