M'KEE IS GUEST OF LITHIANS

Prominent Copco Official Tells of Firm's Efforts for Development.

East Interested in Oregon and Expects to State Soon to Be Under Way.

"Not large cities, nor a large city is what we are most interested in in the development of southern Oregon," said Mr. Paul B. McKee, vice-president and general manager of the California, Oregon Power Company, in an address to the Lithians at the Plaza Confectionery last night.

"Our interests are entirely selfish, in this respect. But, in it is a cooperation and progressive development which will result in the achievement of our endeavors and the increase of population in the southern part of Oregon," said Mr. McKee.

"To do that we have undertaken the effort to advertise Oregon in a positive way, rather than a negative way, and sticking to the truth in endeavoring to entertain favorable thoughts in the minds of folks whom we can interest in the future of this section," he continued.

"Back East, every time I have been there in the past three years, the interest seems to be growing about the opportunities in the west, especially along the coast, and more particularly in Oregon. But, they have not been told the real beautiful story of Oregon's opportunities.

Mr. W. H. Crawford, also a member of the Copco organization, made a short talk in which as head of the development department, he has undertaken to aid in the development of some specific enterprise in each community which the company serves.

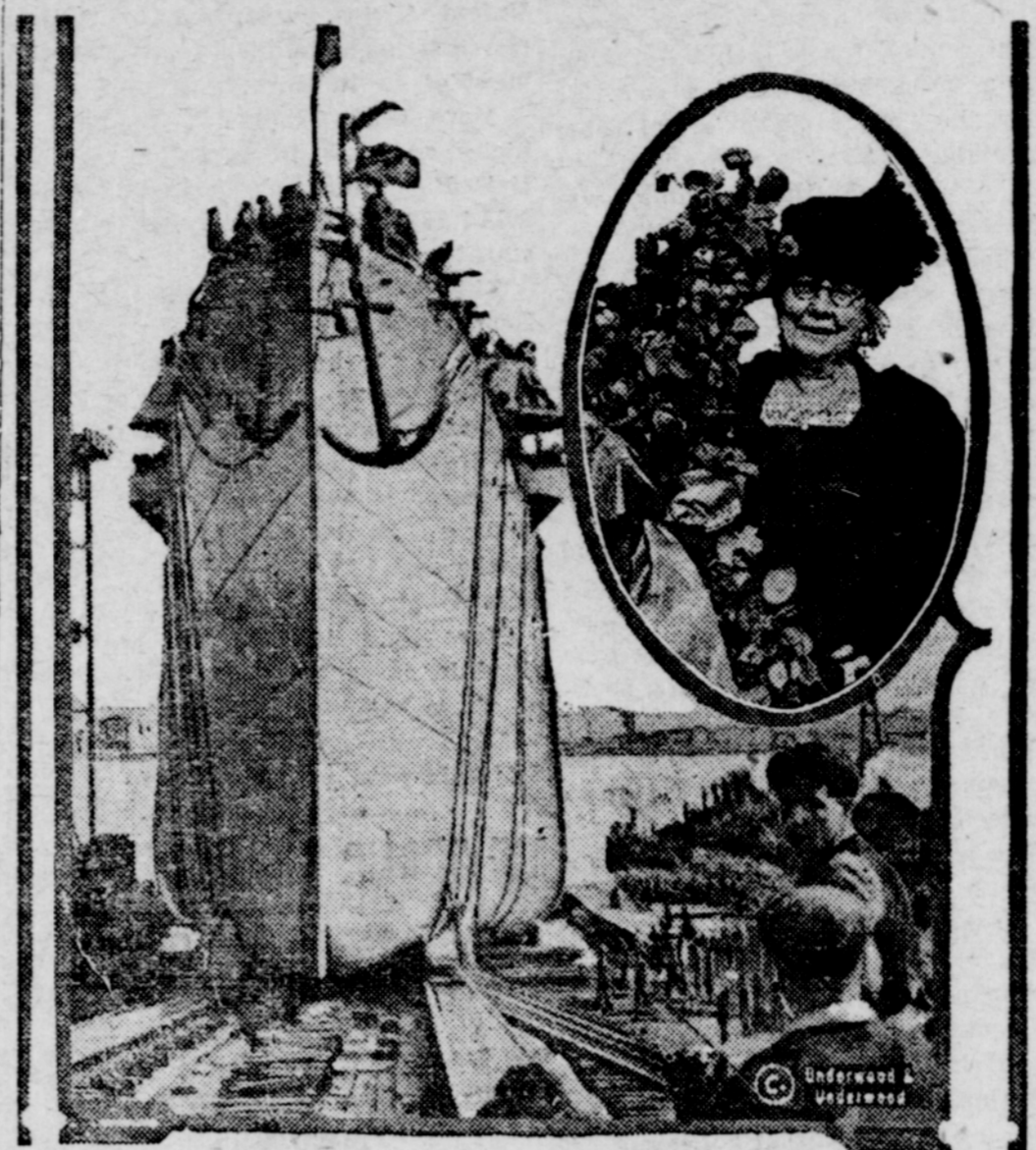

ASHLAND CHIEF TOURIST TOWN

Irving E. Vining Says Coast Recognizes Ashland as Major Tourist Center

Urges Year-round Tourist Camp and Extensive Improvements in Auto Camp and Park.

Irving E. Vining, well known citizen of Ashland and president of Oregon State Chamber of Commerce, was one of the speakers at the meeting and banquet of the Lithians last night and delivered a forceful address on Ashland's importance as a tourist center and the imperative demand for extensive developments and improvements of the famous auto camp and park.

Mr. Vining emphasized the fact that the Pacific coast recognizes Ashland as the major tourist camp town of the West, and made suggestions for improvements that are vital if Ashland's prestige is to be maintained.

"The entire Pacific coast recognizes Ashland as the major tourist camp town of the west, even Portland admits it, but the day of a seasonable tourist camp is short in vision. Ashland should capitalize her location and geographic conditions and go a long step forward. Ashland should start now to take up the slogan 'Ashland, The Year-Around-Tourist Camp.' Right now Ashland could and undoubtedly should build in its tourist camp as many as twenty-five modern, artistic, convenient and small cottages. That comes within the province and authority of the city, and its opportunity in the ownership of the park land, to make for itself, at the least expense, the most wonderful advertising and financial aid in the town's development, by making Lithia park, a year-around tourist camp. Instead of throwing the profits of the park's seasonable business now back into the city treasury, it should use these profits to enhance, build and enlarge its tourist facilities to where it will accommodate year-around travel. Because all year travel now is not a myth, but a fact, which if allowed to pass through in search for a delightful winter location, will be enticed away from us.

"The people are going to the mountains, and finding it more enjoyable and more stable and fewer extremes than many of the seashore resorts. Ashland has within it the makings of an ideal year-around resort. It can be done if the proper people with the proper means and ability are interested and allowed to make use of the locations and the natural advantages the community affords. While they are making a profit from the development of the untouched resources, the community, as a whole and individually will be making a commensurate return.

"Along that line the railroads of the East, and the West as well, have outlined a plan through their advertising managers, because of the fine work of Mr. Dudley, executive manager of the Oregon State Chamber of Commerce, to advertise the Northwest, particularly Oregon, as the yet untouched and undeveloped empire of the United States, agriculturally, industrially, minerally and scientifically. Most of their advertising heretofore has stopped no farther west than Yellowstone Park, the Royal Gorge or the Grand Canyon. But, the features and untold possibilities of the Northwest and the specific advantages of Oregon are to be strongly featured. Ashland can help in making these things successful."
