IMMEDIATE ACTION NECESSARY

The report and recommendation of the Park board, the expression of a number of citizens and the vote of many others at the meeting of the Chamber of Commerce left no doubt regarding the need and demand for enlarging and improving the auto camp. The endorsement received is sufficient to justify the Park board in preparing plans for necessary extension and improvement.

There is no apparent opposition to expending \$10,000 on the proposed improvements and extensions. There is, however, an honest difference of opinion as to the method of financing the improvement. A bond issue has been suggested. Another suggestion made is that the business men of the town associate in some organization, negotiate a loan of \$10,000, turn it over to the Park board, requiring an agreement from the board to wipe out the amount as funds are received from the receipts from the camp ground, and thereby avoid the expense and delay of issuing bonds, as well as affording a method of getting away from the increasing bonded indebtedness of the town.

There is a prevailing sentiment that all of the receipts earned by the auto camp ought to be reinvested in the enlargement and improvement of that utility. The actual receipts from the auto camp and park last year, not including the amount derived from taxes, amounted to \$7,025.94. Included in this is an item of \$300.00 paid by the city for the care of the park. The figures indicate, however, that if it were possible to turn back to the auto camp all of its direct earnings that within a period of two or three years at the most, the obligation of \$10,000 for present enlargement and improvement could be paid in full, together with interest.

The Tidings is of the opinion that a plan can be worked out with comparative ease that will afford necessary finances and satisfy a majority of citizens. This is not a time for controversy, but for honest discussion and arrival at a plan that is sane and agreeable generally.

The question affords an opportunity to the Chamber of Commerce for service. Or it affords an opportunity to the various commercial organizations of the city to work out a plan whereby finances can be made available and at an early date. Whatever action is taken, and regardless of the source of the plan, the Park board and city administration deserves to be consulted and are entitled to cooperation.

By way of suggestion: let the Chamber of Commerce go into the question at an early date, use plans it may evolve, obtain suggestions from others, finally arriving at some method which will provoke a minimum of opposition. In this connection, it is meet to say that nothing will be gained by procrastination.

DAVID HITS THE MARK

There is an article appearing in today's Tidings under the Forum head by David Mark that hits the mark, and calls attention to the careless voter of the importance of registering.

The manner in which the writer scores the indifferent and uninterested voter may be the means of awakening some to the importance of registering and voting for candidates and on public measures. Were a proposal made to disfranchise those who fail to register or those who fail to vote a protest would be forthcoming that would resemble a Kansas cyclone, or perhaps a Mexican revolution. Yet those who would combat the proposal with the greatest force are those who fail to register year after year and neglect to go to the polls and exercise the right of franchise as is becoming every good citizen.

The man who fails to vote is failing in his duty and responsibility as a citizen. He is not measuring up to the standard demanded by a republic. The number of people who fail to vote is appalling and is retarding the progress of direct government.

WHAT ADVERTISING DOES

America has the best life on this earth because it has the best advertised life, says Colonel W. G. Edens of the Public Relations Commission, American Bankers' Association. He goes on: "American health is the best in the world because American people are best informed in the ways and habits of health, largely through advertising. American business is the largest and most successful in the world because it uses advertising the most. American business men enlarge their business institutions in proportion as they advertise them. American buyers become more shrewd in spending their money in proportion as they read the advertisement."

"The press of the United States is regarded by many as the most powerful of our institutions. It must be numbered with the schools and the churches as one of the prin-

ity of most powerful creators of knowledge and patriotism.

"Advertising is what it is today largely because of the power and success of the daily paper. Nevertheless, it is true that the daily paper is as successful as it is today because of advertising."

"The banking business has been benefited largely by advertising within the last dozen or fifteen years. Banking institutions have done more advertising than ever before. They have installed advertising departments which acquaint their communities with facts formerly regarded in the light of institutional secrets. The banker publishes facts which build up confidence in his institution."

"The result has been that millions of people who formerly would not place their money in the care of bankers, but who hoarded it at home, entrusted it to friends or invested it in wildcat speculations, now regard the bank as the safest place in the world. Hundreds of millions of dollars have been brought from their hiding places and placed in circulation, much to the advance of America and American institutions, as well as American business. Newspaper advertising has done more for American banks in the last dozen years than any other single agency."

SPEAKING OF SPEED

There are times when it pays to be in a hurry and other times when it doesn't. Today a number of Josephine county residents found it does not pay to be speedy when visiting in a neighboring county for they were assessed fines for going a few miles over the speed limit last Saturday night, while on their way to Medford to patronize a show being given there. Besides losing the money and the entire morning, the persons involved have lost a little of the kindly spirit which has been hoped could be built up in southern Oregon.

The drivers of the cars state that they were not driving at an excessive rate of speed, yet they were hailed into court. It was not just one or two who were held up. The traffic officer seemed to be concentrating on the people from this county for he was only a few miles from the Josephine county line. It would not have been so bad had there been some real occasion for the sudden outburst of law enforcement.

AGRICULTURAL EXPORT COMMISSION PROPOSED

WASHINGTON, Jan. 16.—The creation of a four hundred million dollar agricultural export commission has been proposed in the senate by Senator McNary, of Oregon. The bill would place the secretary of agriculture at the head of the commission, with authority to buy farm products and sell them abroad, while extending credit to the farmers.

HOOD RIVER FERRY SERVICE IS RESUMED

HOOD RIVER, Jan. 17.—Ferry service between here and White Salmon, Wash., was resumed yesterday, shore ice having been broken and the river having risen about a foot. During the cold weather the Columbia dropped below zero, and power ferry boats were unable to make the Hood River landing at the low stage. The breakup of ice on the upper river filled the current here with many small ice floes.

NEWS LETTER

NEW YORK, Jan. 16.—Little Old New York is just that. Aged as the United States itself, the metropolis is little, too; smaller in area than many a city whose entire population could be hidden away in a corner of one of her boroughs. And yet: The population of New York equals the combined populations of Portugal, Sweden, Switzerland, Denmark and Norway—and there's an addition each year of 150,000, which is double the entire population of the State of Nevada.

To bring home the figures, there are more people in the Greater City than there are scattered through Arizona, Montana, New Mexico, North Dakota and Utah, the City of Chicago, Cheyenne, Wyo.; Houston, Tex.; Rochester, Syracuse, Kokomo.

More men and women work in the garment trade alone than the total number of those who live in the State of Wyoming. One million children attend schools in the city—and play in the streets. It takes 30,000 teachers—the population of Colorado Springs, Colo., to care for them. The cost is \$88,000,000 a year.

As many men and women work for the city of New York as live in Erie, Pa. It takes 2,816 buildings to house this army of workers. A total of 7,500 work in the Municipal building alone. It costs \$1,000,000 a day to operate—more than the next ten largest cities spend jointly.

The cost of operating the Fire and Police Departments—\$51,000,000 a year—is more than Boston spends to run its entire municipal government.

The budget for the Police Department alone is greater than the entire State budgets of Alabama and Mississippi.

Stretch New York's paved streets out in a row and there would be a highway stretching to El Paso, Tex.

There are 880 single-track miles of elevated and subway lines. The total number of passengers carried in one year exceeds the total population of the earth. More people ride in it in one day than are transported over the combined steam railroads of the United States.

The city's foreign commerce is 74 per cent of the entire total of the United States. The aggregate of real and personal property equals that of all the assessed property in the United States west of the Mississippi River.

Births exceed deaths two to one, and there's a marriage every ten minutes.

GRANTS PASS DRIVERS GRABBED BY M' MAHON

Hurrying Home From Seeing Pavlova, They Fall Prey to Traffic Officer.

The following is from the Grants Pass Courier and appeared under the heading "Local Men Contribute to Jackson Campaign."

"Josephine county residents are today contributing toward the Jackson county coffers as the result of the opening of the political campaign in that county. On Saturday night, when local people were turning out en masse for the Pavlova ballet, there was a reception committee awaiting them, in the person of J. J. McMahon, aspirant for sheriff in the neighboring county. Estimates placed the number of victims anywhere from six to 12. 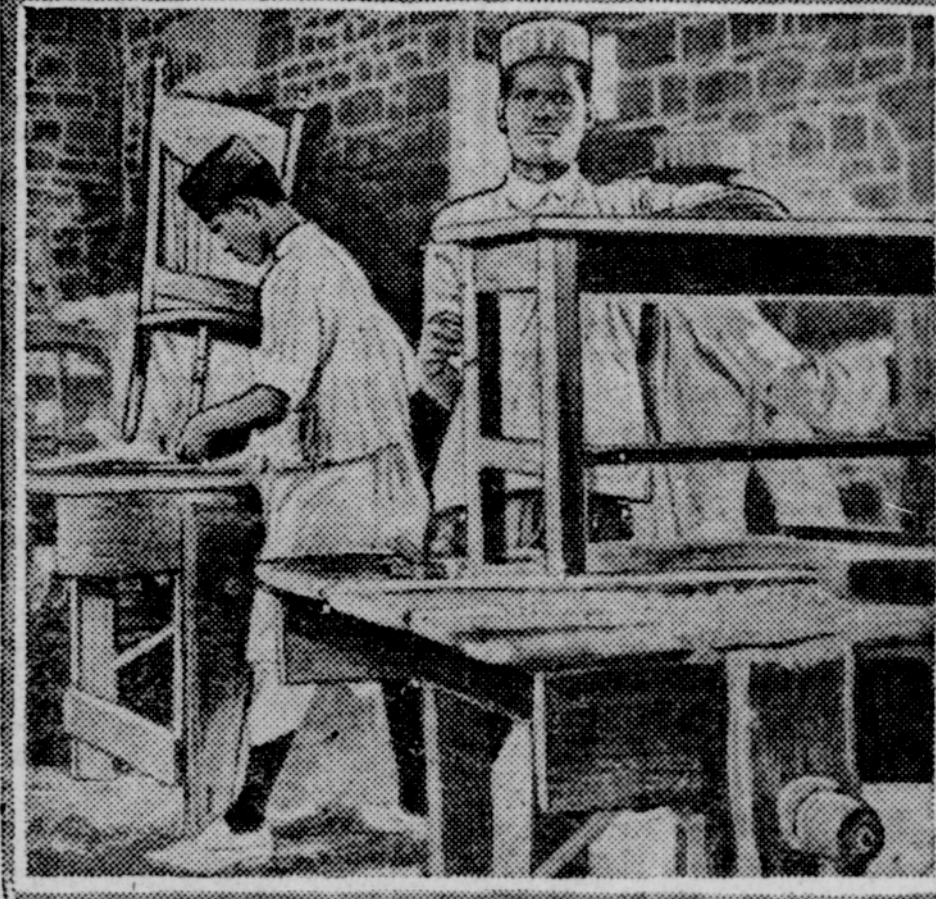
Resolutions of Condolence

Lack of Funds Threatens to Curtail or End American School and Hospital Work Abroad

Just when a stricken world is looking most expectantly toward America and relief comes the report that one of the oldest and most widely spread humanitarian agencies of the United States is in imminent danger of having to curtail or even abandon much of its work in foreign lands.

According to a statement just received by local Presbyterians from Robert E. Speer, secretary of the Board of Foreign Missions of the Presbyterian Church in the U. S. A., whose headquarters are in New York, a balance of \$8,444,170 must be raised by March 31, 1924, nearly three times the amount raised in the past eight and a half months, if its medical, educational and other work of ministering to suffering humanity is not to be curtailed.

In striking Japan, torn China, the stricken Near-East and in the scores of other corners of the earth where the missionaries are spreading the fruits of American civilization in the form of relief from hunger and disease and of enlightenment through education and the Christian religion, the work of the Presbyterians is threatened by lack of sufficient support by those at home.

Not only those who need American help (for there is no other) suffer by closing hospitals and schools, but the missionaries themselves would have to undergo privations. Some of the hospitals founded and operated by the Foreign Missions Board are said to provide the only medical care available for millions of people.

The statement of the Board of Foreign Missions discloses that there is a present deficit of \$624,147.18, growing out of a deficit from war years, from increases to provide living salaries and expenses of missionaries, and other additional expenses. The aim is to wipe out this deficit and to meet immediate requirements. The Board's statement does not complain that American Presbyterians have not been giving in increasing amounts to the work of its foreign missions, but does make clear that the increase is not sufficient to keep up with advancing costs of maintaining the workers in foreign lands.

Unless the appeal of the Board is heard and answered, "the work we have spent life and prayer to build up during three generations must be sacrificed," reads the statement.

THE PLAN IN BRIEF

Proposes 1. That the United States shall immediately enter the Permanent Court of International Justice, under the conditions stated by Secretary Hughes and President Harding in February, 1923.

2. That without becoming a member of the League of Nations as at present constituted, the United States shall offer to extend its present cooperation with the League and participate in the work of the League as a body of mutual counsel under conditions which

1. Substitute moral force and public opinion for the military and economic force originally implied in Articles X and XVI.

2. Safeguard the Monroe Doctrine.

3. Accept the fact that the United States will assume no obligations under the Treat of Versailles except by Act of Congress.

4. Propose that membership in the League should be opened to all nations.

5. Provide for the continuing development of international law.
