STATE GIVES AID IN COW INSPECTION

Veterinarian Comes to Conduct Tuberculin Tests Among Dairy Herds

COOPERATION DESIRED

Tests Will Be Made Free But Owners Urged to Register Immediately.

Dr. H. H. Green, veterinarian from the office of Dr. W. H. Lytle, state veterinarian, arrived in Ashland this morning and in conjunction with city officials is preparing to begin a tuberculin test of all cows from which milk is being supplied to patrons within the corporate limits, for the purpose of carrying out the provisions of an ordinance recently passed by the city council.

The arrival of Dr. Green is hailed with satisfaction by dairy owners whose herds have not been subjected to the test within the past year.

Tests Are Free
Dr. Green advises the Tidings to announce that the tests will be conducted free of charge to dairymen, saying: "The office of the State Live Stock Sanitary Board is desirous of cooperating with the public in so far as men and funds will permit. We are bending every effort to cooperate with cities that are enacting dairy ordinances, realizing that it means much to the health of their inhabitants, and at the same time protecting owners of dairy herds."

Cooperation Desired.
Dr. Green announces that his time is limited in Ashland and that it is imperative that owners of dairy cows register at once in the office of the city recorder, and is desirous that all those who are supplying milk to patrons in the city, and whose cows have not certificates of inspection issued during the past year, register their names not later than Tuesday evening. If this suggestion is followed the veterinarian will be able to conduct approximately all tests Wednesday. He states, however, that in extreme cases he will be able to make a number of tests Thursday.

Three days are required in which to complete tests. In other words, no results will be obtainable until the third day.

Loss Indemnified
Dr. Green states that if the test reveals the presence of tuberculosis in any cow that the owner will be indemnified to an amount equalling from one-third to one-half the value of the animal. Where only a trace of the disease is found cows are declared fit for beef and in that event the amount received for the cow as beef is less than a third of the appraised value the balance is paid by the state and federal government. The value of condemned cows is determined by the owner and the veterinarian.

Believes Few Affected
Dr. Green is of the opinion that local dairy cows are generally free from tuberculosis, although examination will be required to determine. He says that the number of cows afflicted with the disease in California is alarming, and he relates that during the past few days that tests conducted on a herd of 22 cows on the lower Columbia river revealed 19 afflicted and they were all condemned.

AGED PIONEER RESIDENT OF BUTTE CREEK DIES HERE

Many relatives and a wide circle of friends in Ashland suffered a distinct blow yesterday morning when the death of Mrs. Andromeda Charley, 88, occurred at the home of Mrs. Mary Nixon at 307 Meade street.

Mrs. Charley was born October 24, 1836 and lived with members of a large family on Butte creek. In a family manuscript that has been a relic for over a score of years, an interesting part of her life is told. With members of her family spending long months of their time trapping, Mrs. Charley became noted for the well fitting gloves she could make out of furs.

Funeral services are to be held tomorrow afternoon at 2 o'clock from the J. Conger funeral parlor in Medford. H. C. Stock has charge of arrangements.

FIFTEEN ARE KILLED WHEN LAMP EXPLODES

CUMBERLAND, R. I., Jan. 28.—Fifteen persons met death as the result of a terrific lamp explosion which demolished a tenement house. An entire family of father, mother and 11 children were killed. The entire family of Abelard Hamel, Appaline Nancuz, boarder, and Michael Conway lost their lives.

Tomlinson, Henry Enders and Carl Loveland, the newly formed Kiwanis quartet, appeared.

Rev. S. J. Chaney, a Kiwanis, told of the purpose and meaning of Kiwanis. Speaking from a sermon wound around the motto of the organization, "We Build," he talked interestingly and forcefully. The regular monthly musical was also given at the Methodist church last evening. A well trained choir under the leadership of G. H. Yeo, whose reputation as choir leader is enviable, was assisted by an orchestra, under direction of Dr. C. F. Tilton. The musical treat was as good as anticipated and attended by an appreciative audience.

A Weed Lumber Company employee extinguished the fire with a fire extinguisher before the underground gas tank caught fire. However, the flames were going above the top of the building before the fire was finally put out.

INDIAN RALLY IS PLANNED AT ROSEBURG

ROSEBURG, Jan. 28.—An Indian rendezvous, such as was held annually years ago, will be put on by the redskins of western Oregon if plans discussed at a meeting here Saturday are adopted. It is planned to hold a three-day celebration, bringing together more than 1000 Indians and staging Indian sports, war dances, games and parades, such as featured Indian life years ago. The gathering probably will take place in Roseburg either in the late spring or early summer.

SAYS ELEPHANT KICK ANYTHING BUT A JOKE

CHICAGO, Jan. 27.—John J. Dost, 23, realizes that when an elephant kicks one it is nothing to laugh at. One of the big beasts let him have it last fall when he was working in San Antonio, Texas, for a circus in Winter quarters there. It broke his knee cap. He started back to Chicago. More than a month later he collapsed on a Chicago street as a result, according to doctors, of the elephant's kick.

THEATRES OF THREE CITIES ARE MERGED

Vining Enters Chain With Medford and Grants Pass Houses.

MANAGEMENT RETAINED

Combination Will Effect Increased Buying Power and Improved Pictures.

A transaction has been completed whereby the Rivola, Rialto and Vining theatres of Grants Pass, Medford and Ashland are merged into joint ownership and will be operated as a chain as soon as all details can be worked out. Heretofore the Rivola at Grants Pass and the Rialto at Medford have been owned and operated under the management of the George A. Hunt Co., of Medford, which company also conducted the Paige prior to its destruction by fire.

According to H. B. Hurst, of the Vining, the movement has been under discussion for some time, and according to the terms of the transaction the George A. Hunt Co. becomes part owner of the Vining of Ashland, and Hurst acquires an interest in the Rivola and Rialto of Grants Pass and Medford. Commenting on the deal, Mr. Hurst says:

"The merging of three theatres will afford us increased buying power, making one of the strongest combinations on the coast. It will not only permit us to secure a greatly improved class of productions, but will permit us to dictate the price of admission. Under the former arrangement we were compelled to contract for a large number of common-place films in order to secure a limited number of first class productions, and at the same time the distributors were able to dictate the price of admission, especially with respect to the better productions. The change effected will place us in position to dictate prices for high class pictures. It will mean that pictures for which an admission of 50 cents was dictated by the distributors will be exhibited for 35 cents. Hence it will be seen that the change will not only result beneficially to the owners of the chain, but will effect a saving to the picture-going public."

"I consider that the greatest advantage that will accrue to the merger will be improved productions. Management Unchanged
The merging of the three theatres will result in no change in the management. The George Hunt Co. will manage the Rivola and Rialto and Mr. Hurst will continue as manager of the Vining.

AUTOMOBILE CLUB ISSUES NEW BOOKLET

Camp Grounds of California and Entire Pacific Highway Are Listed.

When the call of the open road sounds from the north in the spring Southern California motorists and visiting tourists will find that their desires have been anticipated by the Automobile Club of Southern California. Just from the press is a new booklet of nearly 100 pages entitled "Camp Grounds of California and along the Pacific Highway from San Diego to Vancouver, B. C."

The new compendium of useful information to motorists was compiled by the outing bureau of the auto club, which has to do with camping, fishing, hunting, swimming, yachting and golfing information. The booklet is pocket size, contains an index and maps of the entire Pacific coast, distances to different points, and a list of camp grounds in each city along the route touched in addition to equipment of camp grounds listed and prices noted.

COMMUTATION EXTENDED TO ONE OF CHINESE

RENO, Nev., Jan. 28.—The sentence of Hughie Sing, tong war slayer who was condemned to die by lethal gas February 8, was commuted to life imprisonment this afternoon by the state board of pardons at Carson City.

Gee Jong, Sing's companion in the slaying of an old Chinese laundryman at Mina in 1921, was refused commutation by the pardon board.

UP-TO-THE-MINUTE BULLETINS

TWO TRUCKLOADS WHISKEY STOLEN

HAMMOND, Ind., Jan. 28.—A gang of between 20 and 30 bandits loaded two trucks with whiskey from the warehouse of the Hammond Distilling company and fled. Police of Illinois and Indiana, and prohibition enforcement agents, are pursuing the robbers.

In their haste to get away, the bandits left one empty truck. Three United States government agents who are supposed to guard the warehouse were drunk, according to officers. The liquor secured by the bandits is valued at \$100,000.

34 BODIES RECOVERED FROM MINE WRECK

CRESSON, Pa., Jan. 28.—Nine men remain unaccounted for in the explosion that wrecked the Lancashire Mine No. 8, of the Barnes-Tucker Coal Company at Shankstown. Rescuers were compelled to seek safety when a rising tide of ground water threatened to stop all further work.

The latest official figures show that six miners escaped alive and that the bodies of 35 have been recovered. It is reported that 49 men were working in the mine at the time of the explosion.

PRESENT RESOLUTION CANCELLING OIL LEASES

WASHINGTON, Jan. 28.—The senate plunged into tumultuous consideration of the Teapot Dome mess when Senator Walsh, democrat, of Montana, laid a resolution before the senate providing for the cancellation of the leases, and directing the President to inaugurate, independently of Attorney General Daugherty, court action to protect the government's right. Simultaneously, Senator Leavort laid before the senate Dohney's offer to turn back to the government his lease on the Elk Hills reserve which he obtained, according to his own testimony, a few months after he had loaned Ex-Secretary Fall \$100,000. The House naval affairs committee called off the investigation of leasing of Naval reserve lands by Dohney and Sinclair pending completion of a similar inquiry by the senate.

ORDER ISSUED FOR PAVING RUCH ROAD

Work to Be Under Way at an Early Date; Cost Will Total \$156,000.

Although a decision was not expected for several days, the County Court has ordered the paving of the Medford-Ruch road and plan to begin activities as soon as details can be completed and material and equipment assembled.

At the meeting held last Wednesday in Jacksonville, at which time petitions bearing the names of between 1500 and 2000 citizens of the county were presented, and arguments made pro and con by various speakers, the court announced that the matter would be taken under advisement and a decision announced at a later date.

The road to be paved is 12 miles long, extending from Medford to Ruch by the way of Jacksonville, and it is said by those who have been working to secure the improvement that it will not only afford a quick means of visiting the county seat, but will afford the people of Ruch and the Applegate district easy access to the other towns and districts of Jackson county. It is also said that the new road will be the means of placing the Oregon Caves several miles closer to Jackson county and those going to the caves via Ashland and Medford.

The cost of paving is estimated at 13,000 per mile, making a total of \$156,000. It is said that \$80,000 is available for a bond issue of 1920, together with market road funds of \$43,000, making the total amount available \$123,000.

STATE INCOME TAX BLANKS ARRIVING

Woes of the citizens of Ashland and other districts of Oregon are increasing with the arrivals of state income tax blanks from the office at Salem. A report from Salem says:

One hundred and fifty sacks containing 90,000 letters addressed to as many potential contributors to Oregon's exchequer through the medium of the recently enacted income tax, were dumped into the mails last night. The total weight of the 150 sacks of mail is estimated at approximately six tons. In each of the 90,000 envelopes is a state income tax blank, a copy of the federal blank, a sheet of instructions and an envelope for the mailing of the return.

DYNAMITE USED AS MEANS OF SUICIDE

GRANTS PASS, Jan. 27.—George Kenyon, 32, committed suicide here yesterday by placing his head on a stick of dynamite, which he exploded. The young man purchased one stick of the explosive, went under the north approach of the Sixth street bridge, where Dr. S. Loughridge met his fatal accident Monday, and killed himself. He used only half the stick, placing it under the back part of his head. An 18-inch fuse was then lighted, and he waited for the explosion. His body was thrown 15 feet, the back of his head being blown off. His clothing was torn to shreds.

His health was given as the reason for the act. He was the son of Bert Kenyon of this city and was unmarried.

HELD FOR THEFT OF SUIT OF CLOTHING

Two Young Men Arrested While Trying to Dispose of Stolen Articles.

Slick haired youths giving the names of Albert Dempster and Alfred M. Palmer were arrested Saturday afternoon by Chief McNabb after they had visited several different business houses and auto tire shops trying to get rid of a suit of clothes and an inebriate.

According to the story told authorities by the young men, who claimed to be bakers and had worked in New York, they bought the suit of clothes in the depot in Medford Friday evening as they were waiting for a south bound train. Failing to take the train for the south they came to Ashland Saturday where they were able to get rid of their purloined goods and secure enough money to buy a ticket to Dunsmuir on the stage.

In the meantime, Friday evening L. J. Orres visited Medford and left his machine parked with no fear that a suit of clothes, suit case, and sample case would be taken. When he returned to his machine, he found the clothes had been taken and notified Medford and Ashland police before coming to his home here.

Mr. Orres identified the suit of clothes sold by the youths, as being the suit that was taken from his machine.

Sometime Saturday an owner of a rooming house in Medford informed the police that a suitcase and clothes had been left in a room in her hostelry. The young men were identified by the land lady this morning and were to appear before Judge Gowdy's court this afternoon for a preliminary hearing.

FINE PELICAN BAY GAME LAW VIOLATORS

KLAMATH FALLS, Jan. 28.—Fines of \$125 each were levied from Julius Hokhold, E. E. Bollman, W. Dudley, Bill Johnson, and V. Hargrove, this afternoon at 2 o'clock following their plea this morning of guilty to the charge of possession of deer meat. Johnson, Dudley, Hokhold and Hargrove all paid their fines, while Bowman was given until tomorrow morning to raise the money.

The five men were arrested Friday afternoon about 3 o'clock in the cabin known as Clover Creek ranger's cabin, on the Buck Lake road, by Game Warden Marlon Barnes and an assistant.

EGYPTIAN BECOMES APPRENTICE ON S. P.

The East has come to the West to study industrial progress. At least, Hassan Mohammed El Kabannia of Cairo, Egypt, arrived in San Francisco early this week and began serving an apprenticeship in the motive power department of the Southern Pacific Company. Later he is to do overalls and work in the railroad's shops at Sacramento and Los Angeles.

HINTS THAT U. S. MAY BAR ALL JAPANESE

In Event Japs Are Not Excluded Will Limit Number of Immigrants.

MAY BECOME ISSUE

Movement May Impair Results of Washington Conference and Earthquake Aid of U. S.

TOKIO, Jan. 28.—"It is a matter of saving our face if you are to call it that, but deeper, as it is a matter of national pride," a source close to the local foreign office declared in discussing proposed legislation at Washington which may exclude all Japanese or reduce to a few the number entering the United States as immigrants.

Baron Matsui declined to discuss the matter stating that it was being handled diplomatically, and it is admittedly serious.

A source close to the cabinet claims that feeling is not high relative to this issue as the Japanese are thought centering on domestic issues, but it is the easiest source from which politicians can make a political football issue, arousing their constituents against an imaginary sinister motive of America, and thus gain favor at the serious cost of impairing the recent Washington conference and the earthquake aid of the United States, which united in producing the best feeling that has existed towards America for many years.

MEDFORD, Jan. 28.—Arrangements have been practically completed for the annual gathering of the republicans of Jackson county at the Lincoln day banquet at Hotel Medford here on the night of February 12. B. F. Mulkey of Portland, former Medford man and former district attorney of Jackson county, will deliver the address.

RANCHERS' TRIAL SET FOR AIDING BANDITS

PROSECUTORS DEFY POWER OF GOVERNOR

Will Make Test Case of Law Authorizing Special Prosecutors.

TALK IS RESENTED

Supreme Court Justice McCourt Declares Sanctity of Home Above Dry Statute.

PORTLAND, Jan. 27.—Governor Pierce's address before the annual banquet of the District Attorneys' association of Oregon at the Benson hotel Friday night was held a direct attack upon the integrity of the attorneys and an emphatic inference that incompetency was rampant among those prosecuting officers, by the attorneys who met yesterday at the court-house. Further, it was brought out that the governor, after steadfastly refusing to appear before the open meeting of the attorneys, had violated every statement made by his special representative to the officers of the attorneys' association previous to the business meetings Friday.

Attorneys Resent Words
Indignation at the veiled charges of the governor as made in his address ran high in the meeting yesterday.

That in substance he had violated a promise, but one which of course was not binding since it was made through an agent confidentially to President Johnston, Secretary Fisher and Stanley Myers, was another charge which dropped like a bombshell into the midst of the session of the attorneys yesterday and was the incentive for a storm of protest.

Question Is Discussed

The revealing of this affair came at the start of the session yesterday morning, when it was declared by President Johnston that a confidential matter concerning a communication with the governor was to be discussed. It was suggested and a motion made that the attorneys go into executive session, but this was defeated by a vote of 12 to 9, following a lengthy argument over the point. Stanley Myers, district attorney of Multnomah county, then outlined the method employed by the governor in the approaching the attorneys before the state sessions opened here Friday. He declared that Ward Irvine, private secretary to the governor, had called him Thursday on the telephone from Salem, requesting a conference. This had been granted, according to Myers, and when Mr. Irvine appeared he was met by Mr. Myers, Ben Fisher, secretary of the attorneys' organization, and Clyde N. Johnston, its president.

According to Mr. Myers, the special envoy, Mr. Irvine, apparently in good faith, continued to assure the attorneys present that the governor had given him full right to speak for him and to "write the ticket." With this he went ahead and explained the attitude of the governor as being desirous of completely co-operating with the district attorneys in any future prohibition cases.

Co-operation Is Promised
He would agree, according to Irvine, to lay the entire cases which called for special prosecutors before the respective district attorneys and seek co-operation, and, if special prosecutors were sent, to give the district attorneys complete hearings as to why such a step had been taken.

Mr. Irvine then assured the attorneys, according to Myers' statement, that the governor would be down in the afternoon Friday to make an address before the meeting and he would meet the officers of the association at the Portland hotel at 5 o'clock to confer with them on an address he was to make before the annual banquet. Neither of these appointments was kept by the governor.

Speech Declared Turnback

"It was a surprise to me that the governor was afraid to come before the attorneys in open meeting," said Myers in closing his explanation of what had happened. "His speech at the banquet was a direct turnback on the course that had been outlined by his personal representative, and I, for one, feel that there was apparently a lack of liaison between the governor and his envoy."

Mr. Myers attacked the address made by the governor before the banquet as an unjust reflection on the district attorneys of the state.
