One part of the second story of the building is a lodging house. One theory is that the Mexican was on his way up stairs to get lodgings when a stroke of apoplexy caused him to fall. He was aged about 45 years.

peace-desiring people. We fight if we have to, but not because we want to. We are not a fighting people—when let alone.

We want to see war outlawed. We fought a bit harder and with more zeal and aggression in the last war because we thought—many of us—that it was going to end war. I do not believe we will ever become a war-loving nation.

No Benefit

Just what will we get out of it—this Defense Day observance? We have been posing before the world as a peace-loving nation, and we are. We have been leaders in the great peace movements of the world. The majority of us would like to see a workable league of nations. The world is looking to us as its hope of peace.

Just how is this National Defense Day fireworks of ours going to appeal to other peoples? Are we not adding more coals to the fire instead of pouring on water? It may not make us more militaristic—most of us will take it for another Fourth of July and let it go at that; but what about the man across the waters? After all in the final analysis of this war business we have learned that he is the man we have to reckon with. What influence will it have on him? Let us not pour oil on the troubled waters with one hand and set fire to it (the oil, not the water) with the other.

Approves View
Mr. Hughes is right: there is no need to demonstrate our ability to take care of ourselves. There is no occasion to manifest our willingness to do so, to warn other countries against acts of aggression. They know we are neither too proud nor too scared to fight. We do not have to demonstrate our strength. Our hair is not shorn or is it likely to be. We have not fallen a victim to the lure of Deiliah yet or are we likely to do so soon. How is our National Defense Day to take its place beside our world's peace programme and Disarmament Conference as other nations see us? How will our Defense day measure up beside our propaganda for peace?

Then just what are we to get out of it? A holiday; an opportunity for a lot of patriotic speeches from the men who "didn't get across" and some fireworks; a chance to stop and pat ourselves on the back and tell us just what we think of us—just what a lot of fighting wildcats we are; but what about the day after? Will we accomplish anything of value? Demonstrate any new proves? Reveal any hidden strength? Facts known: can we fight? We can. Will we fight? We will. Can we take care of ourselves. Ask John Bull and the Kaiser. Are we ready to fight? Just as much on the day before as the day after. Will we learn anything new about ourselves? Not a thing, except what the orators tell us. THEN WHY?

And there is yet another side to this National Defense Day for some of us—The Lord's side. I am not of those who believe the teachings of the Master would forbid His disciples fighting for their country, his home or his altar; but I do believe the church which represents Him before the world is not warranted in assuming any part in any militaristic demonstration in times of peace. The church stands for peace, not war, only when war becomes a gem necessarily. And her wars must be wars for peace.

It has chosen a Master whose gospel is preeminently a gospel of peace. If we preach it we must live it and only under the lash of dire necessity should she become a party to war or demonstrations of war.

Questionable Experiment

It is a questionable experiment which the gods of war have imposed upon us this National Defense Day. However, I have no quarrel with the secular world when it chooses to measure its strength or weigh its resources. In such demonstration as this requires of us. It is more or less harmless, I think so far as we are personally concerned. But I am strongly persuaded that the church as an ambassador of the Christ of Peace should refrain from participation in any demonstration that would even seem to place it in antagonism to the unmistakable teachings of its Lord.

We must practice what we preach if we are to persuade other men to practice it, or even believe our teachings, or His. Surely the ambassador of the Prince of Peace is not about his Master's business when he is found in the procession of those who are giving exercise to the dogs of war.

Let us render unto Caesar the things that are Caesar's, but to God the things that are God's.
