German Peace Award Winners Are Announced; First to Two Plans

BOSTON, Mass., Oct. 6.—How can peace and prosperity be restored in Germany and in Europe through international co-operation was the theme of the plans submitted in the contest conducted by Edward A. Filene of Boston in Great Britain, Germany, France and Italy. Awards of \$10,000 were made in each country. The plans submitted from France and Great Britain were announced in September.

More than 15,000 plans were submitted from the various countries. The award on the German contributions were announced today, with the first prize of \$5,000 being divided between two plans.

DEMOCRATIC CAMPAIGN IS NOW WORKING ON "HIGH"
NEW YORK, Oct. 6. — The Democratic presidential drive went into high speed in the east when John W. Davis, the presidential candidate, left for a whirlwind tour into New York state. ROCHESTER, N. Y. Oct. 6.— Senator Robert La Follette, the Independent presidential candidate, opened his transcontinental speaking tour here with a flat prediction that he would be elected to the White House.

He hailed as "utterly ridiculous" the statement of the Republicans and Democrats that his purpose in entering the presidential race was to throw the election into congress.

NEW PARCEL POST SERVICE

The Ashland postoffice has received official notice of the establishment of insured parcel post service between the United States and Great Britain and Northern Ireland. Packages must not exceed 11 pounds in weight or six feet in weight and girth combined. The regulations issued for this new service provide for indemnity up to \$100, minimum insurance fee 15c, and maximum 50 cents. The new service is now effective.
