and after the writer had made a personal inspection of the land, that The Tidings declared in favor of the purchase. Those who are responsible for the attack upon this plan have probably let their minds, distorted by personal prejudices, sway their better judgment in the matter.

One of the arguments advanced by the opponents is that the land could have been purchased some time ago at a lower price than the one now asked for it. In using this argument they are

boosting for the bond issue, for one of the facts which made the Park Commissioners favor the purchase of the McCormick tract at this time was that other land, available for park use, had risen in value after the city had refused to purchase it. Later, when the city was forced to make the purchase, it was discovered that the land had risen greatly in value and the city was forced to pay for the rise. The same thing is happening in the McCormick tract case, and unless the city obtains it at the present time, it is liable to fall into the hands of private speculators who will force the city to pay them a handsome profit when they are ready to sell.
