NEW YORK, Jan. 20.—(U.P.)—The sporting outfits worn at St. Moritz are no more elaborate than those worn in the popular American resort, Lake Placid. Here girls from every part of the country spend a portion of the winter skiing and skating in costumes that might do well in a Sheffield chorus.

Colors rage rampant. This season colorful leather wind-breakers worn with either short skirts or knickerbockers of contrasting shade are popular. The jacket may be the conventional one with high neck and sleeves finished in knitted bands or it may be made lapels and worn with a turtle necked sweater.

Green and brown leather jackets lined in lighter red, worn with flannel skirts, matching the jackets, are also noted. Knickerbockers are more numerous than skirts, although the chromer skirt, which extends far below the knee is far more graceful than knickerbockers.

Facial suede jackets worn with contrasting colored skirts are very becoming. One young Miss of Lake Placid follows this mode with a coat of pastel blue suede worn with a short, yellow flannel skirt. Her plain sporty accessories—blue and yellow shades, cap and woolen stockings are pastel blue.

Very short fur coats of leopard, racoon or caracal are warmer, though not so colorful as the true leather jacket. A great many young girls are wearing them. Caps, mittens and socks are now being made of wool and are quite the popular thing this year. There's a fashion for wearing two pairs of stockings, the top pair being short colorful affairs to harmonize with one's ensemble. Caps are knitted, head-fitting shapes or sueder trimmed in fur.

AMUNDSEN TO PUT NORWEGIAN FLAG AT POLE

ROME, Jan. 20.—(U.P.)—Roald Amundsen will not attempt a landing at the North Pole if he succeeds in flying a dirigible there next summer, but will hover over it and drop a pointed steel pole, so balanced that the Norwegian flag it carries will fly at the top.

This, according to Colonel Noble, contractor of the Amundsen dirigible, will avoid the difficulty of anchoring on an icy surface. "Although feasible, anchoring would be wholly useless," Colonel Noble told the United Press in an exclusive interview. "It would give us no scientific advantage. I think the dirigible will be perfectly capable of remaining still for hours very close to the ground, which would make observations for locating the precise Pole comparatively easy."

Surroundings to determine the depth of the sea, according to Noble, will be effected by dropping depth charges from the strait, and recording the time between the explosion and the echo from the ocean bed. He also explained that a new heating system will be employed, taking advantage of heat chemically produced by the exposure of certain metals to humidity.

The crew of the reconstructed dirigible starts training in actual airmanship next week. Most of the personnel, chosen with great care and after strenuous physical examination, were with Amundsen on the polar vessel "Maud" when he previously attempted to reach the Pole. The "Maud" was recently sojourned in Seattle for debt.

RUMORED NEW WOOD YARD TO START HERE
