HELPING THE POULTRYMEN

Josephine county poultry raisers are having considerable trouble with both coyotes and hawks, according to the Grants Pass Courier, and coyote extermination is now under way in that section by government hunters and trappers.

In outlying sections of Jackson county, poultry raisers have reported heavy losses from these two sources and are hopeful that some similar action might be taken here. Says the Courier:

"Coyote extermination is occupying the attention of government hunters in Josephine county at the present time and poultrymen in outlying districts will be saved large sums because of the elimination of the prowler. There is another danger to the poultrymen, however, and this is from the hawks which seem to be increasing as rapidly as the coyotes are diminishing. One woman near this city had a flock of 140 small chicks. Within a few days, ravages of the hawks had reduced this to 40. Other poultry owners are making the same complaint. Some action will be necessary some day to decrease the danger from the hawks, even if it means the placing of a heavy bounty on the bird of prey."
