"STAR CHAMBER" SESSIONS

As a matter of principle The Tidings is strongly opposed to executive or "star chamber" sessions by the city council or by any other body of public officials. Such meetings breed suspicion in the minds of the public even though of importance transpires behind these closed door meetings.

The city council meeting of last Tuesday night is a case in point. The council went into executive session and barred both private citizens and newspaper representatives. So far as this newspaper was able to learn the only business transacted at this secret session was the consideration of a few bills which had been contracted on behalf of the city by a city official. Surely, the public has a right to know about these bills; why they were contracted and whether or not the council gave them approval. These are matters which effect the taxpaying public, and the public has a right to demand that all public business be transacted openly and without any suspicion of secrecy.

We are informed that the city charter prohibits the transaction of any official business by the city council unless the meeting is open to the public. HOW SHOPPERS TRAVEL

Fresh facts for determining the importance of parking space are offered by four department stores in the "loop" districts of Chicago. Checkers stationed at entrances to the stores asked shoppers the means of transportation used in getting to the stores. Of 15,229 persons questioned, 13,549 said they used public transportation systems, 964 arrived by chauffeur-driven automobiles, and 716 same in automobiles which they drove themselves. On streets near the stores 452 cars were parked.

Those facts may suggest that the availability of parking space is not decisive in determining store patronage, or they may seem positive confirmation of belief that with a motor, as with a murder, the only difficult problem is where to put the body.
