OAKDALE, Cal., Sept. 30.—(UP)—A school bus carrying 40 grammar and high school students plunged into the bed of the Stanislaus river at the Orange Blossom bridge today, killing one student and seriously injuring five others. The dead youth is Roy Merrihew, 11. The bus failed to make the upward rise to the bridge and backed over the bank into the river bed.

PARIS, Sept. 30.—Nearly 100 divorce suits brought either by war brides or by their husbands, who are members of the American Expeditionary forces, are now before French courts.

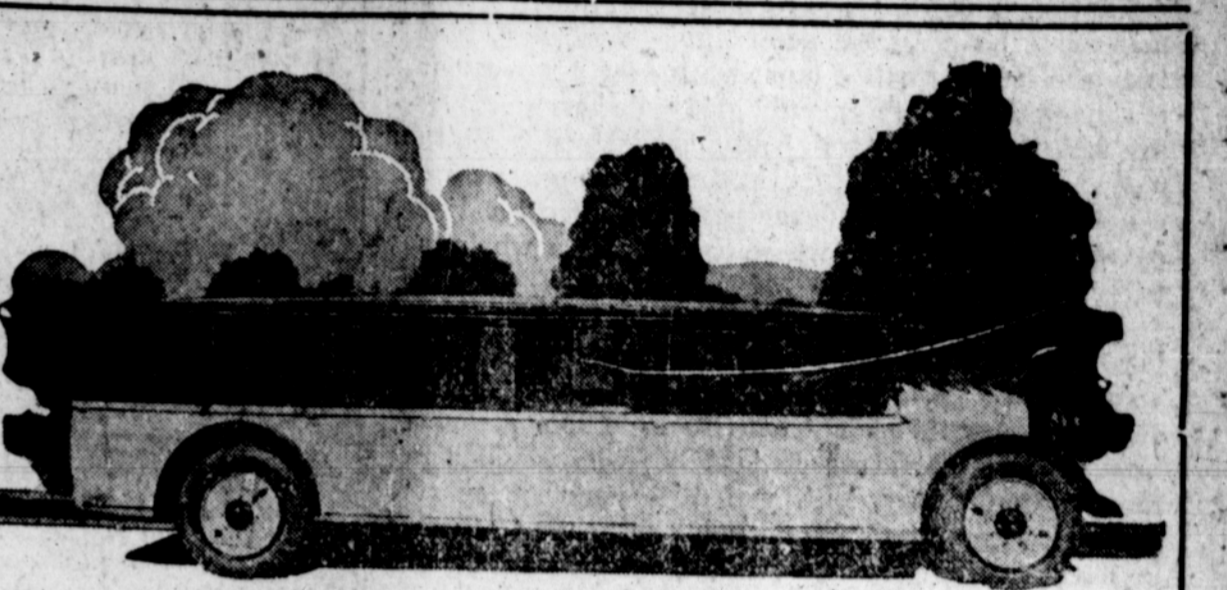
