Supreme Court Permits Him to Appeal to Highest Tribunal

SALEM, Ore., Oct. 23.—(UP) -Another lease on life was granted James Willos, condemned murderer, when Chief Justice McBride of the state supreme court Friday granted writ of error, permitting him to carry an appeal to the United States supreme. court. With Ellsworth Kelley, he was condemned to be hanged November 5th. Unless some move is made on behalf of Kelley, he will hang on the scheduled date.

The two convicts were found guilty of murdering state prison guards in the sensational prison break on August 12 of last year.


