## Condemned Radicals Lost Court Request

### BALL LEAGUE LEADERSHIP WON BY BOAS

Klamath Pelicans Bite the Dust in a Nine to Four Score in One of the Finest Baseball Games Ever Played on the Jackson Hot Springs Diamond; Davis Pitches Well.

Ashland Boas handed the Klamath Falls Pelicans a 9 to four defeat Sunday afternoon and stepped into the ranking championship position in the Southern Oregon League.

Inability of the Pelicans to find the pill as Davis hurled it over the plate was one of the reasons for the ending of the story as it was, Gillick, pitcher, for the Pelicans was taken out at the end of the fourth and replaced by Manager Saunders.

In the first inning Duke Marlow scored the first run for the Boas. Hoffard brought Marlow in home with a single. Davis struck one Pelican out and two others died on first.

Davis struck out the first Klamath player at bat, the second hit a home run and the third and fourth died trying to reach first. In this inning the Boas scored three runs. Marlow up first struck out. Hughes and Logan were walked. Hoffard struck out. Robbins then knocked a home run and brought Hughes and Logan in home. Morgan hit a single. Hanley, injured on first base and Hughes went to third for Hanley. Orr filled place left by Hughes on first.

Klamath failed to score in the next three innings. The Boas scored two runs in the fourth inning. Morgan walked. Force hit one far into the left field good for two bases. Davis hit a single. Marlow singled and brought Force and Davis in home. Hughes' flied out. Logan flied to centerfield. Hoffard flied to right field making the third out.

In the fifth inning with Gillick out of the box and replaced by Saunders, manager of Klamath team, the Boas scored but one run. Robbins, first at bat flied to left field. Morgan to center field. Orr singled. Forced singled, scoring Orr who had stolen to third. Davis flied to right field making the third out. This inning saw the score stand seven to two in favor of the local team.

Marlow, first at bat in the sixth, singled. Hughes bunted to first. Marlow went out trying to reach second. Logan bunted to first. Hoffard singled scoring.

### THREE GAMES WILL DECIDE TOURNAMENT

#### Boas and Klamath Starting Clashes Next Sunday at Fairgrounds

The Ashland Boas and the Klamath Falls Pelicans will meet next Sunday at Klamath Falls for the first of a three-game series to decide the championship in the Southern Oregon baseball league for the entire season.

The second game of the series will be played at the Jackson county fairgrounds and the third game will be played at the place which drew the largest crowd in the two opening games, according to the plans.

Besides playing for the championship, an honor which each team very much desires, the winner of the three-game series will win the jackpot which has been accumulating during the season.

Five per cent of the gate receipts of each game has been set aside for this general purse and the winner will win this fund, which is said to be close to \$500 at present.

The regular league schedule was discontinued with yesterday's games. With this abandonment of the regular schedule, the teams also agreed to drop any restrictions on players—in other words, which insures keen rivalry in the make-up of the two teams. The management of the teams have not announced any plans, but it is understood each team will go on the field with the best team it is possible to corral.

### CARAVAN WILL COME HERE ON A 6-DAY TOUR

Motor Association Plans Extensive Trip; Will Arrive Here Aug. 23; May Take Entire Trip or Only Part of the Jaunt, it is Planned.

The Oregon Motor Association, which recently initiated a personally conducted tour to Mt. Hood which was a wonderful success, according to an announcement from the association's office, will on August 29th, start on another tour that will last for six days and which will bring the members of the party to Ashland on the 23rd, as they go from Crater Lake to Oregon Caves.

A stop will be made, here, the announcement stated, as well as at various other points along the route. Overnight stops will be made at Eugene, Bend, Crater Lake, Oregon Caves and Corvallis. Persons may take the entire trip, may join the party at any point or drop out whenever they desire, it is planned. Each person is to arrange his own transportation.

Following is the itinerary as worked out by the motor association, and, as can be seen, persons who cannot go for the full time may make a two, three or four day trip by returning from any one of the overnight stops:

August 29—Leave Portland at 1 P. M. making the trip via the Pacific highway to Eugene, 123 miles. Overnight stop at Eugene.

August 31—McKenzie River highway, Metolius River resorts, Deschutes and Crooked River canyons, Bend. Approximately 175 miles. Stopping for the night at Bend.

August 22—Bend, Lava Caves, Klamath Falls and Crater Lake, 266 miles.

DEDHAM, Mass., Aug. 8.—(UP)—Hearing of the Sacco and Van Zetti motion for a new trial were being delayed in Norfolk court this afternoon by arguments which question the jurisdiction of Judge Thayer who presided at the trial. The convicted men claimed neither he nor any other superior judge had jurisdiction after the sentence of death had been imposed.

Attorney Hill of the defense opposed arguing the question of jurisdiction before Judge Thayer, but the latter decided that the argued question must be argued before him.

### CASE HELD TO GRAND JURY

#### Raleigh Hoylman Caught as He Attempted to Cash Check on Local Bank

Raleigh Hoylman, who was arrested Saturday for forgery was given a preliminary hearing in the court of Justice of the Peace, L. A. Roberts, this morning, and bound over to the grand jury on a \$500 bond.

Hoylman was apprehended when he tried to cash a check for \$61.50 on the account of Avgaris Brothers, owners of a lumber mill, at the First National Bank.

He had already cashed a check at the East Side Meat Market for \$34.61. Late Saturday evening he confessed that he had a 150 cashed a worthless check on the Ashland Iron Works for \$32.

The young man was unable to furnish bail and was taken into custody by the county sheriff and placed in the county jail.

Under the provisions of a new law, Hoylman can waive the grand jury hearing and plead before a circuit judge. He told the court this morning that he would try to do this.

Hoylman was recently released on \$500 bond in Josephine county on a similar charge.

## GOVERNOR NOT TO DO ANYTHING ON PRAYER FOR FURTHER DELAYS

Numerous Demonstrations by Sympathizers of Sacco and Van Zetti Staged; Strike Called; Washington Publishing House Dynamited; Will Take Famous Case to Federal Court and Then to U. S. Supreme Court if Justice Will Grant Attorney's Request.

BOSTON, Mass., Aug. 8.—(UP)—Governor Fuller today indicated he would not act on petitions asking further reprieves for the anarchists. Unless a reprieve should be granted, the men will be electrocuted early Thursday.

BOSTON, Mass., Aug. 8.—(UP)—Attorneys for Sacco and Van Zetti were today denied writs of habeas corpus by Justice George Anderson, member of the Massachusetts supreme court, thus ending the first legal battle to prevent the execution of the two radicals.

Arthur D. Hill, chief defense counsel, plans to go before the federal courts with a request that they intervene and then to either one of two justices of the U. S. supreme court who are vacationing in this state. They would be asked for a writ of certiorari, which would bring the noted case into the supreme court at Washington.

Neither prisoner took any food Sunday, it being the 22nd day of Sacco's hunger strike. Van Zetti has now joined him again in refusing food and both insist to their counsel that they will not eat again until they are granted a new trial.

PHILADELPHIA, Pa., Aug. 8.—(UP)—Three were arrested and charged with inciting a riot and distributing literature of an inflammatory nature calling a strike as a protest against the Sacco-Van Zetti execution.

SAN FRANCISCO, Calif., Aug. 8.—(UP)—Autos were today prohibited from that part of the streets which are adjacent to the federal building and the mint.

WANSELBURG, Colo., Aug. 8.—(UP)—667 out of a normal force of 1153 men were working in Southern Colorado coal fields today. The others are striking as a Sacco-Van Zetti protest.

### SISTER FINDS FAKED BOMB

#### Infernal Machine at Angelus Temple Found Filled With Glycerine

LOS ANGELES, Aug. 8.—(UP)—Sister May Brown heard Sister Aimee Semple McPherson extol the benefits of the Four Square Gospel Sunday and then walked out of Angelus Temple to find a most terrifying infernal machine supposedly designed to wreck that million dollar institution.

The bomb, consisting of a clock, a small black box and a bottle of alleged nitro-glycerine, was denounced as an obvious fake by Angelus Temple workers and by Mrs. McPherson.

Mrs. McPherson pointed out that Angelus Temple had no enemy who would go so far as to attempt to blow it up and then it was found that the mysterious explosive was glycerine instead of nitro-glycerine.

### BOSTON, Aug. 8.—(UP)—"Sacco and Van Zetti shall not die!"

The shout, echoing through the old Boston Common, Sunday, expressed the determination of 10,000 Sacco Van Zetti sympathizers, to save the doomed men from the electric chair.

Mounted police broke up one meeting and dispersed the crowd when the permit for the meeting was rescinded by the police superintendent.

Another meeting was held nearby under another permit issued in the name of the workers' party of America.

Although several arrests were made when members of the crowd resisted police efforts to break up the meeting, there was no violence.

A police riot squad of more than 400 men was mobilized to keep the peace in the face of inflammatory oratory which was poured out by the soap-box speakers.

### General Wood To Be Buried With Full Military Honors On Tuesday

BOSTON, Aug. 8.—(UP)—Major General Wood will be buried in Arlington National Cemetery Tuesday morning with full military honors.

There his body will rest not far from the White House he so nearly occupied, among the graves of the Rough Riders he commanded with Theodore Roosevelt. Neglect of a growth in his head while carrying on his last duties as Governor-General of the Philippines, caused his death.

Major Burton Read, personal aid to the General, made the funeral announcement. He said

### Three Suggested To Coolidge For Post As General Of Philippines

RAPID CITY, Aug. 8.—(UP)—Three names are being prominently mentioned for appointment to the Governor-Generalship of the Philippines, the post let vacant by the death of Major-General Leonard Wood. They are:

Henry L. Stinson, New York, who conducted for Mr. Coolidge personally the peace negotiations in Nicaragua, and who has been highly regarded by the president for his successful job.

Carmi Thompson, Ohio, who made a personal investigation of the Philippine situation for the president and whose report has

been submitted to congress by Mr. Coolidge with a recommendation for action.

Former Senator Rice W. Means, republican, Colorado, now head of the Spanish-American War Veterans, who is somewhat of the Wood type and highly regarded by Mr. Coolidge.

Names of others mentioned, include Frank V. Hodges, treasurer of the republican National committee; former Senator Lenroot, republican, Wis., and former Senator Wadsworth, (R., N. Y.). Possibilities of their selection, however, is regarded as unlikely.
