

HUNDREDS TO PAY TRIBUTE TO RADICALS

"Only Two of Us Will Die" Was Placard Woman Attempted to Place on Caskeys as She Passed Thru Small Room—Thousands See Bodies.

NICE, France, Aug. 27.—UP—Eight persons were injured, some seriously, when a bomb was thrown late last night into a public ballroom at Jean Les Pins, which is frequented by American tourists. The ballroom is that of Brancaccio Neptune. It is unknown if Americans were among those injured. Because Americans form a considerable patronage of the ballroom it is believed the bomb may have been hurled by Sacco-Vanzetti sympathizers.

BOSTON, Aug. 27.—(UP)—In a heavily guarded north end undertaking establishment, the bodies of Nicola Sacco and Bartolomeo Vanzetti were viewed by thousands Friday and today.

Sympathizers passed the flower bedecked biers in an endless stream. Each was permitted only a second's glance, for outside the street was packed with men, women and children, awaiting their turn.

Only one bit of excitement marked the activities. This was when Miss Mary Donovan of the defense committee struggled with police who attempted to wrest from her several placards.

The incident resulted in the arrest of Miss Donovan, who will appear in court today on a charge of "obstructing the free passage of foot traffic."

The placards which Miss Donovan had intended to set up near the caskeys, bore quotations from the farewell letter of the executed anarchists. One inscription read:

"Only two of us will die. Our ideal, you our comrades, will live by millions; we have won, we are not vanquished."

After more than 6,000 had viewed the bodies Friday, the doors of the undertaking establishment were closed. More than 10,000 were expected to view the bodies today.

Sunday public services will be held.

COMPROMISE OFFERED BY CALIFORNIA

Water Difference in Seven-State Conference Near Adjustment

DENVER, Colo., Aug. 27.—(UP)—Willingness of California to compromise with Arizona in their differences over water from the Colorado river was indicated late Friday at the seven-state river conference.

Governor Young of California announced his state had submitted a counter proposal which differed very little from the plan of settlement recommended by governors of the upper basin states.

The California proposal has been turned over to the Arizona delegation for consideration.

DARROW TAKES ANOTHER CASE

Famous Criminal Lawyer Will Defend Indiana Klan Leader

MICHIGAN CITY, Ind., Aug. 27.—(UP)—Clarence Darrow, Chicago criminal lawyer, has been retained as chief counsel for D. C. Stephenson, once dragon of the Indiana klan, Attorney Robert H. Moore of this city announced.

Stephenson will attempt to obtain his release from prison on the ground of conspiracy between state officials and high klan officers to obtain his conviction for the alleged murder of an Indianapolis girl.

Darrow will carry Stephenson's case to the United States supreme court if necessary, Moore said.

MEMORIAL TO HONOR YOUNG AIR VICTIMS

Poses Explore Hawaiian Wilderness and Naval Vessels Search Ocean—Flowers Will Be Scattered on Pacific as Tribute to Daring Fliers.

WASHINGTON, Aug. 27.—UP—The last detachment of naval vessels searching for the missing Hawaiian race planes, "Miss Doran," "Golden Eagle," and "Dallas Spirit" will leave Honolulu for San Diego Tuesday, R. H. Jackson, commander of the battle fleet informed the navy department today.

SAN FRANCISCO, Aug. 27.—(UP)—More than a score of naval vessels today are continuing the search of the sea for the missing Dole race planes; poses are exploring Hawaiian wildernesses, tracing rumors of flares and motor roars—and last evening, a tentative plan for a memorial service for the seven missing fliers was started.

This plan, originated by Walter W. Cribbins, local business man contemplates holding the service about 700 miles out at sea—approximately the place Edwin was last heard from—on September 16, or a month after the take-off in the Dole race, which the planes "Miss Doran" and "Golden Eagle" never finished.

Word of the plan has been sent to the relatives of Miss Mildred Doran, John Aggy Pedlar and Lieutenant Vilas K. Knope of the "Miss Doran," Jack Frost and Gordon Scott of the "Golden Eagle" and Captain Bill Erwin and Al Elchwald, his navigator, whose "Dallas Spirit" was lost a week ago tonight, a few hours after it hopped off for Honolulu. Flowers will be cast on the water for 100 miles or more as a tribute to the lost fliers, following the memorial services, to be held while liner Maui is halted about 700 miles out in the Great Circle steamship course.

Much Civic Development Made in Ashland During J. H. Fuller Regime

"For Ashland I see nothing but a bright future and I see no reason why our town should not grow and prosper," said John H. Fuller, retiring head of the Chamber of Commerce.

During the eight years Mr. Fuller has been secretary of the Ashland Chamber of Commerce, many worthwhile projects have been sponsored by the organization, to a successful issue. Outstanding among the achievements of the Chamber in the last eight years, was the bringing to a realization the establishment of the Southern Oregon Normal school—a dream Mr. Fuller cherished—a start toward making Ashland the educational center of southern Oregon—a project which it required years of tactful and diplomatic interest to make a reality.

For three years previous to his election to the position as secretary of the Chamber of Commerce, Mr. Fuller interested himself in the Ashland Chautauque, each year bringing faculty members from O. A. C. and the University of Oregon to this city in an effort to interest those

institutions in a summer normal school here. Later this dream was realized when the Chamber of Commerce and the Monmouth Normal school financed the first six-weeks summer Normal school which later became the Ashland Southern Oregon Normal school—which has a scholastic standing and enrollment which insures its high rating among the educational institutions of the state. Mr. Fuller serves as a member of the Board of Regents of State Normal Institutions and his interest in the Normal school is in no way decreased by his resignation from active service as head of the civic organization. Organization of the Lithians, booster and social organization of the Chamber of Commerce, was another enterprise which Mr. Fuller was instrumental in starting and giving his unqualified support.

COMMISSION ORDERS NEW RATES MADE

Preferential and Prejudicial Rates Found Effective on Road From Portland to Spokane—Maximum Rates Are Listed by Commission.

WASHINGTON, Aug. 27.—(UP)—The Interstate Commerce Commission today disapproved rates on sugar in carloads from Portland to Spokane and from Portland, Seattle, San Francisco, Tacoma and Crockett, California, to Missoula, Montana. Rates were prejudicial to Missoula, they ruled, and preferential to Spokane. It was also found the carload rate on canned goods was prejudicial to Missoula.

It was ordered that the rate from Portland to Spokane should not exceed 55 cents per hundred pounds and from San Francisco to Missoula not to exceed 95 cents per 100 pounds.

RUM-RUNNER CREW FACES INDICTMENT

British Columbia Men Were Operating Boat With Big Cargo

SEATTLE, Aug. 27.—Six British Columbia men, five of them officers of the Joseph Kennedy importing company of New Westminster, were indicted in the Motorboat Zev conspiracy case three months ago. It developed when the secret indictment was released in federal court.

The men are O. D. Lampman, managing director; Harry Reifel, secretary; George Reifel, L. N. Miles, George Massie and Charles Wallace.

The case developed after Alfred Hubbard, Seattle dry agent, captured the Zev singlehanded with 200 cases of liquor. Hubbard said he persuaded Chris Skrondal and Laurence Verecken, crew of the boat, that he would aid them to run the cargo to the United States and then took them in custody after the liquor was safe aboard.

CONFISCATE DRUG CARGO

Reckless Auto Driver Had Drugs Valued at \$20,000 in Auto

OLYMPIA, Wash., Aug. 27.—(UP)—The arrest of a reckless automobile driver led to the discovery of drugs with an estimated retail value of \$20,000 and the apprehension of a drug ring suspect here this afternoon.

Deputy Sheriffs located O. F. Holmes, 30, near here shortly after a complaint had been phoned in that he was driving in a dangerous manner. The drugs, cocaine and morphine, were carried in a suitcase in the rear compartment of the car.

The machine bore a California license. Holmes is a drug addict himself, according to police, and is suspected of being affiliated with a dope ring operating between Mexico, Oregon, Washington and California.

OCEAN LINERS GO THROUGH BAD STORMS

Mountainous Seas Frighten Hundreds of Passengers as Tropical Hurricanes Beat Against Great Ocean Vessels—All Reach Harbor.

NEW YORK, Aug. 27.—(UP)—Five battered ocean liners arrived here late Friday to disgorge hundreds of bruised and still frightened passengers after passing through a tropical hurricane that howled at a peak of intensity of 100 miles an hour.

Mountainous seas appearing without warning when the stricken, tilted the Martha Washington 43 degrees, two degrees from capsizing. The liner, with her powerful engines and palatial fittings, was tossed like a canoe in the churning wake of a tremendous sea.

The terror of helplessness reigned for hours among the Martha Washington's 617 passengers, including many babies.

At other points in the hurricane's broad path, the four other vessels were also fighting to keep afloat.

A sixth liner, the Vanderell, outward-bound, had her bridge and lifeboats torn away and was forced to turn back to Halifax when the storm abated.

WELL-KNOWN WOMAN DIES

REDFERN NOT HEARD FROM; MAY BE LOST

Young Aviator Should Reach Rio De Janeiro Early This Evening—Round the World Fliers Leave Newfoundland Early Today With Next Stop in London.

Two new attempts at long distance aviation records are underway today but definite advice as to their progress is lacking.

At 8:45 eastern time, Paul Redfern had been gone 54 hours on his flight from Brunswick to Rio De Janeiro as his destination. At the same hour Brock and Schlee, who took off from Harbor Grace, Newfoundland in the "Pride of Detroit" this morning had been gone 10 hours on their way to Croydon, England.

BRUNSWICK, Ga., Aug. 27.—UP—No word has been received from Paul Redfern, young aviator who left Thursday in an attempted 4,600 mile non-stop flight to Rio De Janeiro. If every detail of the schedule were airtight he should reach his destination at 6 o'clock tonight.

HARBER GRACE, N. F., Aug. 27.—(UP)—The monoplane "Pride of Detroit" took off at 7:54 a. m. Newfoundland Summer-time for the second leg of its projected flight around the world. Croydon, England will be the next stop. The plane is piloted by Wm. S. Brock and carries Edward E. Schlee as passenger.

PROTECTION NEEDED FOR FOREIGNERS
WASHINGTON, Aug. 27.—(UP)—Mexican military protection has been requested for 18 Americans and 11 Britishers reported to be barricaded against alleged "red syndicates" who have taken over the Amparo company mines near Guadalajara.

The state department announced Friday that American Charge D'Affaires Schoenfeld requested such protection following a request from the American consul at Guadalajara, based upon reports of refugees from the mine. An earlier consular report from Guadalajara stated that labor agitators from Guadalajara were attempting to rouse the workmen to take action against foreigners at the mines in case of execution of Sacco and Van Zetti, the department announced.
