COLLEGE PRESIDENT
NOW IN MOVIES

From the office of Paramount comes the announcement that "Tall Timber," by James A. B. Scherer, will be put into production at the Hollywood studios as a forthcoming Paramount picture for Wallace Reid.

Exceptional interest attaches to this statement because "Tall Timber" is the first photoplay from the pen of the first college president to resign his educational honors in order to write for motion pictures. James A. B. Scherer surprised the educational world recently when he abandoned the presidency of California Institute of Technology to join the writing staff of Paramount.

"Tall Timber" will be screened under the direction of Frank Urson, and many of the exterior scenes will be taken in the redwood forests of California.

The eminent educator was born in Salisbury, North Carolina. He received his Bachelor's and Master's degrees at Roanoke College, Virginia, and the degree of Doctor of Philosophy from Pennsylvania College. For five years he taught English at Saga College, Japan. He has written several authoritative books on the Japanese question, including "Japan Today," "Young Japan" and "The Japanese Crisis." He was made president of Newberry College, South Carolina, leaving there to become internationally known for his work as chief field agent, Council of National Defense.

At the Lasky studio he is a member of "Celebrity Row," which includes Sir Gilbert Parker, W. Somerset Maugham, Edward Knoblock, Samuel Merwin and Elinor Glyn.

WILD BIRDS
CHOOSE FORMER NESTING PLACE
URBANA, Ill.—Though many birds from this section migrate a far south as Central and South America, it has been found by actual test that many of them return to the same localities and sometimes even to the same nest.

Results of inquiry in the Middle West and South covering a number of years are reported by Frank Smith, professor of zoology at the University of Illinois, in the annual Illinois Arbor Day and Bird Book.

Facts were obtained by trapping birds, placing small leg bands on them, and letting them go. Here are some of the things Professor Smith records:

A catbird banded near Cleveland,

Ohio, in 1914, was retaken in the same locality the following year. Two catbirds banded in 1916 were retaken in 1917, and one of them was again taken in 1919. Catbirds winter as far south as Panama.

A chimney swift banded in 1916 was retaken in the same chimney the following year. Chimney swifts winter wholly south of the United States. A tiny house wren banded in 1915 was retaken in 1916 and found to be using the same nest box that it had occupied the preceding year, in rearing its second brood of that summer. House wrens winter in the south Atlantic and gulf states.

Tests at Thomasville, Ga., with birds classed as "winter residents" because they fly into the northern states and into Canada during the summer months, showed these results:

Eight shipping sparrows banded in 1916 were all retaken in 1917. Three chipping sparrows were retaken in 1917 that had been banded in 1915. Several myrtle warblers and white-throated sparrows banded in 1916 were retaken the following year.

Charles Freeman
Laid to Rest in
Mountain View

The funeral of the late Charles T. Freeman, whose death occurred at his home on Oberlin street Thursday evening after a long and painful illness, took place yesterday afternoon at 2:30 o'clock from the Nazarene church, and was conducted by the pastor of that church, Rev. McShane, while a military service was conducted over the grave in Mountain View cemetery. Pall bearers were chosen from members of the American Legion with the exception of one, Homer Billings, who was a former Sunday school teacher of the deceased, and were: Milton Fraley, Homer Billings, Dr. R. L. Burdick, William Sams, James Spencer and Gerald Gutter. A full squad of the Oregon National Guard accompanied the bier to its last resting place, where a salute was fired over the grave and taps were sounded.

The death of this young soldier is most sincerely mourned by his many Ashland friends. Ever since returning from France where he had gone with his comrades in his country's defense, Charles Freeman had been making a noble fight for his life, and the fact that it was a losing one made it all the more gallant, as he bore his sufferings with the same uncomplaining spirit that accompanied the soldier on the field of battle.

Charles Talmadge Freeman was son of A. L. and Mary Freeman, and was born in Pacific county, Washington, December 27, 1893, and died at the home of his mother in Ashland, Oregon, April 14, 1921, at the age of twenty-seven years, three months and eighteen days. Charles moved with his parents to Ashland in 1903, where he attended the city schools. He spent one year in the Corvallis high school.

In 1914 he graduated from the Ashland high school, and the year following he remained in Ashland. Later he spent some months in the study of music in San Francisco.

In 1915 he enlisted in the service of his country and became a member of the Oregon National Guard, first company. Upon the entrance of our country into the world war, Charles was called home from San Francisco and went into training at Fort Stevens, at which place he spent about seven months. He then started for France with his company, Battery E, 65th Artillery, and arrived there the latter part of April.

He was placed in the hospital at Fort Snelling near St. Paul, Minn. The latter part of February he was transferred to the general hospital near Denver, Colorado, where he remained a year and eleven days. From here he received his discharge and arrived at his mother's home in Ashland, March 9, 1920.

His health being badly broken he went to Portland, Ore., where he spent some time in the Pierce Sanitarium. Failing to obtain any permanent relief he returned home where he remained until the final summons came from on high.

At the age of fourteen Charles united with the Methodist Episcopal Church of Ashland, and up to the time of his entrance into action for his country, he was faithful in his attendance and church work. After his return home his health would not permit his public attendance at church, but at his private and home life he maintained his faith and hope in God.

He leaves to mourn their loss a father and mother, four brothers, Claude N. A. Bert, Rolfe and Edwin, and one sister, Miss Ethel Freeman, and a host of friends.

ASHLAND BOY TIES FOR HIGH HONORS

Twenty-four students in the University of Oregon have been permitted to register for honors. Exceptionally high grades are required to take the honor examination at the end of the year. Until that time "0," the highest possible grade, is given the students. POET AT 50 SAYS
CAREER AS AUTHOR
IS JUST BEGUN

Dick Posey's introduction as a professional entertainer is most interestingly depicted in yesterday's Oregonian, in an interview given by him to O. H. Barnhill, the well known former Ashland man who is fast becoming a writer of considerable prominence. Preceding a number of sketches from the popular poet of the Rogue River Valley, Mr. Barnhill gives the following sketch of Mr. Campbell, "Dick Posey," as he appears before a Chautauqua audience.

"After parking his car on the shady side of the big cement garage, the newcomer strolled over to the Chautauqua tent, from which issued sounds of hilarious laughter. Accelerating his pace, the visitor bought a ticket and hurried inside the tent to learn the cause of such unbecomingly mirth. On the platform a jolly-faced man of fifty-something, with white hair and twinkling eyes, was impersonating a small boy telling how his father weaned a calf, seeming to enjoy the story as much as the audience.

"Pretty soon the speaker changed to sob stuff, making believe he was an old man mourning for a brother in battle and had come home to die. A hush came over the vast audience as the people listened with rapt attention to the speaker's quivering voice and watched his pain-drawn face. Many a tear bedewed a face but lately convulsed with laughter.

"Who was this man whose elocutionary art so powerfully played upon human emotions? 'Dick Posey,' the Riley of the Rogue,' read the programme.

"'Anybody can make people laugh,' deprecatingly averred Mr. Campbell behind the scenes, vigorously fanning himself with a palm leaf. It's when people's hearts are touched and they are so still you can hear a pin drop that I feel I am doing my best work.

"Yes, this is my first year as a professional entertainer. How did I come to start elocuting on the shady side of 507? Well, I've been speaking pieces for 30 years or more, but never made it a business until this summer. When I was a young fellow back in Posey county, Indiana, I used to read Riley's poems in public. Pretty soon I began substituting my own poems for his, gradually reading more and more original compositions until finally I dropped Riley altogether. But folks never knew just when the change was made.

"I first 'committed poetry' when about 14 years of age," continued Mr. Campbell. "A long and impossible legend was sent to the Toledo Blade, which promptly returned my maiden effort, together with a cold and clammy rejection slip. Shortly afterwards a well-known firm of music publishers, which evidently had seen or heard of my first effusion sent me a request to submit some poems."

"That was when opportunity knocked at my door," sadly confessed the poet, "but I didn't recognize the lady and so turned my back upon her, being so disheartened at the failure of my first literary effort."

"Mr. Campbell came west some 25 years ago, being postmaster at Aberdeen, Wash., for a dozen years, afterwards removing to Ashland, Or., where he has since resided, selling real estate and various other commodities. Even and anon—sometimes offener—he has read his poems at public gatherings, generally for no other remuneration than love of the work.

"The uniform success of these readings and the remarkable enthusiasm with which they were everywhere received attracted the attention of Chautauqua managers, who last year engaged Mr. Campbell for a season's platform work. So eminently satisfactory were the efforts of the new entertainer that plans are being worked out to keep him busy the entire year playing upon people's heartstrings and tickling their funny bones."

SIXTY-EIGHTH ANNIVERSARY
OF ARRIVAL OF HILL
FAMILY OBSERVED

Thursday witnessed the observance of a very notable event in connection with Ashland. This was the celebration of the 68th anniversary of the arrival of the Hill family, one of the first pioneer families to settle in this part of the Rogue River valley. It was also the 33rd birthday of Mrs. A. H. Russell, one of the members of that family, who was a mere slip of a girl when the journey was made through the unsettled western country. The date was further marked by the 15th birthday anniversary of Mrs. Russell's grandson, Francis Winter, and, as is the usual custom, the "Hill tribe," as this well-known family is known in this vicinity, held a gathering to celebrate these anniversaries.

The home of Mr. and Mrs. O. Winter was the scene of the annual "tribe" gathering this year, and 31 guests, principally members of the Hill connection, sat down to a most sumptuous dinner at 6:30 o'clock

Thursday evening. The house and table were extensively decorated with wild flowers, as these were the only blossoms to greet the advent of the Hill family in their introduction to Ashland 68 years ago. Whatever the wilderness brought to this dearly beloved family, the passing years have set lightly upon the heads of the two members who survive. These are the guests of honor at this observance: Mrs. Russell and her sister, Mrs. Mary Dunn, and these two enjoyed the gathering of the "tribe" with as keen an interest as in the days of yore, when the country was new to them.

The birthdays of other members of the family occurring in close proximity to April 14 was the signal of a more extended celebration this year. Three others were honored in this manner by the joint celebration. These were Mrs. Hugh Gillette, Miss Trina Rice and Mrs. Dan Walker, a close friend of the family and herself a pioneer resident of Ashland. Besides the bountiful repast spread before the party, four handsome birthday cakes held a conspicuous place on the board. One of these before Mrs. Russell was marked "83," announcing the years that had flown over her head, while the others more a question mark. Mrs. Russell was also presented with a delightful handkerchief shower, the gifts filling a handsome basket. Amusing gifts were also showered upon the others whose birthdays were observed. A delightful evening was spent after the dinner, with music and story telling, during which Mrs. Edwin Dunn sang several beautiful selections.
