## SCRIBE ESCAPES

UNSCATHED FROM  
EDITORIAL BULL PIT

I went up to Corvallis last week and talked to the Oregon editors at their annual convention. The editor of the Tidings asked me to write something for his paper about the trip, and I said I would. This is it. All conventions are alike. They consist chiefly of program and Josh. A long list of subjects are chosen for discussion, and while a great deal is said, little is remembered. Each speaker has to tell a funny story, give some statistics, quote Shakespeare, and call somebody a liar before he gets started on his subject.

I did all these things in my speech except call someone a liar. I prefer to do that by radio or long-distance phone.

My story was about the fellow who made a specialty of doughnuts. He figured out that he could save money by making the holes in his doughnuts larger. That is, he would give his customers more hole and less doughnut. One day he suddenly realized that it takes more dough to go around a big hole than around a little hole, and he went crazy because he had made such a blamed fool of himself.

For statistics, I gave some figures compiled by experts on the pastime of fishing. These figures showed that 243,721,862 pounds of fish are lost every year because fishermen jerk their poles too soon. I imagine twice that many pounds are also lost because they jerk their poles too late.

This was my quotation from Shakespeare: "Some men buy advertising, others deadhead it, while Henry Ford has it thrust upon him."

The subject of my talk was "The Value of Newspaper Features." These features are becoming more and more popular all the time. A "feature," if you are not familiar with that term, is something supplied daily to the papers by various syndicates. The cover just about everything there is. The comic strips like "Mutt and Jeff," "Bringing Up Father," "The Katzenjammer Kids" and "Polly and Her Pals," are illustrated features, while other features are just plain reading matter. My own stuff, "Sap and Salt," that you see in the Tidings every day, belongs to the latter class. Many papers subscribe for these various features, and in this manner the work of the well-known artists and writers can be had at reasonable cost, and millions of readers are entertained and amused by them. The small daily can thus run the same matter as the metropolitan dailies and get the best there is in art and literature.

Features not only help editors to get new subscribers, but hold them as well. Readers become accustomed to look every day for their favorite feature, and soon it is a habit that sticks. Some features seem so silly you wonder why in the world they are published, but readers have different ideas of what is interesting and amusing, and what one likes, somebody else doesn't, and there you are! No feature can last if it fails to find a following, and no feature can be "killed" if the public wants it.

A large part of the big Sunday papers consists of features. You see the same things in the Portland and San Francisco papers, that you see in New York and Chicago. By dividing the expense up between them these papers all get the best there is to be had, while no paper alone could afford to employ all these high-priced artists and writers.

About all I remember now about

the trip was the awful condition of the Pacific highway on both sides of Roseburg. Recently I crossed the continent by auto from New York City to Ashland, and in all that distance I cannot recall worse pieces of roadway than the detours between here and Eugene. When Oregon gets as good roads as she now has scenery, she will take her place ahead of California and Yellowstone park. What we need are better roads and more advertising. The roads are in process, but so far as advertising is concerned, we are away back in the rear of the parade.

The trip to Corvallis made one thing very plain in my mind, and that is this: Ashland has more fine scenery to the square inch than any other dozen spots I saw going and coming back.

MAN ACCUSED OF BEATING  
WIFE ARRESTED SATURDAY

Carl Wolf, of 128 Factory street, was arrested Saturday by local officers and lodged in jail, on the charge of beating his wife.

Mrs. Edith Beardorff fell down a flight of stairs at the home of her daughter, Mrs. Robert Middleton, Wednesday evening, and while she was severely shaken up and received a few bruises, she fortunately escaped any apparent serious injury. No bones were broken.

She had gone upstairs to retire for the night, and had gone to one of the other rooms upstairs before going to her own. When she returned to the hall, which was dark, and started for her own room, she mistook the stairway for the door to her room, the two being side by side, and made a step which she thought would take her through the doorway, but instead, resulted in the accident.

GASOLINE SUPPLY  
WOULD RUN OUT IN  
ABOUT SIX WEEKS

Much speculation has been entered into as to how long the motor cars of this vicinity would run in case of a complete tie-up of the railroads.

In an interview with Mr. Patton, local manager of the Standard Oil company, he made the statement that his company had about 80,000 gallons of gasoline in storage at the present time, and at the rate at which it was being consumed, this amount would last for about 30 days but his opinion was, that should a tie-up occur, the sale of gas locally would be confined to commercial cars and thereby lengthen the time which it would last to six weeks or possibly two months.

Information at hand indicates that the other companies which sell gas in the city would have a supply that would last about the same length of time.

This would mean that should the strike stop all trains, approximately six weeks would pass before the people of this community would begin to feel the effect of the strike greatly, although it is probable all pleasure cars would be compelled to stay in the garages.

SPECIAL GRAND  
JURY IS HEADED  
BY A WOMANINVESTIGATION OF ALLEGED  
OUTRAGES BEGUN TODAY  
IN MEDFORD

Jury Was Sworn In This Morning  
In Jacksonville and Convened  
This Afternoon in Medford, Where  
All Sessions Will Be Held.

The opening battle being staged in Jackson county generally, and in Medford particularly, against the Ku Klux Klan, was begun this morning, when the special venire of grand jurors was assembled in Jacksonville, and sworn in. The special jury, which will make the investigation into the alleged outrages in this county, is headed by Marie Benedict, who will officiate as foreman. The others are: Paul C. Pearce, Charles Lindsey, Delbert A. Lyons, J. W. Smilie, Frank Silva and Lester Layton.

The particular offenses to be inquired into occurred last spring, when a citizen named Hale was taken out by a mob and badly scared, although not injured. About 40 witnesses have been subpoenaed.

Assistant Attorney General Lilleqvist, a Marshfield lawyer, will represent the state in the investigation, assisted by District Attorney Rawles Moore. It is considered rather singular that Governor Olcott should have chosen Lilleqvist to conduct this investigation. He is a Marshfield man, the home of Senator Hall, who is battling Olcott for the gubernatorial nomination, and for some years was a political ally of Hall's.

The eyes of the state are fixed on Jackson county just at this time, largely owing to the fact that Assistant District Attorney Raymond L. Turney, of Los Angeles, is on hand fresh from a similar investigation in that city, and is said to be in possession of a complete roster of the membership of the Klan in this state. Besides this array of legal talent, the federal government is taking a hand in the investigation. Tom Word, state chief of the department of justice, having arrived in Medford with a corps of secret service operators.

All the principal newspapers of the state, as well as the Associated and United press, have representatives on hand, indicating that Jackson county will get more advertising in the next few days than it has had in many years.

The boys' and girls' clubs of Jackson county held their annual picnic in Lithia park Saturday, and reports indicate that all present enjoyed themselves greatly. Some seventy members were in attendance.

They arrived at the park during the forenoon, and after an appetizing basket lunch at the noon hour, listened to two short addresses, one by County Agent C. C. Cates, and the other by Mrs. Cowgill, of the faculty of Oregon Agricultural college.

Games between individual members and between the different clubs were indulged in for some time, until the swimming pool was mentioned; when all were in the notice of taking a plunge, and the balance of the afternoon was spent at the Natatorium.

Lloyd A. Moss, county club leader, had charge of the picnic, and while a larger number was expected, he was very much gratified with the success of the entertainment. H. E. Badger, who has charge of one of the local clubs, assisted Mr. Moss in the activities of the day.

## JACKSON HOT SPRINGS

## IMPROVEMENTS GOING IN

The improvements at Jackson Hot Springs are being steadily pushed forward and every day sees the work nearer completion than the previous day. The large dance pavilion, which was finished just before the Fourth, is laid of the best lumber obtainable and in the best manner possible and presents as nice a floor as was ever seen for dancing purposes. The floor is kept covered with sawdust and shavings when not in use, to protect it from the sun. The posts for the side walls have been erected. They are about 10 feet apart and of 4x4 material. The shingles have been hauled to the ground, and a roof will be put over the platform before the rainy season starts.

The excavation work for the swimming tank is getting well along and all the dirt that can be taken out with teams and scrapers has been done this way and the balance of the work will consist of straightening up the side walls. The forms for the sides will be built within a short time and the cement will be in place within the next fifteen or twenty days. The proprietor expects to have the tank in shape and ready for use in a short time.

A great deal of the ground surrounding the pavilion and tank was of a marshy and boggy nature and the solid dirt that was taken out of the bottom of the tank was deposited in these soft places after tile had been put in to carry off the underground supply of water. The ground now presents a solid surface over which machines and teams can go with ease without fear of being swallowed up in the soft ground.

The trees surrounding the tank and pavilion make an ideal spot for rest and recreation and will be a beauty spot when all of the present plans have been worked out and the grounds graded.

The Parent-Teachers association announced some time ago that they had obtained a special rate for the children of the city to swim at Helman's bath house, and that a special instructor would be present at the bath house in the mornings to give swimming instruction to all children who bought the tickets through the association.

Despite the fact that the bath house is liberally patronized by the children of the city, it seems that very few purchase tickets from Miss Chatten, the playground superintendent, who has the tickets of the association for sale.

The tickets are sold at 20 cents each, children buying such tickets to furnish their own bathing suits. This ticket also entitles the child to swimming instructions from Miss Chatten, who has taken a special course that she might be the better qualified to teach others. The classes have been very small and thereby each child gets more special attention than where there are larger classes.
