### PETITION FOR WAGON ROAD UP WEST FORK

T. B. Adams, the well known miner and prospector, was in town Saturday circulating petitions, one to the Forestry bureau and the other to the county court. The former asked that the government trail from the falls eight miles up the west fork of the Wallowa be made into a wagon road, over which supplies, wood, stone and mineral could be hauled. The petition to the court asked that body to aid in the construction of said road.

Mr. Adams states there are several claims up there that would be coming paying producers if this road was built. Both petitions were very generally signed, over 180 signatures being secured up to Saturday noon.

E. F. Stubblefield was circulating Saturday a petition to the Forestry bureau, asking for a rearrangement of the Wallowa National forest boundaries, taking out of the reserve land on which there is no timber, but opening it for agricultural and grazing purposes. This petition was also very generally signed.
