WALLOWA BETTER THAN WILLAMETTE

OPINION OF ONE WHO RESIDED 27 YEARS WEST OF THE CASCADES.

Wallowa county has better climate and soil and better opportunities in every line than the upper Willamette valley, according to J. A. Fisk, the well known stockman, who was in Enterprise, Monday. Mr. Fisk returned Thursday from a seven months visit at his old home in Lane county. He first went to Acme, four miles from the mouth of the Siuslaw river, where he visited his brother whom he had not seen for 11 years. The damp fogs of the coast made him ill, and he came into the interior to Eugene and Crow where he spent the winter.

Mr. Fisk resided 27 years in Lane county before coming here eight years ago so he knows of what he speaks when he says he would rather have one acre here than 30 acres there. An indication of the backwardness of the country in agriculture is shown in the wages. Farm hands there receive 75 cents a day or \$20 a month. Here they get from \$35 to \$45 a month. In Lane haying wages last summer were \$1.25 a day, and during the short harvest season \$1.50 was paid.

Eugene, as the result of much advertising, is having a big real estate boom and is filling up with Eastern people. Mr. Fisk said he suffered more from the cold there last winter than he ever did here, and in spite of his long residence there does not like the rain and heavy, damp fogs. He has come back more enthusiastic than ever over the climate, soil and conditions in this county, and says it is good enough for him to spend his days in.

Frank Houck of Ellen is in town to see his cousin and a friend, Messrs. Houck and Hastings of Pullman, Wash., who are here looking over the country with a view of locating. Frank Houck has traveled over every section of Washington and says there is no place at all equal to Wallowa county, in soil, climate and opportunity.

Death of Father Bradley.
