**BANK GUARANTY WINS.**

It seems pretty evident now that those who opposed the bank deposits guaranty plan which was a part of the Democratic platform in the last national campaign will have to hunt up new arguments with which to combat that policy should it ever become an issue in the future.

Up to within the last week or so they cited that while the scheme would no doubt work all right in the case of small failures, the failure of the larger banking institutions in a

state which had adopted that policy would "show it up as a delusion and a snare."

But a \$3,000,000 failure in Oklahoma last week demonstrates that the new law does hold water. No sooner was insolvency discovered than the state bank examiner took charge and quietly began to pay out the depositors in full.

There was no excitement, no riots, no worry, no suffering, no record of suicide.

The bank examiner just took charge and paid off the depositors as they presented themselves.

Of course that wasn't satisfactory to everybody. There were some people who objected to the plan merely because it was working so well. So these people got out a federal injunction restraining the state official from complying with the state law.

It happened that there was a nephew in the injunction and that public servant found it and continued his work until every creditor was satisfied.

Of course the carping critics will not admit that the scheme is a success, not yet.

"Wait till a lot of the banks fail," they say.

As a matter of fact the conditions—even should the failure of a lot of banks at the same time, a coincidence that can hardly be considered a logical contingency—the condition of the depositors would not be any worse than with no guaranty at all.

But what's the use of considering such a fatuous speculation? It is just about as useful as that old argument about the number of angels who could stand on the point of a needle, by which Duns Scotus gave the legacy of his name as a "pat" addition to our language.
