O. A. C. To Celebrate Quarter Centennial

Great Time Planned At End Of College Year—Forestry Professor.

Corvallis, Feb. 10—The Oregon Agricultural College will celebrate its Quarter Centennial as a state institution at the close of the present college year with the most elaborate function ever held at the institution. The most able and distinguished speakers obtainable, excellent music, military drills, athletic contests and dramatic exhibitions will be among the features. All of the college and student organizations will hold reunions—in short every effort will be made to attract the alumni of the college at this time. The details have not been worked out but the enthusiasm of both the student and the faculty, in whose hands the arrangements have been placed is a sufficient guarantee of the great success of the undertaking.
George W. Peavey has been engaged as Professor of Forestry at the Oregon Agricultural College to fill the vacancy left by the resignation of Professor E. R. Lake.
Mr. Peavey is a graduate of both the Literary department and the Forestry School of the University of Michigan. He has been in the Government Forest Service for several years. Much of this time has been spent in the Pacific Coast states. He resigned the position as chief of planting in the states of California and Nevada to accept the position at the college.

REPUBLICAN ASSEMBLY.
The Republican state central committee, or to speak accurately, a part of it, has issued a call for a state "assembly" of the party to meet in Portland, Thursday, July 21. It is to consist of 1248 delegates, 18 being the number allotted to Wallowa county. It recommends the selection of delegates by county assemblies, delegates to the latter being chosen by majority vote only, at precinct mass meetings. M. C. George is the newly elected state chairman, succeeding Judge Calk, who resigned.
