

# INSTRUCTIONS AS TO LANDS

## WALLOWA NATIONAL FOREST IS STILL TECHNICALLY CLOSED.

La Grande, July 1.—The recent eliminations of various tracts of lands supposed to be of an agricultural character, from the edges of the national forests, by proclamation of President Taft, has been the cause of nearly as much interest and far more misunderstanding on the part of the general public than the famous openings held last year in the states of Washington and Montana. At the U. S. Land Office at La Grande, official notice has been received giving the eliminations from the Umatilla and Whitman national forests only. The Wallowa National Forest, which is the center of interest in this part of the country, has not yet been flooded here. A copy of the presidential proclamation, in connection with the Wallowa forest has been received in this city, through unofficial sources, and all persons intending to file upon lands should carefully note the following paragraph relating to settlement and entry of lands thrown out:

"The lands hereby eliminated from the Wallowa National Forest which are not embraced in any other reservation or appropriation, shall be restored to the public domain and become subject to settlement under the general provisions of the homestead laws on such date and after such notice by publication as the secretary of the interior may prescribe, but shall not become subject to entry, filing, selection, or other form of appropriation until the expiration of thirty days from the date so fixed, and no person will be permitted to gain or exercise any right whatever under any settlement or occupation begun prior to such date, and all such settlement and occupation are hereby forbidden."

It will thus be seen that, before the Interior Department names a date for settlement, no one will be permitted to settle upon any of the eliminated lands, as this is expressly forbidden. It will also be noticed that none of such lands will be subject to filing of any kind until the expiration of 30 days from the date fixed for settlement. Hence the element of speculation and fraudulent location in connection with these lands is largely minimized. Due advertising will be made, through the local officials, not only of the dates but of the lands eliminated as well. Therefore, intending settlers should be very careful to follow strictly

the official notices and directions, and, if this is done on the part of those interested, no official influence need be consulted or followed. The officials here request all interested persons to use extra caution in this regard.

# ORGANIZATION AT JOSEPH FORMED

## SOCIALIST SPEAKER J. L. FITTS FINISHED SPEAKING DATES AT THIS PLACE.

Socialist speaker J. L. Fitts arrived in Enterprise Tuesday evening, speaking in the assembly room of the court house here the same evening. He spoke in Joseph Wednesday evening and night, and returned to Enterprise to speak Thursday evening on the street and Thursday night in the court house again.

At Joseph a socialist organization was effected by the speaker, Mr. Mahan there being chosen organizer, and George Houser secretary. Both meetings at Joseph were held on the street.

In his speaking here, Mr. Fitts gave general satisfaction. He was denounced by those who heard him to be a departure from the rampant idealism affected by some exhortors of the same calling. He dealt with the theme of socialism versus capitalism in a calm though earnest manner, and confined his remarks to argument rather than to abuse. At Joseph he devoted much of his time to showing the distinction between the two parties, notably, the laboring party and the capitalist party. In Enterprise, instead of alighting upon God, church and the religious conviction; rather than harrowing up with irrelevant noise and inaccurate sedition the institutions that must be preserved under any phase of economy, he showed how socialism would all the more conserve the good in all institutions by eliminating the bad, than is possible under a regime of heartless and more or less brutal class struggle. And on the whole, his handling of the economic problems which lie at the heart of the producing world, gave general satisfaction.

### BUSINESS CONDITIONS.

Extract from editorial New York Herald, May 30, 1910.  
The only unfavorable element in the situation is the unfavorable attitude of federal lawmakers and state officials towards the railways and the spirit which would prevent the companies from moderately advancing their charges to offset the increased cost of operation. When the manufacturer is obliged to pay higher prices for raw material and increased wages he does the only possible thing in the circumstances and correspondingly raises the charge for his product. The railways are obliged to pay increased prices for supplies and higher wages, and it is only reasonable that they should get more for what they sell, namely, transportation.

That they are impelled to raise their charges is plain from current traffic returns showing increased gross takings, while costs of operation have increased in still greater ratio, with resulting decrease in net earnings. Unless the greatest of all industries is permitted to prosper the country cannot be prosperous.

Archbishop Christie dedicated St. Philip's church, the new Roman Catholic edifice at Dallas, Sunday.

The Chemawa Indian school has a stand of 14 acres of white spring side oats that measures an average of 6 feet 5 inches in height.

Definite plans are being carried out for the Wallowa hospital, and before August 1 it will be ready to receive patients.

In a report prepared by the state land department it is shown that the department has paid over to the state treasurer \$33,089.37 for June.

Walter Malory, charged with stealing horses in Asotin county, Wash., is being sought in the fastnesses of the lower Grande Ronde river by officers, who believe that he is hiding there.

Miss Alice L. Webb, for the last five years assistant editor of the news bureau of the University of Wisconsin, has been appointed editor for the news bureau of the state agricultural college of Oregon.

Within less than five months, say the promoters, Marshfield and North Bend will be connected by an electric road now in actual course of construction. The distance is 5 1/2 miles. Next year it is planned to extend the line to Empire.

Chester W. Washburne, a graduate of the University of Oregon, class of 1905, has been placed in charge of the United States geological survey on the lower Columbia river, to ascertain, definitely, whether or not the country has deposits of oil, gas and coal.

The general opinion that Attorney-General A. M. Crawford was a candidate for the gubernatorial chair was overturned when he filed his declaration of intention with the secretary of state to become a candidate for reelection to the office of attorney-general.

As a result of statements charged to members of the Umpqua Valley Horticultural Society and Fruitgrowers' Association, in which they accused members of the Roseberg Merchants Protective association of unfairness in buying farm products, a war between the organizations is raging.

While one of his helpers struggled with him trying to seize the revolver with which he had threatened to kill himself, George Bennett, a prominent dairy man of Tillamook county, finally wrested the weapon away and shot himself through the head. Death was instantaneous.

Articles of incorporation are in the course of preparation for a company to build and equip a large modern hotel to be built in the center of the business district at Klamath Falls. The hotel complete is to cost approximately \$75,000. Much of the stock has already been subscribed and the undertaking is sure to be a success.

An initiative petition favoring the creation of an employees indemnity commission has been filed with the secretary of state.
