Fast Steamer May Oppose Kilburn.

George D. Gray, of San Francisco, head of the California & Oregon Coast Steamship Coast, is here on one of his periodical journeys North. Mr. Gray's presence in Portland at this particular time is significant in view of the recent developments in the tussle for business between the several steamer lines paralleling the coast between the Columbia river and San Francisco.

Mr. Gray informed a representative of the Telegram he had no information to give publicity to, but it is believed his mission here is to arrange for the substitution of a faster steamer in place of the Alliance to compete with the F. A. Kilburn, of the Russell & Rogers' fleet, which now makes the same ports as the Alliance, in addition to San Francisco, and of late has made better time than the C. & O. liner.

It was given out at the time the Alliance's route was changed, so that she touched only Coos Bay and Eureka, that another steamer would be placed on the through run the coming year. At that time there was no opposition to the coast port and the trade was safe, but since the Kilburn commenced to make points on Coos and Humboldt bays it is said the California & Oregon Coast Steamship Company has awakened to the necessity of bettering its facilities, and it is confidently thought a vessel will be secured that will be equally as fast as the Kilburn.—Telegram.

Washington, Dec. 29.—Commissioner Greene and Examiner Snyder, of the Civil Service Commission, returned here today from a three weeks' visit to the Panama Canal Zone, where they went for the purpose of introducing the commissioner's rule for the employment of people connected with the canal.

There has been an average of 1500 Americans on the isthmus for the past eight months, and not one death has occurred among them.

Fusaa, Dec. 29.—Rinlung fort was captured at 3 o'clock this morning, with 1000 Japanese casualties. Seven dynamite mines, exploded at 10 o'clock yesterday, made breaches on the front wall, through which a large body of Japanese charged, under cover of a tremendous bombardment, and captured the first line of light guns. A bitter fight resulted in the capture of the fort.

Bilibung Fort, situated about two miles from the outskirts of the town of Port Arthur, from it bears northeast. The fort just captured is a half south-east of Kekwan Fort, recently captured by the Japanese. The possession of these two forts should make a most important breach in the fortifications of Port Arthur and cut off communication between the hill forts and the forts of the western section of the inner circle of fortifications.
