Mile of Jetty Gone. Astoria, Or., Dec. 29.—Five thousand feet of jetty superstructure was carried away in an 80-mile-an-hour gale off the mouth of the river early this morning, leaving only 500 feet of the outer end remaining. To repair this work, together with the portion that was carried away by previous storms, will take several months, so it is unlikely that there will be any extension of the jetty until late next summer, if at all during the coming year.
