Enterprise of Coos.
Coos will be the only county in the United States to have a building at the Lewis and Clark Exposition. That enterprising section of the state will spend \$10,000 on a county structure which promises to outdo some state buildings in beauty and prominence. Plans for the Coos building were filed with the exposition management on Saturday, and show that the contemplated home for Coos exhibits will be spacious and beautiful in appearance.

This week a commissioner from Coos county will arrive in Portland and with Director of Works Oskar Huber, will pick out a site for the county building. Work on the structure will begin at once after the site is chosen, and it is expected to have it completed early in the spring, so that a careful installation of the Coos showing may be made prior to the opening.

To Protect Themselves Against Bad Debtors.

The merchants of this place have formed a merchants' protective association, the object of which is to protect themselves and each other against "dead beats." All merchants who do a credit business are to report to the association, from time to time, the names of persons who do not pay their debts, and such names will be placed on the "Dead Head List" and will not be allowed any further credit by members of the association until they pay up their back debts. Every merchant in Coquille has expressed an intention to join the association, and it is the purpose of the association to include Bandon and Myrtle Point, and any points between this place and those two points where there are merchants doing a credit business.

They have adopted by-laws and elected the following officers: D. H. Johnson, president; W. T. Kerr, vice-president; J. J. Stanley, secretary; and H. N. Lorenz, treasurer. Stanley & Burns have been appointed attorneys for the association and a bond or forfeiture is to be deposited with them by each member for the faithful compliance with the rules of the association.

It looks as though the professional "dead beat" will have a hard row to hoe in this town in the future; but if the conditions warrant such action on the part of our merchants, it is high time something was done to affect some kind of a change, and it is not at all flattering to our community that we have this class of citizens in sufficient numbers as to require concerted action by our business men for their self protection.

Salem, Feb. 1.—Senator Malarkey's bill amending the code to provide for the statute allowing the grantee of a deed five days in which to have the instrument recorded was killed in the House yesterday by a big majority.

Under the present law a person is allowed five days in which to record a deed, and if recorded at the expiration of the time allowed the instrument stands valid against any other executed at a subsequent time. The proposed law would repeal this provision and make one in its stead whereby the recording of a deed would take precedence of time in point of execution of another.

During the discussion the fact developed that the opposition to the bill was based on the ground that it was against the interests of those residing at a distance from the county seat and who were apt to be unable to attend to the immediate recording of conveyances. Laws similar to the one proposed are in force in other states.
