IN THE CIRCUIT COURT OF THE STATE OF OREGON, FOR THE COUNTY OF COOS.

Thomas Wilson, Plaintiff, vs. Angus McDonald, Mary McDonald and John McDonald, Defendants.

To John McDonald, one of the above named defendants:

In the name of the State of Oregon, you are hereby notified that you are required to appear and answer the complaint filed against Angus McDonald, Mary McDonald, and yourself in the above entitled suit within six weeks from the date of the first publication of this summons, to-wit:

Within six weeks from Friday, the 10th day of March, 1905, the same being the date of the first publication of this summons, and if you fail to so appear and answer on or before Saturday, the 22nd day of April, 1905, the same being the last day of the time prescribed in the order for the publication of this summons, for the last publication thereof, judgment and decree will be taken against the defendants in said suit for the relief demanded in the complaint in which is as follows:

That there be adjudged to be due and owing to the plaintiff from the defendants Angus McDonald and Mary McDonald the sum of \$800, together with interest on \$500 thereof at the rate of 8 per cent per annum, payable annually, from the 21st day of November, 1903; and together with interest on \$300 thereof, at the rate of 10 per cent per annum, payable annually, from the 22nd day of May, 1903; for such attorney fees in said suit as the Court may adjudge reasonable, and for his costs and disbursements in this suit.
