Sues for \$2,200 Damages.

Katie Sargent, of North Bend, has brought an action against N. J. Cousins, of the same place, wherein she is suing for \$2,000 personal damages, besides \$100 doctor's fees and \$100 general expenses. She alleges that she was thrown from her father's light wagon or buggy when he attempted to pass Mr. Cousins, also in a wagon, on the Virginia avenue bridge several weeks ago. She was so painfully hurt that she was under the doctor's care for some time and was forced to use crutches for several days or about three weeks. It is said that Mr. Cousins claims that Miss Sargent and her father attempted to pass him on the wrong side of the road and that when he heard him call to him to give him a chance to pass, he, thinking he was on the left turned his team abruptly to the right, which forced the one passing against the fence and the accident followed. Since court had adjourned, the case will not likely come up for hearing until the next term.—Harbor.

Ships Carload of Cheese.

On Tuesday of last week a carload of cheese from Myrtle Point went out via the Southern Pacific, being shipped direct to New York. The Enterprise says that the shipment was billed by Andrew Christensen, of the Sugarloaf Creameries, and included 451 cases, having a gross weight of over 37,000 pounds, and containing approximately 17 tons of cheese.

Can Pay Taxes Now?

The following North Bend dispatch to the Oregonian is interesting in view of the fact that Manager Stevenson, of the North Bend Mill & Lumber Co., stated here at the Budget meeting Dec. 31 that the company had not been able to pay any taxes for several years. \$200,000 new capital ought to help some in that line. The dispatch reads:

The North Bend Mill & Lumber Co., which has operated with fewer interruptions than any sawmill on Coos Bay for the past two years and a half, has undergone a change in ownership. The deal was closed in December in San Francisco. C. K. Hudson, of Washington, D. C., is the new member of the firm and has taken over the stock of L. J. Simpson and the Standish-Hickey company, of San Francisco. Two hundred thousand dollars of new capital went into the concern. The steam schooner Yellowstone, owned by Swayne & Hoyt, who are heavy stockholders, has been taken over by the company.

Schroeder Home Burned.

The residence occupied by Gus Schroeder and family, on the old Schroeder place at Arago, was destroyed by fire Monday, together with its contents. The origin of the fire is not definitely known, but it is supposed to have started from a defective flue. The men were out at work, and the fire obtained such a start that little if anything was taken out. Among the contents of the house was a new piano, and this with all the household goods, etc., made a heavy loss for Mr. Schroeder. The house was not of great value, having been built some years ago from an out-building, at the time the main residence was burned. This is the fifth destructive fire that has occurred on the place in the last eighteen years. The first destroyed the creamery built by the elder Henry Schroeder, and two store buildings have burned at different times. The old Schroeder residence went up in smoke at four years ago.—Herald.
