OREGON DISPLAY BEATS ALL

Tillman Reuter Takes First Prizes at Dry Farming Congress.
 Lethbridge, Alta.—Oregon beats the world as a dry farming country according to awards given exhibits from that state at the International Dry Farming congress which closed here. Tillman Reuter, of Madras, displayed what experts pronounce the finest dry farming products ever seen. He was awarded sweepstakes in the following classes:
 Best sheaf of barley, best individual exhibit of all kinds of grain, best grasses and forage, best 90-day corn and largest potato.
 He received first prizes for six-rowed barley, best spring rye, best three years' growth of alfalfa and sand vetch.
 This is not the first time that Reuter has won a "world's series" in the dry farming field. He won similar success at the congress in Spokane in 1910 and again at Colorado Springs last year.

Berlin Women in Riots for Meat.

Berlin.—Hundreds of Berlin housewives joined in a wild riot because the butchers in the union markets refused to handle meat imported so as to reduce the cost of living.

FILE STATEMENTS OF CONTRIBUTIONS

Washington.—Contributions totaling \$591,030.20 and expenditures of \$558,311.25 in the republican presidential fund were disclosed in the financial statement of the republican national committee filed with the clerk of the house of representatives.
 Charles P. Taft, brother of the president, appeared as the largest contributor. The report shows that he gave \$50,000 in two \$25,000 contributions to the New York headquarters, and \$6000 to the Chicago headquarters, making a total of \$56,000.
 Contributions to the presidential campaign fund of the democratic party this year totaled \$678,364, according to the sworn statement of Rolla C. Wells, of St. Louis. Expenditures aggregated \$562,618, including \$120,000 sent to Chicago from headquarters at New York, and there are outstanding obligations of \$55,149.
 All told 53,303 contributions were received by Mr. Wells and of these 52,030 were for amounts of \$1000 or less. Governor Wilson, the nominee, gave \$500.
 The Roosevelt progressive party received contributions for its campaign fund up to October 17 of \$304,244, spent \$292,341, and had unpaid bills and contract obligations for \$41,341 more.

Frank A. Munsey, who gave \$70,000, George W. Perkins, who gave \$45,000, and W. Emlen Roosevelt, who gave \$31,000, appeared as the leading individual contributors.

A SUMMARY OF IMPORTANT EVENTS

National, Political and Personal News Items Briefly Sketched.

Total abstinence has been enjoined on all Indian agents and Indian employes by Acting Commissioner Abbott, of the Indian bureau.
 Katmai volcano, which caused great damage on the Alaska Peninsula and adjacent islands last June, is believed to be in violent eruption again.
 Plans for the administration of the executive order of President Taft, placing all fourth-class postmasters under civil service have been announced.

Washington, D. C., was chosen by the executive committee of the national women's Christian Temperance Union, as the place for the 1913 national convention.
 The presidential election in Cuba is to be held Saturday and the result is awaited with keen interest because of the disturbed financial and political conditions in the island republic.
 Naval constructors have just completed a new hydroplane of distinctive design. The new craft was built at the Washington navy yard and reinforced leather enters largely into its construction, it is said.

Thursday the battleship New York, now building at the Brooklyn navy yard, was launched. The New York is a sister ship to the dreadnought Texas, recently launched at Newport News. The two vessels will be the largest fighting ships of the American navy.

William Hamilton of the Morgan firm testified at the hearing in the government proceedings against the International Harvester company, that J. P. Morgan & Co. received \$3,000,000 in International Harvester stock as a commission for the sale of D. M. Osborne & Co.'s plant to the so-called trust.

Political News Bits

Colonel Theodore Roosevelt is rapidly recovering from the wound inflicted by John Schrank's bullet.
 Figures compiled by Secretary of State Frank Jordan place the total number of registered voters in California at 988,706.
 Colonel Roosevelt expects to be able to attend the final campaign rallies of his party in New York city. Governor Wilson will make several speeches and Governor Marshall will be heard in several of the western states, winding up in Chicago the Saturday night before election.

The State Supreme Court handed down an unanimous decision in Nebraska, holding that the six Taft electors chosen by the republican state committee, together with the two republican electors chosen at the spring primary who remained loyal to Taft, are entitled to the designation "republican" on the ballot.

The week will see the close of the presidential and state political campaigns. All parties are preparing for the customary "whirlwind" finish, although doubt is expressed in well informed quarters whether the heaviest oratorical guns that can be brought into action will be effective in dispelling the pall of indifference with which the nation's financial and business interests, and to a great extent the public at large, appear to await the outcome of the election on November 5.

People in the News

John Evers, second baseman of the Chicago National League team, will be manager of the team next season, succeeding Frank Chance.
 After a vacation of nearly two months, President Taft has returned to Washington to take up the labors of what he expects will prove a busy winter.
 Governor Osborn of Michigan was one of the 13 persons injured at Chicago in streetcar and train wrecks due to a dense fog. The governor escaped with a slight hurt.
 Police Lieutenant Charles Becker was found guilty of murder in the first degree by the jury which recently tried him for instigating the death of Herman Rosenthal, the gambler.
 Mrs. Belva Ann Lockwood, veteran champion of woman's rights, candidate for the Equal Rights party for president of the United States in 1884, celebrated her 82d birthday recently.
 Saying she was inspired by the atmosphere of a state where women vote, Mrs. Thomas R. Marshall, wife of the candidate for vice president on the democratic ticket, gave her maiden speech at a meeting of democratic women at the Spokane hotel.

The election of United States Senator Root of New York, as Stafford Little lecturer on public affairs, was announced by the meeting of the board of trustees of Princeton university. The chair was held by ex-President Cleveland until his death in 1908.

TURKS ARE DRIVEN BACK RAPIDLY

Servians March Into Uskup Unopposed and Adrianople is Invested.

London.—The swiftness and efficiency of the onward movement of the armies of the allied Balkan states is making Europe open her eyes. From the north and all along the line from Greece on the south they are crowding back the boundaries of the Ottoman Empire in Europe. The often predicted and long delayed day when the Turk will have his back against the wall seems at hand.

The two pivotal points of Turkey's defense on the north were Adrianople and Uskup. The Bulgarian army in the east has defeated the Turks at Kirk-Killsseh, which is the strongest outpost of Adrianople, and invested that fortress.
 The Servian army in the west walked into Uskup without opposition. The Turkish garrison there withdrew on the railway toward Saloniki.

Events about Adrianople are even more important. The Bulgarians apparently are proceeding successfully with the investment of the fortress. The Turkish army which was defeated at Kirk-Killsseh did not fall back upon Adrianople, according to news, but took the road to the south, where it could connect with the railway to Constantinople. The second Bulgarian army followed through the mountains, carrying on the fight all day in an endeavor to cut off the retreating forces.

Constantinople dispatches continue to speak of the readiness of the Turkish army to take the offensive. In any case a few days must see decisive action. A Bulgarian army has occupied Bunarhisar and is marching towards Kuleli Burgas.

The Bulgarian forces, according to advices received at Sofia, have captured the towns of Lule Burgas and Demotica. It is also reported that the Turks are constructing earthworks along the river Erkene, west of Eskil-Baba.

Unless the Turks are able to take the offensive vigorously the present indication is that they will be driven out of Europe altogether, failing interference by the powers at the present stage to end the war, as happened in the Russian campaign against Turkey in 1828 and 1878, when Russia had captured Adrianople and was at the gates of Constantinople.

DIAZ CONDEMNED TO DEATH

Three Associates Are Also Sentenced By Mexican Court Martial.
 Mexico City.—General Felix Diaz, leader of the revolution recently inaugurated in Vera Cruz, and three of his confederates have been sentenced to death by the court-martial before which they were tried in that city.

At the same time that word of the verdict against Diaz was received, came the report that the military court had decided to recognize the order of suspension of sentence upon the revolutionary leader, granted by the supreme court, pending investigation as to whether the trial of Diaz should be by military or civil court.

Efforts to save their lives, especially that of Diaz, continue unabated. Prominent women, men high in affairs, members of congress, and even high army officers have appealed to President Madero for clemency.

Rojas Menaces Chihuahua

Juarez, Mexico.—A new menace in Chihuahua has developed by the entrance in the state of Antonio Rojas, the rebel leader who has been terrorizing Sonora, and the possible junction of his troops with those of Inez Salazar, operating south of Juarez. Already the two rebel forces are about 15 miles apart and General Blanco has set out from Casas Grandes with a strong force of federals to attempt to prevent the rebel junction.

PLOT TO ARREST CZAR BAREE

Plan Was to Take Russian Ruler on Private Yacht
 St. Petersburg.—News of a daring but frustrated plot to arrest the Czar and force him to abdicate the Russian throne, and fuller details of the alleged attempt to kill the 8-year-old Czarovich, heir to the crown, both stories naming the recently self-exiled Admiral Chagin as the chief conspirator, have stirred all Russia. It is said that the Admiral, the Czar's favorite, and commander of the imperial yacht, the Standart, committed suicide when warned by the telephone that the police were about to search his quarters.

Although the plot was hatched at St. Petersburg, the execution was planned for Jalta, where the fleet was seriously disaffected. According to persistent rumors the plan was to have the officers and crew of the Standart put the royal party under arrest and force the Czar to abdicate and waive his son's rights in favor of Michael.

BATTLE IN HAVANA STREETS

Conservatives and Liberals in Clash in Heart of City.
 Havana.—More than 20 persons were wounded here in a pitched street battle between conservatives and liberals, in which several hundred shots were fired. The trouble started at the close of a meeting of liberals, supporters of Vice President Alfredo Zayas, candidate for the presidency, and a number of conservatives who favor the reelection of President Gomez.

The fight was precipitated by the conservatives attempting to force the liberals from the sidewalk in front of the Hotel Inglaterra. The battle raged about central park, in the heart of the city, until mounted police and cavalry charged the fighters with drawn machetes. President Gomez placed his resignation in the hands of the secretary of state, but he was forced to withdraw it by the conservatives who insisted that he stay in the fight.

JUDGE, JURY AND LAWYERS IN FEAR

New York.—An extraordinary situation for any civilized community has developed since Lieutenant Becker was found guilty of murder in the first degree. The men who did their duty—the judge of the court, the lawyers for both sides, jurors and witnesses—cannot walk the streets with a feeling of safety.

Justice Goff was threatened by letter and over his private telephone before the jury returned a verdict. District Attorney Whitman has received threats that he will not live to prosecute another case, and John F. McIntyre, chief counsel for Becker, makes no secret of his belief that his life is in danger.

Friends of the jurors who convicted Becker have been getting anonymous letters and telephone calls, some of which have been alarming. Justice Goff, District Attorney Whitman, Attorney McIntyre and others who dislike sensationalism, have sought to minimize the facts that indicate that men who hire out for assassination and assaults seek an opportunity to cap the Rosenthal case with a crime more atrocious even than the killing of Rosenthal, but the facts are that vicious threats have been received and that precautions are being taken by the men threatened.
