

SHED BY BROKEN GLASS; NEARLY BLEEDS TO DEATH

BURG LOCAL CARRIES DINER TO GROVE

NARROWLY MISSES BEING DE- CAPITATED

Dispute Over Ticket Money at Armory Dance Results Seriously to One Disputant.

Miraculously escaping being decapitated or having his skull crushed in with falling plate glass, Edward Derringer bled profusely Saturday night from wounds received when pushed through the window of the Armory by James Potts, following a dispute regarding ticket money.

Derringer received severe cuts on both sides of his head and on his right wrist. He fainted from loss of blood. The injured man escaped instant death by mere chance, according to his own story. After falling through the window and lying with his neck in the frame, the glass continued to fall. The window was of extra strength plate glass and ten feet in height. A large piece falling several feet might easily have decapitated him or crushed in his skull. He thinks that a large fragment fell flatwise across his head and received the force of that which continued to fall, thus preventing fatal injury.

According to his story told The Sentinel, Derringer had closed up the skating rink of which he had charge at 11:30 and dropped in for a couple dances before going home. He found some fault because charged the price of a full ticket for only the two dances, was about to go home and had his overcoat part way on when Potts struck him in the face, knocking him against the window, then shoved him through the glass, all the while clinging to him and pushing him.

Potts has charge of the floor and in police court stated that Derringer made himself obnoxious and insulting and endeavored to pick a fight. He stated that both fell through the window and that he continued to push Derringer in order to get him out of danger of the falling glass. He was also hit by the glass but escaped injury. He thinks that the fact that he pushed Derringer clear of the window saved his legs from severe injury.

When Derringer got up with blood spurting from the wounds, girls were screaming and one young woman was swinging at Potts vigorously. Derringer, forgotten by the men in the excitement, was taken to a physician's office by two young women, fainting from loss of blood before help arrived. An examination showed that one gash missed an artery by a pin head. Six stitches were taken.

Warrants were sworn out for both Potts and Derringer. Potts pleaded guilty and was fined \$10 and costs. Derringer, who was at Eugene endeavoring to have a state warrant sworn out for Potts, left from there for his home at Grants Pass, whether to evade arrest or not is not known.

ARMY OFFICER THOUGHT SCORE IMPOSSIBLE

SIXTH COMPANY LOCATED AT COTTAGE GROVE MAKES UNUSUAL RECORD

Lorane, Ore., Nov. 18.—(Special to The Sentinel.)—As a result of the sudden raise in the waters of the Siuslaw, there was a large run of salmon and salmon trout last week and large numbers of them were caught. Some beauties weighing 10 to 15 pounds were captured.
