GROVE IS WORSTED IN DEBATE

EUGENE AND SPRINGFIELD TEAMS ARE VICTORS.

Local Teams Lose in Both Cases by Unanimous Decision. — Opponents Win Through Merits of Delivery.

workmen are certain of compensation is necessary. He quoted statistics to show that 80 out of every 100 injured are not compensated, that workmen get only a small percentage of the awards made them, the greater part being eaten up with costs of action, that delays of the law work severe hardship and that employers do not pay for injuries until compelled to.

Mr. Woodard, opening for the negative, implied that there might be some difficulty in defining "similar" and "hazardous" as used in the subject of the debate. While recognizing the need of protection of some kind for injured workmen, he believed the Washington law a false ideal and opposed the entering of the state into the life and accident insurance business, thereby establishing a paternalistic form of government, the result of which would be the furnishing of fat offices for a few who would loaf around waiting for employers with bribe money. His argument was that the insurance should be taken in some way out of the cost of production. He showed the danger of workmen purposely injuring themselves and of the unfairness to employers that might result from injuries maliciously inflicted by fellow workmen. "Why not carry the idea out to the pensioning of all who suffer from conditions for which they are not to blame? It would be just as reasonable," declared the speaker.

Miss Westfall's argument for the affirmative was well prepared and convincing. The way she said, "I will prove to you," left no ground for doubt that she would do so. She pointed out the weaknesses of the present liability law of Oregon whereby employers pay fees out of all proportion to services rendered and the injured workmen receive so little. She declared there should be no profit exacted in administering a fund for the benefit of the needy and showed how this could be brought about through the Washington law where the commission charged with its administering is allowed discretion in making assessments and settling claims that make it fair to both sides. "The industries and conditions," the speaker said, "are identical in Washington and Oregon and a law that works well in one should work the same in the other. She declared the employers should pay for injured workmen the same as for injured machinery and held up the Washington law as being extremely economical and having the endorsement of employers.

Miss Marston for the negative took up the social side of the question and attacked the paternalistic form of government under which all individual rights in business would be taken away. "The state," she said, "should not be asked to subsidize industry," and she demonstrated that the small industry would be given a big advantage over the large one, in that the small industry in case of a large casualty could quit business and escape just payments while the large one, with property larger than any probable loss by injury could not evade its own duty and would also have to bear the burden of the small industry that evaded the law. She also made a point of the fact that no provision is made for sickness resulting from unhealthy conditions imposed upon workmen. Closing, she declared a lawless state like Washington to be a poor one to pattern after and showed the litigation that might arise from passing a state law conflicting with the national law being considered by congress.

The summing up was brief on both sides.

The Grove team showed lack of time to prepare for the delivery of its arguments, which were fully as strong as those of the negative but were not as forcibly presented. The noticeable lack of support on the part of patrons of the schools also disheartened the home debaters. On both sides the feminine debaters were easily the favorites.
