CANNERY BUSINESS PROFITABLE

Report of Manager of Eugene Cannery Shows Past Year to Have Been Successful.

At the annual meeting of the Eugene Fruit Growers' Association the report of Manager Holt showed a wonderful business for the past year in the face of a shortage of \$40,000 in the items of cherries and prunes. The association handled 180 tons more cherries and 290 tons more prunes in 1911 than in 1912, so that the difference in these two crops could not be wholly overcome. But all kinds of berries showed a marvelous increase. There were but 600 pounds of gooseberries canned in 1911, while there were 39,110 pounds canned in 1912, an increase of more than 6500 per cent. The pounds of strawberries canned in 1911 were 40,590 and in 1912 89,800. The amount of loganberries increased from 29,353 pounds to 89,804 or 300 per cent; blackberries increased from 4920 pounds to 61,143, the amount of raspberries from 13,380 pounds to 18,214.

In the year 1912 large amounts of cabbage, tomatoes, rhubarb, beets, asparagus and spinach were canned while none were canned in 1911; 93,038 pounds of spring beans were canned in 1912 against 16,000 pounds the previous year, and 400,000 pounds of pumpkin in 1912 against 122,000 pounds the previous year. The total number of tons of vegetables for 1912 was 268 against 69 tons the year previous and the total number of tons of berries 147 against 44 the year previous. The total number of cans filled were 335,000, or 46 carloads.

SEVEN AND HALF YEARS FOR MEDFORD ROBBER

Wells Lounsberry, of Dr. Jekyll-Mr. Hyde Character, Convicted at Kansas City.

Wells Lounsberry of Medford, Oregon, convicted in the federal court in Kansas City, Kansas, Friday of robbing a mail car on the Union Pacific railroad between Kansas City and Lawrence, Kansas, last August, was sentenced Friday afternoon to serve seven and one-half years imprisonment in the United States penitentiary at Leavenworth. Lounsberry was taken to the penitentiary the same night.

Lounsberry and his wife sat side by side when the verdict was rendered. He apparently was unmoved. "Mrs. Lounsberry was prostrated when sentence was pronounced.

The Right Kind of Factories

At both Creswell and Cottage Grove determined efforts are being made to secure a cannery. At the former thriving little city, success is practically assured. The growers have been interested, and are planning to plant crops for the cannery's use, and enough capital has been pledged to assure the plant.

At Cottage Grove, the grange is gathering statistics and information from the farmers in order to determine how much land may be counted on to furnish the necessary crops. After this work has been completed, in conjunction with the Commercial Club, it will endeavor to interest capital in erecting a plant.

Both of these wideawake communities are following an excellent plan. The expression "factories and a payroll make a prosperous city" has been used so unthinkingly that it has become trite. Nevertheless it is true, and never more so than when used in reference to canning factories. The benefits conferred by these industries are twofold: a bucket brigade and a payroll are provided for the town where they are located; and the surrounding country is furnished with an excellent market for crops that would otherwise go to waste—and by going to waste is meant not only failure to use what is produced, but failure to produce the crops for which a market could be found.

More canning factories are one of the special needs of the Willamette valley. Production of the raw material will hasten the development of the land, and will make it bring satisfactory returns on a very high valuation. The market is almost unlimited, and needs only careful study.

Frequently the operation of canning factories opens up unexpected opportunities for profit to the farmers within the market radius of the industry. For instance, at Eugene the lowly pumpkin was made to yield handsome returns last summer—some growers getting gross returns of as high as \$100 to the acre.

At Corvallis, where a canning factory was established last year some startling results were obtained. Some difficulty in disposing of the pack was anticipated, but at the close of the season the manager received the surprise of his life. When he began to interview the buyers, he discovered that the problem was not one disposing of the season's pack, but of supplying the demand. He could have sold his total output four times over.

Every town in the Willamette Valley could easily support at least one prosperous canning factory, and the beneficial results would be far reaching. Land that is now scarcely paying taxes would be brought into profitable use, and room and employment would be found for four or five families where only one is now supported.

SPRINGFIELD PROPERTY IS SOLD TO GROVE MAN

W. N. Rinehart Purchases Choice Frontages on Main Street of Neighboring City.

The Eugene Guard of a few days ago published the following:

W. N. Rinehart of Cottage Grove who has taken options on two pieces of business property in Springfield from Perkins & Machen, was in Eugene today. When seen by a reporter he said:

"Yes, I have bought, or rather will buy these pieces of property and intend to buy another piece on Main street in Springfield in a few days, but am not ready to announce it till the papers are all made out. The statement that I represent John B. Yeon of Portland in these purchases is a mistake. I do not know how the report originated, but I presume some real estate booster started the story to make the sale of the property look big. I do not know Mr. Yeon at all and never had any dealings whatever with him.

"You may say for me that I have implicit confidence in Springfield's future. I have invested quite heavily in several Oregon cities just at the right time and have always made money on the investments, and I don't think I am making a mistake in buying Springfield property right now. I know nothing of the intentions of the Southern Pacific company in regard to building shops, further than that I have heard the reports and rumors, but even if the company does not build, Springfield is going to grow fast. I don't think it will outstrip Eugene, but it is going to be a much larger city than it is now. Mark my word."

Mr. Rinehart says he will improve the property which he has just bought and will eventually erect business buildings on the lots. He said the lot he bought having a frontage of 100 feet on Main street would be a fine location for a hotel.

Mr. Rinehart is a member of the pioneer Rinehart family which holds family reunions at different points in the state every year and is a cousin of H. D. Edwards, ex-county commissioner, of this city.
