LANE TO GET \$35,000 FROM FORESTS

Disposal of 500 Million Feet of Government Timber Brings County Large Sum.

The prospective sale of 500 million feet of saw timber in the Cascade Forest Reserve on the upper Willamette river by the government to private operators promises to make Lane county the recipient of from \$30,000 to \$40,000 as its share of the sale. According to the rules governing the National Forest Reserve, the county in which a sale is made receives 35 per cent of the money paid to the government. At the present time Supervisor C. R. Seitz is not able to give the details of the sale, but says the price usually received for such timber ranges from \$1.50 to \$2.50 a thousand feet, so the county will receive a large sum of money when the sale is consummated. Mr. Seitz prophesies that a number of big timber deals will take place in the Cascade Forest in the near future.

Extensive improvements are being planned in the Cascade forest now, including the building of 40 miles of new trail, and additional telephone lines to make a total of 300 miles of trunk line. In addition to the special appropriation of \$3,500 for the improvement of roads, Mr. Seitz is endeavoring to secure more funds for road improvement next year. These improvements are expected to facilitate travel and increase the efficiency of fire guards, thus minimizing fire danger.—Register.

BOB-SLED, WAGON, AUTO FOR 60-MILE TRIP

Snow Makes Usual Means of Travel Impossible—Attendance of Physician Urgently Needed.

An improvised bob sled, a light wagon and an automobile were utilized in bringing Mrs. John O'Leary 60 miles from McKenzie bridge to Eugene Monday to receive medical attention. Mrs. O'Leary had been sick for some time and since she needed the frequent attendance of a physician, her husband determined to take her to relatives in Eugene. Snow along the upper McKenzie was too deep for a wagon, so a drag was constructed and with two or three assistants, Mrs. O'Leary was able to get to Blue River, where a light rig was secured and the journey continued. J. A. Airheart met the party near Cook's place with an automobile after traveling three miles through snow, and brought Mrs. O'Leary the rest of the way, arriving at Eugene at 9 o'clock in the evening, 12 hours after she had started.

Mrs. O'Leary's 17-year-old son, who had been in Eugene, learned Friday of his mother's illness. He secured a horse immediately and started for McKenzie bridge carrying medicine. He left Eugene at 3 o'clock, and arrived at his home at 2 o'clock Saturday morning. He changed horses three times on the trip, stopping only long enough each time to secure a fresh mount. The distance is 60 miles, and in spite of the condition of the roads this is one of the fastest trips between Eugene and the upper McKenzie on record. The record trip, however, is ascribed to Marsh Awbury, who 40 years ago crossed the Cascades from Sisters to Eugene, 100 miles, in 24 hours, seeking a doctor for his wife.—Register

WARNED NOT TO KILL SONG BIRDS

Game Warden Is on Lookout for Boys With Guns.

Numerous complaints have recently been made that boys about the city are putting to death great numbers of robins and other song birds. The penalty for this offense is severe and all persons are warned to refrain from further butchery of song birds protected by law.

Extract from laws: "Every person who shall, within the State of Oregon, after the passage of this act, for any purpose, injure, take, kill, or destroy, or have in his possession, sell or offer for sale, any yellow-breasted chat, meadow lark, robin, song sparrow, lark, variegated thrush, wood thrush, hermit thrush, American goldfinch, bluebird, snowbird, oriole, lazulifinch, house and winter wren, pine linnnet, California linnnet, warbler, vireo, swallow, tanager, grosbeak, kinglet, or horned lark, shall be guilty of a misdemeanor." [L. 1895, p. 59].

The penalty for this offense is a fine of from \$5.00 to \$100.

County Court Buys Work Teams.

County Commissioner Hawley has completed the purchase of two good teams and wagons for the county's use. One of them is a team of good mules and the other is a team of horses. They have rented Mr. Edward's barn and they will be kept solely for the county's work. There is a good deal of the macadam road to be taken care of at this time. Holes keep wearing in the roads and it is not worth while to hire men and teams to go out and fix them up. They figure they can save money by having their own teams and men and make the repairs in the different districts without going to the expense of hiring a crew of men to do it. There are many other uses the teams may be put to.—Register.

How to Clean Room of Sick.

"In sweeping a room with a sick person in it, always use a damp broom to avoid raising a dust," said Mrs. Alice Marks Dolman, instructor in home nursing at the Oregon Agricultural College, in a recent lecture.

"Never use a feather duster to dust with, for this raises dust but does not remove it," she continued. "A good solution to use on a dust cloth, to moisten it, is as follows: dissolve 1 $\frac{1}{2}$ teaspoonfuls of carbolic acid crystals in one quart of boiling water and add 1 ounce of glycerine. Be sure that the carbolic acid crystals are all dissolved, else there is great danger of a serious burn. This solution is a mild disinfectant and will not injure wall paper or furniture."
