Ordinance No. 364

An ordinance dividing the City of Cottage Grove into three wards and changing the boundaries of the three wards of said City as heretofore established by Section 5 of an act entitled: "An act to incorporate the City of Cottage Grove; enacted and adopted by a special session of the Legislative Assembly of the State of Oregon for the year 1903, which said act was filed in the office of the Secretary of State December 28, 1903, which said boundaries were modified by Ordinance No. 256, passed by the Common Council April 5, 1910; and establishing the boundary lines of said wards.

The Common Council of the City of Cottage Grove Does Ordain:

Section 1. For the purpose of Municipal Representation, the City of Cottage Grove is hereby divided into three wards, as follows:

Ward No. 1. All that portion of the City lying West of the Coast Fork River shall be Ward No. 1.

Ward No. 2. All that portion of the City of Cottage Grove lying between the Coast Fork River and the main track of the Oregon & California Railroad shall be Ward No. 2.

Ward No. 3. All that portion of the City of Cottage Grove lying East of the main track of the Oregon & California Railroad shall be Ward No. 3.

Section 2. Each of said Wards as provided in this Ordinance shall constitute an election district and shall form a separate election precinct of said City for the purpose of holding all municipal elections and for the purpose of electing all elective officers provided for by the Charter of the said City and each of said Wards shall be entitled to elect two members of the Common Council of said City of Cottage Grove. For the year 1914 T. C. Wheeler shall be Councilman for the First Ward, R. C. Walker for the Second Ward and C. B. Hayes for the Third Ward.

Section 3. Whereas, the next municipal election in said City occurs on the first Monday of December, 1913, the health, peace and safety of the City demands that this Ordinance should take immediate effect. An emergency is therefore declared to exist and this Ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor.

Section 4. Ordinance No. 254 is hereby repealed.
