## HARRY BOWN IS NOW JUDGE OF LANE COUNTY

Supreme Court Hands Down Decision Giving Jobs to Men Elected in November.

Harry L. Bown is now county judge of Lane. He succeeds Helms W. Thompson, who relinquished the office to Mr. Bown yesterday afternoon upon receipt of the news that the supreme court had decided that the men elected as county judges last November should be seated. Mr. Bown took the oath at 4 o'clock yesterday afternoon and began his work as head of the county court this morning.

Mr. Bown was at his farm west of Junction City when word came that the supreme court had given its decision. He was notified over the telephone and went to Eugene on the first train.

Mr. Bown said: "I certainly appreciate very much the interest taken by the people of Eugene and Lane County in this case and the many congratulations I have received since the news of the court's decision was received. I am unable to express in words my feelings toward those who have been so generous with their expressions of friendship and good will. I will do the best I can to fill the duties of the office."

Mr. Bown, who ran for the office on the democratic ticket at the November election, received 6767 votes as against 441 for W. W. Calkins, the republican candidate, and 845 for J. W. Marksbury, the socialist candidate. He is one of the most popular citizens of the county and is known from one end of it to the other. He was sheriff of Lane for four years and a half and was deputy sheriff for a number of years under the late W. W. Withers and under Fred Fisk.

Judge Thompson retires after a good record of over five years in office. He was appointed judge by the governor in November, 1909, to succeed G. R. Christman, who resigned. Judge Thompson was elected to the office a year afterward. He did not run at the last election. His term would have expired on the first Monday in January this year but the county clerk did not issue a certificate of election to Mr. Bown on the advice of the attorney general, also the district attorney, based on a dictum of the supreme court handed down shortly before the election to the effect that the county judges elected in 1910 held for a six-year term. The question came directly before the supreme court on proceedings from Union County when the supreme court was asked to issue a mandamus requiring the county clerk of Union to issue a certificate of election to the man who received the highest number of votes for county judge. The Union County case decides the status of all the county judges elected in 1910.

## Taxes May Be Payable to the County by Monday.

Taxes may be payable next Monday or early in the week, according to S. W. Taylor, county treasurer, who today stated that he expects to complete the writing of 30,000 statements this week. At present he has a force of three shifts each of four men, working a total of 24 hours on the acreage books. There are but two of these and only two men can work on a book. The personal property book has not been turned over as yet by the assessor.
