A SUGGESTION TO UNCLE SAM.

THE U. S. government has a plan to advance to the counties of Oregon and Washington the estimated future earnings of the forests located in them. The money thus received is to be used for road improvements. Such a plan is a good one as far as it goes, but there is little need for extending roads until we settle up along those that we already have. There are millions of acres in Oregon tributary to improved roads that are not being cultivated because those who would settle such lands haven't the money to remove the timber and put in the first crop.

Why can't the government anticipate somewhat upon the earnings of this land and advance enough to enable the prospective settler to go thereupon and start in earning a living?

Canada has a system of lending the homesteader money to get started with. Are we going to allow our northern neighbor of the snows to exhibit greater enterprise and greater business sagacity than we?

SOME NEWSPAPERS NEED IT.

BILL has passed the Minnesota House making it compulsory for newspapers to publish the names and addresses of writers of communications during political campaigns when the same reflect on the character of candidates and giving the candidate attacked the right to make a reply equal in length to the original communication. It is a reflection upon the honesty of some of the newspapers when such a law is necessary, but such a law is needed in Oregon to deal with some of the dirty mud-slinging rags.

FAIR BOARD RECONSIDERS.

IT is understood that the County Fair Board is about to revise the list of prizes for grange exhibits at the approaching fair. The Sentinel last week called the attention of the board to the fact that its niggard policy in allowing but three prizes for grange exhibits was going to result in mighty poor agricultural exhibits. Had there been no more to offer for prizes such criticism would not have been made, but there seems to be something wrong when more money is offered for one horse race at an agricultural exhibition than is offered for all agricultural exhibits combined.

There can be no question but that the amusement features draw the attendance, but if there is to be nothing but amusement features it is a mistake to call it an agricultural fair. If nothing but horse racing will draw a crowd, call it a race meet and be done with it, but let's not have an agricultural fair with all the prize money going for horse races.

The money that is spent for horse races does not go to Lane County. Very little of it stays in Oregon. Most of it goes to horse owners from outside the state. If horse racing draws the crowds why not make it a race meet of Lane County horses only and stir the pride of Lane County farmers in breeding fast horses? A race between plow horses from different sections of the

county might not break any records but should prove quite a drawing card in getting the rural attendance.

A Lane County fair should be for the purpose of developing Lane County, not for the purpose of supporting horse breeders from outside the state.

The Lane County Fair Board got a law passed by the recent legislature permitting the people of the county to vote money for the purchase of the fair grounds at Eugene. Until the bill was amended it provided that the County Court should make a levy for that purpose. It is well for the political features of the members of the Legislature that the bill was amended. Now that it is up to the people to vote such a levy the members of the fair board had better see to it that they do not conduct the fair as an entirely Eugene proposition. The votes of the farmers of the entire county will be needed.

A JOB FOR MASONS.

THE Christian Science Monitor publishes an appeal from Charles W. Jennings, editor of the Fourth Light, a monthly journal devoted to the Masonic brotherhood of the United States, calling upon all Masons to take advantage of the greatest opportunity in history to put into effect the tenets of the brotherhood and to attempt to bring their influence to bear to end the conflict now raging in Europe. Mr. Jennings does not suggest any particular method, but if wishing for peace and hoping and praying for peace will help any, he can depend upon the whole Masonic brotherhood, even to those serving in the ranks and shooting and killing one another. This fraternity, that has survived for centuries through war and pestilence, may be able to do something towards bringing about peace at this time.

SUPERVISORY SYSTEM GOING.

THE rural supervisory system seems to be getting not much more popular. That the County School Board realizes this is indicated by the fact that it has cut off two of the supervisors.

The Sentinel has always supported the system on the ground that the rural child should have as good school opportunities as the city child. The Sentinel strenuously opposed doing away with the system until it had been given a fair trial. Now that the system has had a fair trial The Sentinel believes in leaving the system up to the rural residents—the ones who are benefited thereby. The suggestions made by The Sentinel were adopted at the recent Legislature and after May 22 it will be optional with the rural directors as to whether there shall be a school supervisory system. Although still believing in it, The Sentinel expects to see the system done away with almost entirely. The Cottage Grove country during the past two years has had one of the most competent supervisors of the county. If the system continued to become unpopular under his supervision The Sentinel sees no hope for its life.

MANY PRIZES FOR BOYS AND GIRLS AT FAIR

Great Northern Again Offers \$50 Trophy; Dozen Silver Loving Cups Also Given.

A total of nearly \$400 in cash, a \$50 loving cup and ten or eleven other silver cups and two trips to Salem, form the awards offered the children of Lane County at the coming county fair.

The prizes are offered for all manner of garden products, especially corn and potatoes, for fruit canning, pastry making, and other branches of domestic sciences, and for school industrial work. In these branches the prizes are \$2.50, \$1.50 and \$1.00. Two silver cups are offered in the poultry department, and a silver cup is awarded in both the potato and corn growing contest. Five grand special prizes of loving cups are offered the best boy and girl exhibitor in each class.

The \$50 Great Northern loving cup is offered to the district having the greatest collective exhibit; the grand special prizes are the two trips to the state fair at Salem, with a week on the grounds, and are offered for work in the industrial club projects. A silver cup is offered to the team of five that does the best cooking and serving of baked apples, hot biscuits and coffee.

The following are the rules of entry for the Boys' and Girls' Industrial Fair to be held in connection with the county fair this fall:

Any boy or girl in Lane County under 20 years of age is eligible to enter these contests.

The contests will be divided into three (3) classes. Class (A) will include all contestants from and including the ages of 13 and 20 years, excepting those who will come under class (C), class (B) will include all under 13 years of age, and class (C) will include those who have had over three (3) months' training in domestic science, domestic art or manual training in any school offering such courses.

Prizes will be offered on the basis of the following qualifications:

(1) The contestants must certify that they have prepared their exhibits.

(2) Entries must be made on blanks furnished by the fair association.

(3) Any child may enter as many competitions as he desires, but no child shall make more than one entry for each prize.

(4) Collective exhibits cannot be a part of individual, or individual exhibits part of collective. (This rule does not apply to competition for the Great Northern loving cup.)

(5) In case there is no competition the prizes will be awarded at the discretion of the judges.

(6) Articles exhibited at last year's fair will not be accepted.

(7) Fruit and vegetables must be in pint glass sealers, except in the girls' canning contest.

(8) Exhibits should be in place by 11 p. m., Tuesday, September 21.

(9) Entries due care will be taken to protect and care for exhibits, the association will not be responsible for lost or damaged articles.

(10) Permission cannot be granted to anyone to remove exhibits till the fair has closed.

(11) Communications regarding information, etc., in this department, should be addressed to the county superintendent of schools, Eugene, Ore.

Time to Spray Again.
C. E. Stewart, county fruit inspector, announces that it is now time to spray for apple scab, and gives the following formula:

"For the second spraying for apple scab use lime-sulphur solution at the rate of three gallons to 105 gallons of water; add of paste arsenate of lead four pounds, or, of dry arsenate of lead two pounds to each 100 gallons of this solution.

"Apply as soon as three fourths of the petals have fallen, keep well agitated and see that all calyx cups are filled with the solution; spray all foliage on the trees.

"The third scab spray should be applied not more than two weeks after the second, using the same solution, excepting that the arsenate of lead should be omitted."

BRIEF NEWS OF OREGON

An entire new lighting system has just been installed in Dallas.

The new crematorium at the eastern Oregon state hospital has been completed.

The Junction City annual pumpkin show will be held September 16, 17 and 18.

Industrial clubs are being organized in many of the districts of Washington county.

Charles Volz, a well known business man of North Bend, died suddenly of hemorrhage.

Mrs. Jack Wenandy committed suicide at her home in Bend. Domestic difficulties are blamed in a note.

Six months' attendance at Sunday school was the sentence meted out by Juvenile Judge Gillette to a delinquent Grants' pass boy.

The Polk County Jersey Breeders' association will hold a big public auction May 5, at which all breeds of cows will be sold.

Alfred Ball, of Salem, has been appointed deputy sealer of weights and measures for the western district by State Treasurer Kay.

Frank Meredith, secretary of the Oregon state fair board, has been offered the secretaryship of the Washington state fair board.

In an effort to exterminate coyotes infested with rabies, the rangers of the Malheur national forest have killed more than 100 coyotes within the last month.

Pythian Sisters of the third district held their convention at Albany with delegates present from all lodges of the organization in Marion, Linn, Lane and Polk counties.

One hundred and sixty-five thousand two-year-old Douglas fir trees will be planted on Dead mountain, three miles above Oakridge in the Cascade national forest this year.

The lowest bid for the construction of the proposed stretch of the Columbia highway in Hood River county, \$40,343, was submitted by Standifer & Clarkson, of Portland.

Following the usual custom, the committee in charge of the Seventh Annual Strawberry Festival to be held at Roseburg on May 21 and 22, will elect a "queen" by popular vote.

The Douglas County Game Protective associations at Roseburg, Tiller and Yoncalla, have passed resolutions endorsing the appointment of R. L. Ewing, of Medford, as state game warden.

Hugh Priest and Thomas Patterson were convicted at Portland of a charge of arson, arising out of an attempt to burn the L. B. Menefee Lumber company's shingle mill at University Park, February 16.

James A. Osborne lost his life and William and James Winegar were rescued by the government lifesaving crew when they attempted to land through the surf on Bandon beach in an 18-foot rowboat.

The lumber industry of the Hood River valley is recovering. Manager J. E. Robertson, of the Stanley-Smith Lumber company announces that their new plant at Green Point will be in operation with spring weather.

Fred R. Mellis, of Baker, will have charge of the Oregon mining exhibit at the Panama-Pacific exposition, and it is the plan of the committee in charge of the work to make the exhibit a permanent one in Oregon after the fair.

Forty accidents, none fatal, were reported to Labor Commissioner Hoff during the week. Fourteen of the accidents were in connection with lumber manufacture and logging, while 11 were in connection with the railroad work.

Labor Commissioner Hoff is sending out notices in regard to the law passed by the last legislature which regulates employment agencies. Under the new law, which becomes effective May 22, agents must secure licenses from the labor commissioner.

Following an appropriation of \$20,000 by the state highway commission, with which to improve the Pacific highway between Canyon Creek canyon and the Josephine county line, Douglas county will appropriate a like sum in the improvement of the road.

According to advices received by State Forester Elliott from the federal forestry department, Oregon's appropriation under the Weeks law for forest fire-fighting will be \$8000 this year, \$2000 less than the appropriation the state has received during each of the past three years.

Sheepmen have been notified of a meeting to be held at Baker April 1 and 2 for the purpose of organizing so that the woolgrowers may get the most from present market conditions. Both Oregon and Idaho woolgrowers will be present. Co-operation will be emphasized at the meeting.

A cabinet conference of the Y. W. C. A., attended by representatives of nine Oregon educational institutions, was held in Albany. The University of Oregon, Oregon Agricultural College, Willamette University, Albany College, Philomath College, Chemawa Training School, Salem High School, Eugene High School and Corvallis High School associations' officers were present.
