

WM. HORN, PIONEER IS DEAD

Had Been Prominent Resident of Oregon for Quarter of a Century

Was Born in Scotland and Married There Over Fifty Years Ago. Five of Six Children Born to the Union Survive

Wm. Horn, who had lived near Walker for almost a quarter of a century, died July 7, after a long illness. The funeral was held at the Walker church Sunday afternoon at 3 o'clock, interment being in the Walker cemetery.

By special request of the family, Rev. W. V. Metcalf, of Albany, conducted the services.

Wm. Horn was born at Culross, Perthshire, Scotland, May 1, 1840. November 16, 1865, he was united in marriage to Catherine Condie, who survives.

To this union of over fifty years six children were born, five of whom are living. In 1870 the family came to America, settling at Joliet, Ill., where they resided for eight years. In 1892 they moved to Oregon, settling at Walker.

Mr. Horn was a member of the Presbyterian church, serving as a ruling elder for a number of years.

Surviving children are Mrs. F. Maekie, Mrs. R. Y. Porter, Malcolm A. Horn and Wm. A. Horn, of Walker, and A. Horn, of Portland. Mrs. J. C. Wright, a daughter, died in 1906. Two sisters live in Scotland. A brother, Andrew Horn, lives at Portland. There are thirteen grandchildren.

Big Sugar Company Incorporates Here

The Utah-Idaho Sugar company, of Salt Lake, the \$10,000,000 concern headed by Joseph Smith, has formally entered this state by filing copies of its incorporation and paying the necessary fees for permission to do business in Oregon.

The Utah company has already done considerable work in the state, including the sugar factory at Grants Pass, and has investigated the possibilities of making beet sugar in Sutherlin and other localities.

Another large foreign corporation entering the state is the Pathe Exchange, of New York, the \$3,000,000 moving picture concern, which filed copies of its articles Saturday and received permission to do business in the state.

Each foreign corporation coming into the state pays a declaration fee of \$50 and a regular fee of \$100 a year.

PASS CREEK CANYON ROAD TO GET ROCK

The county court of Douglas County has promised Dr. A. C. Seely, president of the Roseburg Commercial club, that immediate action would be taken to have the road through Pass Creek canyon placed in a passable condition.

The deplorable condition of the road in Pass Creek canyon was brought to the attention of the court by Dr. Seely, who, in a few words said that many complaints had been filed with him lately regarding the highway under consideration. "The complaints of tourists passing over this road have been general," said Dr. Seely, "and in some instances Douglas county has received some very unfavorable advertising. The time has now been reached when the members of the commercial club, of which I am president, desire to know what is to be done with this notorious road. I have no quarrel with you gentlemen, but I wish to be placed in a position where I can advise the club members and other inquirers what the court intends to do. If the court anticipates

improving the road I will so inform those who seek information. In the event the court does not intend to improve the highway, I will inform them of that fact. I came here this morning merely to seek information and I think that I am entitled to a definite answer."

C. G. EMPLOYERS TO HOLD JOBS

Men Who Go With Militia Will Be Retained in Service by Mills and Railroad.

Cottage Grove employers have shown no lack of patriotism when asked if they would allow employees to go to encampment with Sixth company C. A. C. O. N. G., and even to the Mexican border with the troops, if necessary. J. H. Chambers, of the J. H. Chambers Lumber company, and L. S. Hill, of the Brown Lumber company, who jointly operate the U. S. Logging company, have agreed that any of their men who are members of, or become members of, the militia, may resume their regular positions upon their return. The wood foremen, George Hastings and LaSalle Stewart, have also agreed to cooperate. The Oregon Pacific & Eastern railway has done the same. The latter has always been exceptionally lenient about allowing its employees to go to annual encampment, sometimes at great inconvenience to the business.

Captain Woods has issued an order to Sixth company requiring attendance at encampment of all officers and enlisted men who have served 60 days or more. This order was made necessary by recent instructions from the war department which stipulate that all companies, at the time of leaving their home station for encampment, shall consist of not less than two officers and forty-two enlisted men who have served sixty or more days.

Presents Bill for \$85.30.

Shinn, presented a bill Monday for \$85.30 against Lane county for damages sustained by his automobile April 9, 1916, when his driver ran into an obstruction placed across the bridge on the Pacific highway south of Cottage Grove. He alleges that the agent of the county or one of his employees placed a two-by-eight across the roadway at the bridge in such a place that it could not be seen in time to stop an automobile. He presented a number of affidavits, and also a number of verbal witnesses to support his bill.

ELEVEN MEASURES WILL APPEAR

Three Proposed Questions for the Voters to Settle Fail to Get on Ballot

Law for Permitting Manufacture of Light Beer in State Favored by 42,046, While 30,170 Want State Teetotally Dry.

Eight state-wide measures bearing a total of 227,328 signatures—five proposed county laws, and three measures submitted by the last legislature—will be on the official ballot at the general election next November.

Three proposed state-wide measures, for which petitions were in circulation, apparently failed to obtain the necessary number of signatures.

Of the state-wide measures which will appear on the ballot, the constitutional amendment advocated by the "equal rights for home industry" committee proposing to allow the manufacture of light beer in Oregon, leads in the number of signatures, with a total of 42,046. This is the largest petition ever filed in the office of the secretary of state, and contains 7294 more signatures than the "dry" petition filed two years ago. C. T. Haas, of Portland, filed the completed petition. He said that the names were obtained by volunteer circulators and that slightly more than half were obtained outside of Multnomah county. Approximately one-third of the signers are women.

The proposed constitutional amendment to prohibit the importation of liquor into the state for beverage purposes was filed by J. Sanger Fox, in behalf of the Oregon prohibition committee. It bore 30,170 signatures.

Other state-wide measures for which petitions were filed with the number of signatures are: People's land and loan law amendment, 24,653 signatures; providing normal for Pendleton amendment, 28,000 signatures; state-wide tax limitation amendment, 25,283; rural credits amendment, 27,250 signatures; prohibition of compulsory vaccination and medical treatment law, 25,126 signatures; law to repeal and abolish the Sunday closing law, 24,500 signatures.

State-wide measures referred by the last legislature are: Single item veto amendment; exemption of ships amendment; and amendment repealing constitutional provision forbidding suffrage to negroes, Chinamen and mulattoes.

MILITIA BOYS WILL GO TO ENCAMPMENT

Members of Sixth company C. A. C. O. N. G., are making preparations to enter their early Sunday morning for Fort Stevens for the usual midsummer encampment. A number are still of the opinion that from there they may be sent to the border, despite the fact that there is a lull in the exciting conditions in Mexico.

A special train will bear the Cottage Grove and Eugene companies to Portland and at that city the other companies in the corps will join them and proceed in a body to the fort.

All officers and men attending camp will take the federal oath prescribed under the law of June 3, 1916, prior to departure for camp.

Special School Meeting Wednesday.

The special school meeting to vote for the budget for the coming year here will be held Tuesday afternoon in the high school auditorium. The budget suggests a 10-mill levy as necessary for carrying on the work. This is two mills less than the previous levy.

Embarrassment to Wader Prevented by High Water

"Wink" Wallace Has Successful Hotel Business at Grass Valley

C. W. WALLACE arrived Sunday from Grass Valley to visit his mother, "Aunt" Ann Wallace, whose condition is very critical. "Wink" says he is enjoying a fine business with his hotel—served 300 meals July 3 and 450 meals on the Fourth, and had to put three and four in each bed.

They had a little cloudburst there May 29, four people being drowned in a canyon 17 miles below Grass Valley. Wink had just put in ten dozen chickens to last over the Fourth and had to wade around up to his waist to rescue his poultry. It is probable that "Wink" was saved considerable embarrassment by the fact that the water was high enough to prevent the exposure of his nose to rotund nether extremities.

Crops will be fine out there this year, Mr. Wallace states.
