HAWLEY FEATURE AT REPUBLICAN FINAL RALLY

**Congressman Is Expected to Draw
His Usual Large and Ap-
preciative Audience**

Probably the last, certainly the largest, republican rally of the campaign will be held here on the evening of either Friday, October 20, or Saturday, October 21, when Congressman Hawley will deliver the principal address. Mr. Hawley always draws a large crowd and special efforts will be made to make this meeting the banner one of the year. It is expected that a number from Eugene and from outlying communities will be present.

The meeting will probably be held in the Rex theater.

Bridge Being Repaired.

The floor of the Main avenue bridge over the Coast Fork is being replaced this week, the work being done by Street Commissioner Pitcher and a crew of carpenters. Only one of the two driveways is being repaired at a time, traffic thus being left open. By this method of putting in the planking it will be convenient hereafter to repair one side at a time or to remove only half of a plank when one breaks through.

DOROTHY COOPER INJURED IN ACCIDENT

**Board Falls from Theater Balcony and
Inflicts a Deep Scalp Wound
Upon Little Girl.**

Miss Dorothy Cooper, daughter of Mr. and Mrs. W. B. Cooper, was quite seriously injured Monday while attending the matinee performance of "Civilization." A board which had been a part of the paneling of the balcony fell and struck the child on the head, inflicting a deep scalp wound. There were some boys in the gallery at the time and it was at first thought that one of them had kicked the board loose. It is now thought such was not the case but how the accident happened has not been established.

Little Dorothy is recovering nicely from her injury.

An Explanation.

A deplorable accident occurred at the Arcade Theater during the matinee Monday afternoon while the wonderful film "Civilization" was being shown.

The gallery had been reserved for the school children and a piece of panel was in some way dislodged from the rail in front of the balcony and fell, striking the little daughter of W. B. Cooper on the head and inflicting an ugly scalp wound.

There were a number of boys in the front row and Donald Woods happened to be sitting where the piece fell and was accused of kicking the piece out.

The testimony of six boys sitting on either side and back of Donald proved that no one had done any kicking on the boards and that the boys did not know that a piece of lumber had fallen until one of the employees came up to investigate and after feeling of the panels told the boys that several were loose and not to lean against them. The boys had discovered that one was very loose when they sat down and picked it out and laid it under the seats.

It is needless to say that Manager White and Mr. W. B. Cooper, the owner of the building, have made the necessary repairs so there will not be a recurrence of the trouble.

Registration Expected to Be 15,500.

The total registration of voters is expected to be 15,500 for the November election, according to estimates of the members of the force of the county clerk. On September 29 the number registered was 13,796 and it is estimated that since then 1700 have put their names down. ADAMSON LAW IS CONDEMNED BY UNIONISTS

**Railway Employees Not Affected
by Wage Raise Claim
Discrimination**

**Seattle Leader Says That President and
Congress Could Not Settle in
Three Days What Has Puz-
zled Labor Three Years**

That the Adamson wage increase law has not done away with the probability of a strike upon the railway systems of the country is evidenced by reports from different points of dissatisfaction of those employed in the departments of the railway service that were not affected by the Adamson law. These claim that because of better organization the trainmen, already the highest paid in the railway service, were able to compel an increase in their wages, while those more in need of an increase in wages, were discriminated against.

Leaders of the Brotherhood of Railroad Car Men in the northwest met in St. Paul a few days ago to discuss a plan to demand higher wages from the Great Northern, the Northern Pacific, the Canadian Pacific and the Chicago, Milwaukee & St. Paul railroads and recognition of the union by the Great Northern. The car men, it is said, were disgruntled over the passage of the Adamson law, providing a raise in wages for trainmen, as they contend that the law did not include them.

Some of the leaders of the car men predict that a strike will ensue if the demands to be formulated at the meeting should not be granted.

Albert A. Piller, Seattle labor leader, denounced the Adamson law granting an eight-hour day to railroad men, in a speech delivered to the Associated German-American republican clubs of Washington, meeting in state convention.

"Three years ago in Philadelphia," said Mr. Piller, "Samuel Gompers, speaking from the floor of the American federation of labor convention, assumed invocation of political action to bring about the universal eight-hour day. He scored it on the ground that it leaned toward paternalism. He said that any improvement in labor conditions must be won by the unions themselves, not by any outside help."

"Now, the American federation of labor has fought over this point for three years, and has been unable to solve the problem. How could President Wilson and congress settle it in three days? The Adamson law is a blow to Americanism and union labor."

Christian Endeavor Rally at Dorena.

Dorena, Ore., Oct. 10.—(Special to The Sentinel).—Arlo Bristow, of Pleasant Hill, Miss Mae Harbert, of Thurston, and Miss Ruby Senesky, of Springfield, Christian Endeavor officers of Lane county, came up from Eugene Saturday and held a very interesting meeting at the church Sunday. The program consisted of Sunday school at 10 o'clock, a sermon at 11 by Mr. Bristow, a basket dinner in the hall at noon, conferences on Christian Endeavor work in the afternoon, Christian Endeavor in the evening led by Miss Senesky, after which Miss Harbert gave a talk on missionary work and Mr. Bristow a talk on pledges.

Lane's Claim Approved.

Lane county's claim for land grant taxes has been forwarded to Washington, approved for payment by ex-Governor West, who is in charge of checking the claims of the Oregon counties for taxes due on the forfeited O. & C. lands.

The statement shows approximately \$284,785.06 due Lane county for 1913, 1914 and 1915 taxes. This includes penalty and interest, the latter being figured up to the time settlement is expected.

Circuit Court Cases Decided.

In the case of Gottfried Graber against George O. Knowles, administrator of the estate of J. C. Cluckey, a judgment in the sum of \$593.35 has been rendered and an order issued for the sale of the mortgaged property.

In the case of O. W. Davis against the Long Placer Mining company, judgment has been rendered for \$2312.60 and an order issued for the sale of the mines.

Stranger Found Not Insane.

Frank Morris, a transient, was picked up here by Marshal Pitcher a few days ago and taken before the probate judge to be examined for his sanity. He was found digging dirt with his hands along the railroad track and acting in a peculiar manner but the court found the man sane and ordered his discharge.

NUMEROUS CONTESTS FOR SCHOOL PUPILS

**To Spelling of Past Years, Arithmetic
and Declamation Added.**

Not only will the annual spelling contests take place among the school pupils of Lane county this year, but E. J. Stewart, county superintendent, plans to hold rapid arithmetic contests and declamation contests.

In the arithmetic contest there will be two sets of 20 questions each, sent to teachers. One set will be for fifth and sixth grades and the other for seventh and eighth grades and questions will cover only work already finished. Thirty minutes will be the extreme time limit for this work. The pupil may work the questions mentally or with pencil and paper as he chooses, but only the answer is to be set down under each question.

The dates for these contests are November 3, January 12, February 16 and March 30.

A final contest will be held in Eugene as in former spelling contests, at which representatives from each school may compete, and appropriate medals will be given to the winners.

The date of the first declamation contest will be November 20.

Four spelling contests will be held again this year on the following dates: November 20, January 12, March 2 and April 13. Sealed lists of words will be sent in time for each contest.

OREGONIANS ARE PUTTING MONEY IN THE BANKS

**Farm Products and Lumber Are Bring-
ing Good Prices.**

The war prosperity is beginning to hit Oregon. With everything the farmer has to sell bringing big prices and with lumber orders plentiful, bank deposits have taken a tremendous jump.

Increases in the deposits and resources of banks in Oregon since June 30 have broken all previous records, according to the statement, covering the condition of all banks at the close of business on September 12, issued by S. G. Sargent, superintendent of banks.

Deposits totalled \$140,049,599.03, an increase of \$10,685,078.64 since June 30, and an increase of \$17,704,755.27 since September, 1915. Resources totalled \$178,561,927.95, an increase of \$11,087,711.29 since June 30 and an increase of \$18,951,761.71 since September, 1915.

The statement says that investments show a much stronger commercial activity and a tendency on the part of the public to engage in business enterprises.

Big Advertising Bill for a Little Thing.

It is but a few years since the handsome young men with the latest style collars made their appearance in the advertising columns of the newspapers. The total cost of this advertising, especially that of Cluett, Peabody & company, amounted to a "pretty penny," but—the net profit of that concern for 1916 over 1915 was the neat sum of \$389,805. The total net profit was \$1,376,589.

The net sales of Cluett, Peabody & company for 1915 were \$6,730,582. In 1916 this total was increased almost \$2,000,000, or to be accurate, just \$8,471,504.

Postoffice to Be Discontinued.

The postoffice at Row River will be discontinued October 16. There are but a few families there since the mill ceased operations and no one can be secured to act as postmaster. The mail will go to Dorena after the discontinuance of the office.

CIGARETS MAY HAVE CAUSED FIRE

**W. L. Hubbell Barn and Its Contents
Are Totally Destroyed in Blaze
Tuesday Afternoon.**

It is thought probable that children smoking cigars was the cause of a fire Tuesday afternoon when W. L. Hubbell's barn was destroyed, together with the contents. Boys had been frequently seen at play there.

The fire was a dangerous one because of the proximity of several houses but the fire department had the flames under control before they had an opportunity to spread.

There was considerable hay and dressed lumber in the building.

School Money Is Sent Out.

Warrants for school money amounting to over \$21,000 were sent out last week by E. J. Moore, county superintendent, to the various school districts over the county.

This money is yearly allotted the districts, the amounts being based on the number of children attending school in each district. For each pupil the sum of \$1.80 is allowed.

NOW TIME TO SPRAY PEACH, SAYS STEWART

**Growers Cautioned Not to Let Blight
Get a Foothold.**

The following advice in regard to the use of spray at this time has been issued to Lane county fruit men by C. E. Stewart, county fruit inspector:

"To prevent California peach blight, spray now with the 6-6-50 Bordeaux mixture. If trees are not badly infected the lime-sulphur solution used at rate of one gallon to eight or ten gallons of water will keep the disease under control."

"Peach blight infections will start directly after the fall rains begin, and one should not wait until the leaves are off the trees to spray, as it will then be too late for best results. Cover all parts of the tree thoroughly."

"Young apple trees, not in bearing, should be sprayed at this time to prevent anthracnose, with the 6-6-50 Bordeaux mixture or the lime-sulphur solution at the rate of one gallon to eight gallons of water."

"All bearing apple trees should be sprayed with one of the above solutions just as soon as the fruit is off the trees, as no fungus diseases can be stopped with spray after the infections have once started."

"The lime-sulphur solution used at rate of one part to eight of water is apt to injure the fruit buds on young De Anjou pear trees."

SHORT LIST OF NAMES ON BALLOT THIS YEAR

**Only Fifteen Candidates in the Field
for County Office.**

The county clerk's office has received from the secretary of state the certificate of nomination of all the candidates on the national, state and district tickets for the election which is to be held November 7. There are 21 names in the list of presidential electors, 39 candidates for state and district offices, and 15 names on the county ticket.

There are 11 measures to be voted on, and in most of the precincts there will be justices of the peace and constables to elect. There are four candidates for commissioner of the Port of Siuslaw.

Keeney Files for Assessor.

B. F. Keeney has filed with the county clerk his petition as independent candidate for county assessor at the November election. The petitions contain 641 names.

Mr. Keeney failed to obtain the republican nomination at the May primaries, being defeated by D. P. Burton, of Cottage Grove, who was assessor for a number of terms previous to 12 years ago when Mr. Keeney took the office.

N. J. Bryant, of Franklin, is the democratic candidate to oppose the two at the polls.

Fire Prevention Day Observed.

Monday was National Fire Prevention Day and was observed as such by fire departments over the entire country. The idea of the day is to concentrate the thoughts of citizens upon removing the causes of fire. The local department issued posters giving suggestions as to what to do to prevent fires.

Civilization Is Great Film.

The greatest film ever shown here, was the universal opinion of "Civilization," the 11-reel film feature presented at the Arcade Monday. The film showed briefly a few of the horrors of war and made a strong appeal for the doctrines of peace and industrial happiness.

PROGRESSIVES AND REPUBLICANS NOW ONE

**Aims and Needs of Present Day
Bring Warring Sections
Together Again.**

**E. A. Clark, of Portland, in Stirring
Address, Points Out Benefits of
Returning the Grand Old
Party to Power.**

"I was a progressive in 1912 and campaigned a large part of this state for that party, but today I am doing the same thing for the republican party. We progressives believe in peace with honor and a guarantee of the protection of American rights at home, abroad and on our borders. After the record of humiliation, cowardice and vacillation of the past four years, there is but one thing left for a progressive to do, only one party to which he can go. The two sections of the republican party are now united and brought together by the aims and needs of these days."

These were the opening words of an address Friday night by E. A. Clark, of Portland, former candidate for United States senator on the progressive ticket. A large audience, well sprinkled with old soldiers and women, listened to Mr. Clark for two hours as he contrasted the record of achievement of republican administrations with the record of hesitation of the democratic administration. He pointed out repudiation of platform pledges, record of gross extravagance of an administration solemnly sworn to economy, its dealing with Mexico, unequalled by the worst intermeddling trouble-maker of any neighborhood.

How free trade has hurt the Pacific northwest was shown by actual figures of loss of lumber business through foreign importations and industrial loss through lack of confidence in the business sagacity of a democratic administration and a lack of confidence in democratic policies.

"I can best illustrate my point," the speaker said, "by telling the truth about Portland." Then he recited figures showing that the amount of new construction in the metropolis increased by leaps and bounds during the last republican administration but had declined equally as rapidly under the present administration. He told of the hundreds of unemployed that were upon the charity of the city during that part of the democratic administration preceding the war prosperity.

The speaker referred to the declaration of American rights in the democratic platform of 1912, the adoption of which in the republican platform of 1916 is considered by the democrats a criticism of their administration.

"What war has he kept us out of?" the speaker asked. "Not out of the war in Europe, surely. Switzerland, surrounded by war, has not got into it. Holland has not got into it. Sweden and Norway have not got into it. Yet none of these have allowed their rights to be trampled upon. They have not allowed their national honor to be violated. What excuse would there be for us to get into war with a wide ocean between us and the warring nations?"

If the same firm position had been taken when the first American was killed upon the high seas that was taken when an indignant people compelled such a position to be taken, the Lusitania incident never would have happened. If the warning by the German government that the Lusitania was to be sunk had been taken cognizance of with a firm but polite notice that such action would mean the immediate cessation of diplomatic relations, the incident never would have happened and we would have preserved our national honor.

"Have we been kept out of war with Mexico? Ask the widows of the brave men killed in the northern invasion. Ask the relatives of the boys who gave the last full measure of devotion at Vera Cruz. Ask the widows and orphans of those killed on our own soil by bandit hands or by stray bullets from across the border. We have intermeddled and intermeddled in Mexico and have only made conditions worse. We refused to recognize the only stable government Mexico has had in recent years, simply because it was said Huerta was a murderer. Later we gave him asylum in this country and cast our favor first on Carranza so that he could murder Villa, then on Villa so that he could murder Carranza. We sent John Lind to Mexico for the very purpose of devising ways and means of overthrowing the only stable government there was in Mexico. We succeeded in that purpose and now we say it is up to Mexico to find her own way out of the middle we have made."

"We stand by the Monroe doctrine and say no foreign nation shall interfere with the affairs of the western hemisphere. European nations have taken us at our word. But we have done no more to protect the property and lives of citizens of Europe than we have to protect the lives and property of our own citizens. When the great war is over, when the victorious nations of Europe have the greatest and best trained armies in the history of the world, we will be asked what we are going to do about this loss of life and property of the nations of Europe. If Mexico does not make amends we will be asked to make amends. We may not be called upon to account for neglect of the lives and property of our own citizens, but we will some day have to say what we are going to do about the loss of life and property of other nations."

**First Crop at Creswell Is Successfully
Marketed at Prices That Mean
a Splendid Profit.**

Encouragement for the fruit industry of Lane county is found in the experience of Lane county this year. About 15 cars will be shipped this season, this being the first season any have been shipped. The price received for extra fancy has been \$1.15 f. o. b. Creswell, which price nets the grower a nice profit.

The orchards about Creswell are bearing for their first year and as the crop increases the shipments will increase rapidly.

The growth of the fruit industry about Creswell will be watched with interest in other parts of Lane county, as that section has the largest acreage of any section in the county. In that section spraying has been followed to a greater extent than anywhere else and the effect of spraying will be watched by fruit sections in other parts of the county.
