GERMANS CONTINUE TO YIELD GROUND

Heavy and Useless Sacrifices Made in Attempts to Stop French Advance.

Paris.—Notwithstanding the bad weather and the difficult state of the ground, the French continued to advance south of the Oise. The war office announces that French patrols reached Folembray south of the forest of Coucy.

The Germans made heavy and useless sacrifices, the statement says, in several attacks on positions captured by the French between the Somme and the Oise. Wherever they approached a French position they were thrown back by counter attacks.

The pressure of the French from St. Quentin to the Aisne is so powerful that it begins to seem doubtful, in the opinion of the French military critics, as to whether the Germans will be able to hold on to the so-called Hindenburg line. The invaders have opened the sluices at La Fere, apparently feeling that their chances of holding the town are not good now that the French have got a footing on the high ground in the Jussy region, northeast of Tergnier. If General Nivelle is able to establish himself in this position his guns will command La Fere.

Further south the French are making solid progress against the five-mile salient covering St. Gobain and formed by the lower Coucy forest.

The columns here are working hand in hand with columns operating northeast of Soissons, in the direction of Laon. The latter made continuous progress and their advance exposes the left extremity of the German line at St. Gobain to the risk of being out-flanked and driven back to Laon. It is evident that the German staff is alive to the growing danger and that they are making desperate efforts to check the French advance.

REPUBLICAN FORM OF GOVERNMENT CHOSEN

London.—The central committee and the parliamentary representatives of the constitutional democratic party at Petrograd voted in favor of a republican form of government for Russia, according to a Petrograd dispatch. Professor Paul N. Milukoff, the foreign minister in the new government, is leader of this party.

A Reuter dispatch from Petrograd quotes the foreign minister as saying: "We shall remain faithful to all past alliances similar to that with our allies, which will be still further strengthened and become still more cordial and sincere. The change in regime will disperse the distrust our allies had a right to feel toward the late government. It is Russia's duty to continue the struggle brilliantly both for her own liberty and that of all Europe."

Warm appreciation of the cordial feeling shown by the people and government of the United States toward the new regime in Russia was expressed by Foreign Secretary Milukoff in a statement.

FRAME NEW PEACE OFFER

Belgium to be Restored in Part, but Not Permitted to Have Army.

Berne, via Paris.—Peace negotiations have begun, says the Journal de Geneve, which does not reveal the source of its information, but declares it is absolutely reliable. Germany would offer to restore the territory she occupies in France, except in the mining district of Briey, in exchange for a channel port, Calais or Dunkirk, and an indemnity of 15,000,000,000 francs.

"Germany would also offer," says the newspaper, "to restore the territorial integrity and the sovereignty of Belgium on condition that Belgium would not be allowed to maintain a national army and that Germany would be permitted to garrison Namur, Liege and Antwerp perpetually."

America Supports Cuban Government

Havana.—A note from the American government to the Cuban government, reiterating the purpose of the United States to support the Cuban government in its efforts to re-establish order and condemning the conduct of the rebels, was delivered by William E. Gonzales, the American minister.

Germany to Seize Grain.

Berlin, via London.—The German government announces that all grains and legumes still in the hands of consumers above limited quantities will be seized for the benefit of the public.

First Armed American Ship Arrives.

Washington.—The American liner St. Louis, first armed American ship to cross the Atlantic, has arrived safely at her destination, Secretary Daniels announced.

Cousin of General Robert E. Lee Dead.

Eugene Register: L. E. Lee, a third cousin of the famous Confederate general, Robert E. Lee, died at Forest Grove a few days ago, according to word received in Eugene March 16. Until three weeks ago Mr. Lee resided at Lorane. He would have been 104 years old had he lived until March 24.

Mr. Lee was born in North Carolina March 24, 1813. He came to Lorane from Kansas and made his home with his son, W. E. Lee. Although longevity runs in the Lee family, Mr. Lee attributes his many years to chewing tobacco. Since a boy of five years, he chewed tobacco, having acquired the habit on his father's farm in North Carolina. Mr. Lee's father was killed in the middle of life but his

grandfather lived to 104 years, while his great-grandfather saw 107 years. A sister who survives him, Mrs. Eliza Gross, resides in North Carolina and is 99 years old.
