
Cottage Grove Retrospective

Staff hearing tests

Last Monday, 44 City employees from the Police Department, Middlefield Golf Course, Utilities, Building Maintenance, Shop, Water, and Wastewater received hearing tests. Annual hearing tests create a baseline level for each employee that can be monitored for any significant changes.
