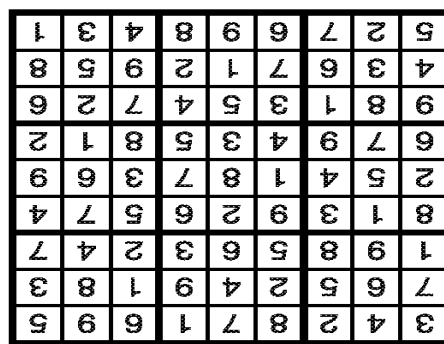
SUDOKU
