FIREWOOD ADVERTISING LAW

Oregon Dept. of Agriculture requires a cord be stacked and measure 128 cubic ft. i.e. 8x4x4 or 2x8x8 etc. =128.

Oregon State law requires advertisements quoting a price to also express quantity in units of a cord or fractional parts of a cord. Ads must also identify the species of wood and whether the wood is unseasoned (green) or dry. Where mixed wood species are offered, the percentage (%) of each group must be stated within 10% (percent) accuracy.

The proposed rules would:
 • Change the term "Open Burning" to "Outdoor Burning" throughout Title 47
 • Clarify terminology pertaining to size and materials of "religious ceremonial fires" and "bonfires"
 • Clarify terminology relative to outdoor burning during the LRAPA "Home Wood Heating Season"
 • Require residents within the Oakridge Urban Growth Boundary to be subject to outdoor burning prohibitions and exemptions during the November through February Oakridge
